Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Mortgage 1, Inc. 401(k) and Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The following description of the Mortgage 1, Inc. 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Reference should be made to the plan agreement for a more complete description of the Plans' provisions.

(a) GENERAL

The Plan is a defined contribution plan covering eligible employees of the Company. Employees are generally eligible to participate in the 401(k) plan for employer profit-sharing contributions after 90 days and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

(b) PARTICIPANT CONTRIBUTIONS

The Plan is a defined contribution plan intended to qualify as a profit-sharing plan under Section 401(k) of the Internal Revenue Code. The Plan allows eligible employees to contribute up to 90% of their annual compensation, not to exceed limitations established by the Internal Revenue Service. Salary deferral contributions are contributed to the Plan through regular payroll deductions. The participants may elect the percentage of his or her contribution to be allocated into various investment options offered by the Plan.

(c) EMPLOYER CONTRIBUTIONS

The Company may make a discretionary contribution to the Plan in such amount as determined by the Company's board of directors. The participant may elect the percentage of the employer's contribution to be allocated into various investment options offered by the Plan.

No contributions were made by the employer for years ended December 31, 2024 and 2023.

(d) PARTICIPANT ACCOUNTS

Each participant's account is credited with his or her contributions, allocation of Company contributions, plan earnings, and forfeitures. Allocations are based on participant earnings or account balances as defined. Participants are vested immediately in their contributions plus actual earnings thereon.

(e) VESTING

Vesting of Company contributions is based on the following table:

A participant is credited with one vesting year for each plan year in which 1,000 or more hours of service have been accrued. A participant will become fully (100%) vested upon normal retirement age as an employee, at death while an employee, or disabled while an employee.

(f) NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their accounts in amounts limited by the plan. The loans are secured by the balance in the participants account and bear interest at rates that range from 4.25% to 9.5%, which commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

(g) WITHDRAWALS AND PAYMENT OF BENEFITS

Withdrawals and payment of benefits are paid from participant accounts as of the applicable valuation date. Benefits are payable upon retirement, death or other termination of employment. Certain in-service benefit withdrawals are also permitted.

(h) ADMINISTRATIVE EXPENSES

Certain expenses incurred in the administration of the Plan are paid directly by the company.

(i) FORFEITURES

Any balance in the account of a participant who has separated from service to which he or she has no vested interest, pursuant to the application of the vesting schedule, will be held in a forfeiture suspense account and reallocated to the eligible participants in the ratio in which their compensation for the plan year bears to all participants' compensation for the plan year. At December 31, 2024 and 2023, there were no forfeited amounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

(a) BASIS OF PRESENTATION

The accompanying financial statements are presented on the accrual basis of accounting, such that all income, benefits, and expenses are recognized in the period to which they relate.

(b) VALUATION OF INVESTMENTS AND INCOME RECOGNITION

Investments are stated at fair value as determined by quoted market prices. Shares of mutual funds are valued at the net asset value of the shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes gains and losses on investments bought and sold as well as held during the year.

(c) USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

(d) PAYMENT OF BENEFITS

Benefits are recorded when paid.

3. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company may amend or terminate the Plan at any time subject to the provision of ERISA. Amounts credited to participants' accounts become 100% vested upon termination of the Plan.

4. RELATED PARTY TRANSACTIONS

Certain plan investments are shares of mutual funds managed by the custodian of the Plan, and therefore, these transactions qualify as party-in-interest transactions.

5. TAX STATUS

The Internal Revenue Service has determined and informed the company in a letter dated October 6, 2021, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator and the Plan's tax counsel do not anticipate that changes in the Plan since the date of the determination letter will affect the qualified and tax-exempt status of the Plan.

5. TAX STATUS (continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to tax examinations for years prior to 2021.

6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

7. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

7. FAIR VALUE MEASUREMENTS (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds are valued at the net asset value (NAV) of shares held by the plan at year end.

Money Market Fund approximate their fair value based on their short-term nature.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
