Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Wil Fischer Distributing Co., Inc. 401(K) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). In forming our opinion on the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

1. Description of the plan

The following description of the Wil Fischer Distributing Co. (“Company”), Inc. 401(K) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

a. General

The Plan is a defined contribution plan covering all employees of Wil Fischer Distributing Co., Inc., Wil Fischer Distributing of Kansas, LLC, Wil Fischer Distributing of Poplar Bluff, LLC, Wil Fischer Distributing of St. Joseph, LLC, and Wil Fischer Distributing of Dodge City, LLC, who have one year of service. To become eligible the first eligible computation period, the employee must have worked at least 1,000 hours during the first twelve consecutive month period after commencing employment. The next eligible computation period will then switch to the Plan year. The employer operates locations in Missouri and Kansas. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan, subject to IRS guidelines. The Company may make matching contributions equal to a discretionary percentage of the participants’ elective deferrals. The total amount of employer matching contributions allocated to a participant in any plan year will not exceed 4% of plan compensation. For the year ended December 31, 2024 and 2023, the Company matched up to 3% of the employee deferral plus .5% of every percent above 3% up to a maximum of 4% match.

c. Participants’ accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) plan earnings. Allocations are based on participant earnings or account balances, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

d. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s matching portion of their accounts plus actual earnings thereon is based on years of service (1,000 hours of service). A participant is 100% vested after six years of credited service.

1. Description of the plan (continued)

The vesting schedule is as follows:

Less than two years	0%
Two years but less than three years	20%
Three years but less than four years	40%
Four years but less than five years	60%
Five years but less than six years	80%
Six or more years	100%

e. Payment of benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account (automatic if under \$5,000), or directly to an eligible retirement plan as a "tax-free rollover."

f. Forfeited accounts

At December 31, 2024, forfeited nonvested accounts totaled \$389. These accounts are used to restore forfeited accounts if re-employed and then to reduce future employer contributions and/or pay fees.

g. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

h. Parties-in-interest

Reliance Trust Company is the trustee/custodian of the Plan's investments and executes transactions therein. The Plan sponsor is Wil Fischer Distributing Co., Inc. (the Company). The Company's owner is a participant in the Plan as well as the Plan administrator. Roberts, McKenzie, Mangan & Cummings, PC is the Plan's independent auditor, ADP Retirement Services is the third party service provider. Each of these entities/individuals are classified as parties-in-interest with respect to the Plan.

i. In-Service Withdrawals

Certain participants may make withdrawals prior to termination of employment. Participants who have obtained the age of 59½ are allowed to receive a distribution of all or any portion of their vested account balances in a single sum payment.

j. Participant Investment Rollovers

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

2. Summary of significant accounting policies

The following are the significant accounting policies followed by the Plan:

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in common collective trust funds, including the Invesco Stable Asset Fund, which is an indirect investment in a fully benefit-responsive investment, are valued using Net Asset Value (“NAV”) as a practical expedient, and are recorded at the Plan’s proportionate share of the contract value as determined by the fund manager. This is considered the fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Payment of benefits

Benefits are recorded when paid.

3. Information prepared and certified by Qualified Institution

The December 31, 2024 and 2023 Statements of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part from information certified by the Trustee in accordance with 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified at December 31, 2024 and 2023 includes investments in mutual funds and collective trusts of \$10,046,064 and \$8,858,890, and related income of \$1,129,993, for the year ended December 31, 2024.

4. Investment contracts with common collective trust funds

Invesco Stable Asset Fund’s objective is to seek preservation of principal and to provide interest income reasonably obtained during prevailing market conditions and rates. For the year ended December 31, 2024, the fund earned a 2.91% calendar year return.

5. Fair value measurements

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability; and
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value collective trust fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

5. Fair value measurements (continued)

Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Administrative costs

All administrative costs not otherwise shown are absorbed by the Plan sponsor.

7. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Tax status

The Plan has been designed to qualify under Section 401 of the Internal Revenue Code (Code). The Plan operated under a standardized adoption agreement in connection with a volume submitter retirement plan and trust document sponsored by ADP, LLC. This volume submitter plan document has been filed with the appropriate agency and has obtained its latest determination letter dated October 6, 2020. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Separated participants

At December 31, 2024, \$57,508 of the net assets available for benefits are for those participants who have separated from active service with the Plan sponsor.

10. Subsequent event

The Plan has evaluated subsequent events through September 30, 2025, the date which the financial statements were available to be issued. There were no other significant events noted that did not exist at the date of the statements of net assets available for benefits but arose subsequent to that date.
