We have performed audits of the accompanying financial statements of Trader Interactive, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1—Description of the Plan

The following brief description of the Trader Interactive, LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Reference should be made to the amended and restated Plan Agreement for a more complete description of the Plan’s provisions.

General – Trader Interactive, LLC (the “Company” and “Employer”) established the Plan on July 28, 2017, and amended and restated the Plan on March 1, 2023. There were no material modifications made to the Plan as a result of the most recent plan amendment. The Plan is a defined contribution plan covering certain employees of Trader Interactive, LLC (the “Company” and “Employer”) who have attained 18 years of age and who have one month of service. All employees except for members of a collective bargaining unit, nonresident aliens, leased employees, temporary employees, seasonal employees, and interns are eligible to participate. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Administration – The Company is the Plan sponsor. The Company outsourced the recordkeeping function of the Plan to ADP Retirement Services and the trustee function to Reliance Trust Company, the “qualified institution” of the Plan. Certain administrative functions are performed by employees of the Company. These employees do not receive compensation from the Plan.

Participant Contributions – Participants may contribute up to 50% of pretax annual compensation, as defined in the Plan, and no more than the maximum amount permitted by law subject to certain Internal Revenue Code (“IRC”) limitations. The maximum contribution limit for 2024 was \$23,000. Participants who are 50 years or older during the Plan year may make additional pretax contributions referred to as catch-up contributions. The limit on catch-up contributions for 2024 was \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. In addition, a participant may direct after-tax contributions into Roth 401(k) accounts, subject to certain limits. Roth 401(k) accounts allow participants to elect to be taxed currently on part or all of their contributions made to the Plan. Future distributions of Roth 401(k) contributions and the related earnings are not taxed if certain requirements are met.

Employer Contributions – The Employer matches 100% of the participant’s elective deferral contribution up to 4% of the participant’s annual compensation. Participants must complete a year of service to be eligible for employer contributions. The Company may also make a discretionary, non-elective contribution each year on behalf of the Plan’s participants. There was no discretionary, non-elective contribution made during 2024. The matching contribution is invested as directed by the participant.

Participant Accounts – Each participant’s account is credited with the participant’s and Company’s discretionary-matching contribution and an allocation of: (a) the Company’s discretionary, nonelective contributions and (b) investment earnings or losses (including net appreciation (depreciation) in fair value of investments) and charged with an allocation of administrative expenses not paid by the Company. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are 100% vested in their account balance and Company contributions.

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by their highest outstanding note balance during the past 12 months or 50% of their vested interest, subject to certain Plan restrictions. The notes are secured by the balance in the participant’s account, and the interest rate will be computed using the prime rate (as specified in the Wall Street Journal), plus 1%. Notes must be repaid within five years. If the note is made for the purchase of a participant’s residence, the note may be repaid over a reasonable period of time longer than five years, up to 30 years.

Note 1—Description of the Plan (continued)

Participant Investment Account Options – Upon enrollment in the Plan, a participant may direct contributions into any of various investment options held by the qualified institution. Participants may change their investment options at their discretion.

Hardship Distributions – Hardship distributions are permitted if the distribution is due to expenses incurred or necessary for medical care described in IRC Section 213(d), purchase of a principal residence, payment of tuition, to prevent eviction from or foreclosure of the principal residence, or any other condition which the Commissioner of the Internal Revenue Service (“IRS”) determines is deemed an immediate and financial need of the participant. Any distributions will be taken first from the participant’s pre-tax deferral account and then from the participant’s Roth deferral account.

Benefits and Payments – On termination of service due to death, disability, or retirement, a participant will receive a lump-sum amount equal to the value of the participant’s vested interest in their account. Participants who have reached the age 70½ may be required to take certain minimum distributions. Participants may also withdraw all or any part of their vested account balance after having attained age 59½ or incurred a disability in accordance with the Plan.

Note 2—Summary of significant accounting policies

Basis of Accounting – The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Such estimates include those regarding fair value. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Fair value measurements and disclosures provide the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three Levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

Note 2—Summary of significant accounting policies (continued)

The financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no significant changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 of the valuation hierarchy.

Stable Value Collective Trust Fund – The Plan invests in the MetLife Stable Value Fund, a collective trust fund. The fair value of the Plan's interest in the fund is based on NAV as determined by the fund manager based on the underlying investments of the fund (primarily guaranteed investment contracts and fixed-income securities) and as supported by the unit prices of actual purchases and sales transactions occurring as of or close to the financial statement date. NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The fund provides for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date. There are no unfunded commitments related to this investment.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date and interest income is recognized when earned. Net appreciation in fair value of investments includes the Plan's gains on investments bought and sold as well as held during the year.

Benefits Paid to Participants – Benefits are recorded when paid.

Administrative Expenses – The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses relating to the specific participant transactions, including notes receivable from participants and distributions, are charged directly to the participant's account.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participants' account and are included in administrative expenses. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent loans are treated as deemed distributions based upon the terms of the Plan document. At December 31, 2024 interest rates ranged from 4.25% to 9.50%.

Note 3—Information certified by the Plan’s qualified institution (unaudited)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the qualified institution has certified the following data included in the accompanying financial statements and supplemental schedule as complete and accurate:

- Investments at fair value and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 5—Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant becomes fully vested with the amount of credit in their individual account and under no conditions will any part of the account revert to the Company.

Note 6—Tax status

The Plan has not obtained a determination letter from IRS stating the Plan was in compliance with the applicable requirement of the IRC. The Plan is relying on the IRS approval of the volume submitter plan that it is utilizing. The IRS has determined and informed the document sponsor, by a letter dated October 6, 2020, that the volume submitter plan document was designed in accordance with applicable sections of the IRC. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7—Party-in-interest transactions

Administrative fees paid by the Plan during the year ended December 31, 2024 were based on customary and reasonable rates. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid during the year for accounting and other services rendered by parties-in-interest were based on customary and reasonable rates for such services. While these transactions qualify as party-in-interest activity, they are expressly exempted from the prohibited transaction rules (ERISA, Title I, Section 408(b)).

Note 8—Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9—Subsequent events

The Plan has evaluated subsequent events through September 2, 2025, in connection with the preparation of these financial statements, which is the date the financial statements were available to be issued.
