Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Cliffs Club Services 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1—Description of the Plan

The following description of the Cliffs Club Services 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan, which was adopted October 1, 2020, and most recently amended effective January 1, 2023, for the benefit of Cliffs Club Services, LLC’s (the “Company”) employees, is a defined contribution plan under Section 401(k) of the Internal Revenue Code (“IRC”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Employees who have attained 21 years of age and completed one year of service with a minimum of 1,000 hours worked during that year are eligible to participate in the Plan. Plan entry dates are the first day of each month. Leased employees and employees of any member of the controlled and/or affiliated service group whose employer does not affirmatively adopt this Plan are not eligible to participate.

Contributions – Participants may contribute up to 90% of eligible compensation not to exceed the annual maximum deferral prescribed by law.

Rollover contributions to the Plan are permitted upon meeting certain requirements.

Company matching contributions are determined each year at the discretion of the Company. The Company provided a discretionary match equal to 25% of the first 6% contributed during 2024.

Qualified non-elective contributions may be made by the Company in order to satisfy the non-discrimination tests described in the IRC. Qualified non-elective contributions are allocated to non-highly compensated Plan participants. Allocations are made to the participants with the least “test compensation” in the ascending order of test compensation until the qualified non-elective contribution has been fully allocated. The Company did not make any qualified non-elective contributions for the year ended December 31, 2024.

Discretionary profit sharing contributions may be made by the Company. The Company’s profit sharing contribution percentage is determined at the discretion of the Company’s Board of Directors. Discretionary profit sharing contributions are allocated as of the last day of the Plan year to every active participant on that date or to any participant who has retired, becomes totally disabled or died, and was active in the Plan during the Plan year. The allocation is based upon the participant’s proportionate share of the total eligible compensation paid during that Plan year. No discretionary profit sharing contributions were made for the year ended December 31, 2024.

Vesting – Participants are 100% vested in their voluntary salary reduction contributions, including any investment gains or losses on the contributions. The effective vesting schedule regarding employer contributions is as follows: 0% after one year of service, 0% after two years of service, and 100% after three years of service.

Forfeitures – Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. These forfeited amounts are used to pay administrative expenses or reduce future employer contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$16,983 and \$17,853, respectively. During the year ended December 31, 2024, \$35,954 was used to reduce employer contributions and no forfeitures was used to pay administrative expenses.

Investment Options – Upon enrollment in the Plan, participants may direct their contributions, the Company’s discretionary matching contributions, the Company’s discretionary profit sharing contributions, and the Company’s qualified non-elective contributions, if any, in a variety of investment options as more fully described in the Plan’s literature. Participants may change their investment options at any time.

Note 1—Description of the Plan (continued)

Participant Accounts – Each participant's account is credited with the participant's contribution and an allocation of (a) discretionary matching, discretionary profit sharing, and non-elective contributions (if any); (b) Plan earnings and losses; and (c) forfeitures of terminated participants' non-vested accounts if not used to offset employer contributions. The participants' accounts are also charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance. Loans terms range from one to five years, or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and accrue interest at rates from 4.25% to 9.50%, which represent the prevailing rates similar to the rate charged for a loan made under similar circumstances by persons in the business of lending money. Loans mature through December 2029. Principal and interest is paid ratably through monthly payroll deductions.

Withdrawal and Payment of Benefits – On termination of service, if a participant's account does not exceed \$5,000, the Plan will automatically distribute the participant's vested account balance in a lump sum. Upon termination of service for participants with account balances over \$5,000, the participant may elect at any time to receive the value of the participant's vested interest in his or her account in the form of a single lump sum, installment payments over a specified period of time, part lump sum and part installments, or rollover the vested balance into an IRA or other qualified plan.

Participants still employed may withdraw all or part of their vested account, excluding earnings, upon furnishing proof of financial hardship.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants prior to March 15 of the subsequent year.

Note 2—Summary of significant accounting policies

Basis of Accounting – The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates. Significant estimates of the Plan's financial statements include the measurement of the fair value of investments, further described in Note 3.

Contributions – Employee contributions are recorded in the period during which the Company makes payroll deductions from the participants' earnings.

Discretionary matching and profit sharing contributions and qualified non-elective contributions are accrued and paid based on amounts to be funded for each year under the Plan provisions and the applicable requirements of the IRC.

Investment Valuation and Income Recognition – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Investment Committee determines the Plan’s valuation policies utilizing information provided by the investment advisors and Reliance Trust Company, the “qualified institution” of the Plan. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in common collective trust funds and mutual funds are deducted from income earned on a daily basis and are separately reflected as administrative expense on the statement of changes in net assets available for benefits. Consequently, management fees and operating expenses are reflected as a reduction of investment returns.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Administrative Expenses – Personnel within the Company perform many administrative duties of the Plan, including maintenance of personnel files and reconciliation of payroll records, at no charge to the Plan. Other administrative costs, such as professional fees, are charged to the individual participants’ accounts. Any costs not paid by the Plan may be paid by the Company.

Payment of Benefits – Benefits are recorded when paid.

Risks and Uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Note 3—Fair value measurements

Fair value as defined under U.S. GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. U.S. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

Level 1 – Observable inputs such as quoted prices in active markets.

Level 2 – Inputs other than quoted prices in active markets that are either directly or indirectly observable.

Level 3 – Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan’s assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

Following are descriptions of the valuation methodologies used for assets measured at fair value. No changes have occurred in the methodologies for December 31, 2024 or 2023.

Mutual Funds – These investments are public investment vehicles with a readily determinable fair value. The funds are classified within Level 1 of the valuation hierarchy.

Common Collective Trusts – Valued at a daily net asset value (“NAV”), which is not traded in an active market or exchange. Each investment is valued at a daily calculated unit value as provided by the administrator of the fund. The common collective trust held by the Plan is further classified as a stable value fund, which has indirect investments in synthetic and traditional guaranteed investment contracts. As the investment is indirect, there is no readily determinable fair value and the trust is valued at NAV as a practical expedient; therefore, it is shown outside the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6—Party-in-interest transactions

The Company has outsourced the recordkeeping function of the Plan to Automatic Data Processing, Inc. (“ADP”) and uses Royal Investment Associates for investment advisory services. Fees paid by the Plan to ADP and Royal Alliance Associates, Inc. totaled \$40,066 and \$13,575, respectively, for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions.

Note 7—Income tax status

The Company adopted a prototype non-standardized profit sharing plan with a cash or deferral arrangement. The prototype plan received a favorable opinion letter from the IRS on October 6, 2020, which stated the Plan is designed in accordance with applicable sections of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan has not received a determination letter specific to the Plan itself; however, The Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

Note 8—Plan termination

Although, it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
