Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**Note 1. Description of the Plan**

***General***

The following description of Nwestco Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Nwestco, LLC (the Company) for the benefit of its employees who are age 21 or older and have completed one month of service, as defined. The Plan is subject to provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Empower Annuity Insurance Company of America was the insurance company for the Plan, and issuer of the guaranteed investment contract, and served as the record keeper for the Plan during 2022. Empower Trust Company, LLC was the custodian of the Plan during 2022. Effective January 1, 2023, the Plan was amended to change custodians to Reliance Trust Company, LLC and to change recordkeeper to ADP Retirement Services. The guaranteed investment contract agreement was terminated during 2023. The President is the trustee of the Plan.

***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 90% of eligible compensation. Employee rollover and Roth contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company may make matching contributions as determined by the Company. For 2024 and 2023, the Company made matching contributions equal to 100% of each participant's contributions limited to participant contributions on the first 3% of eligible compensation. Contributions are subject to certain limitations.

***Transfer of Plan Assets***

On January 31, 2024, Nwestco, LLC acquired Able Environmental Technologies and approved an amendment to terminate the Able Environmental Technologies 401(k) Plan effective May 17, 2024. All participants in the Able Environmental Technologies 401(k) Plan became 100% vested in that Plan upon termination and were provided the option to have their account balance rolled into any qualified plan (including the Plan) or IRA, receive a lump-sum distribution or be paid through an annuity contract. An aggregate of \$1,094,431 was rolled into the Plan during the year ended December 31, 2024, and is included as a transfer on the statement of changes in net assets available for benefits.

***Participant Investment Account Options***

Each participant has the option of directing his contributions into any of the various investment options offered by the Plan and may change the allocation daily.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contributions, if any, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after six years of continuous service.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1.00% above the prime rate. Principal and interest is paid ratably through weekly payroll deductions.

***Payment of Benefits***

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or, in certain circumstances, as defined, installments over a period of not more than the life expectancy of the participant or beneficiary. For termination of service or for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

***Forfeited Accounts***

At December 31, 2024 and 2023 forfeited nonvested accounts totaled \$36,744 and \$15,533, respectively. These accounts may be used to pay plan expenses and based on the type of employer contribution, may be used to reduce any company matching contributions or reallocated to participants in the same manner as employer nonelective contributions. During 2024 and 2023, \$6,805 and \$9 of forfeitures were used to reduce company matching contributions or to pay plan expenses, respectively.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes in net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sale of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Insurance Company and Custodian**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, during 2023 and 2024, Reliance Trust Company, the trustee and custodian for the Plan, (qualified institution) has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at year-end) is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year-end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

#### **Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Individually nonmaterial expenses paid to parties in interest aggregated \$39,158 and \$25,235 during the years ended December 31, 2024 and 2023, respectively.

The Company pays directly any other fees related to the Plan's operations and provides certain administrative services at no cost to the Plan.

#### **Note 5. Plan Amendment**

Effective January 1, 2023, the Plan was restated with the change in custodian and recordkeeper from Empower Trust Company to Reliance Trust Company.

Effective May 1, 2024, the Plan document was amended and restated to include employees of Able Clean-up Technologies, Inc. The Company acquired Able Clean-up Technologies, Inc. in 2024.

Effective June 1, 2024, the Plan document was amended and restated to recognize service time for employees of acquired entities either through asset or stock purchases towards eligibility, vesting allocations, and contributions.

Effective December 1, 2024, the Plan document was amended and restated to allow forfeitures to be used to reduce any Employer contribution on an annual basis and to be used to reduce any Employer contribution on a per payroll period basis.

#### **Note 6. Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan has no Level 2 or Level 3 investments.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**Note 8. Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by ADP, LLC. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 10. Subsequent Events**

Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

The Company acquired Gettler-Ryan, Inc. in 2025. Effective April 1, 2025, the Plan document was amended and restated to include employees of Gettler-Ryan Inc. Employee Savings Plan into this plan and recognize their years of service.
