Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Georges Enterprises 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS**Georges Enterprises 401(k) Plan**

December 31, 2024 and 2023

Note 1 - DESCRIPTION OF PLAN

The following description of the Georges Enterprises 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

a. General

The Plan is a defined contribution plan of Georges Enterprises, LLC (the “Company” or “Plan Sponsor”) and its participating affiliates. Employees of the Company and participating affiliated companies who have at least three months of service and are age twenty-one or older, except collective bargaining employees, non-resident aliens, and leased employees, as defined in the plan agreement, are covered under the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

b. Contributions

Each year, participants may contribute from 1% to 75% of their pre-tax annual compensation, as defined in the plan agreement. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan includes an automatic contribution arrangement. Under this arrangement, the Company and its participating affiliates withhold 3% of compensation from participants who fail to make an affirmative deferral election upon entering the Plan. In addition, the initial automatic deferral amount of 3% increases 1% each succeeding year on the anniversary date of the automatic contribution until a 6% deferral percentage is reached for participants who have not made an affirmative deferral election. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Additionally, the plan agreement provides that participants may make Roth contributions to the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company and its participating affiliates are allowed to make flexible discretionary matching contributions under the Plan. For 2024, the Company and its participating affiliates made flexible discretionary matching contributions in the amount of 25% of participant contributions up to 6% of compensation in the amount of \$539,859. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Note 1 - DESCRIPTION OF PLAN (Continued)

c. Participant Accounts

Each participant's account is credited with the participant's contributions and company matching contributions, as well as allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

d. Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the company matching contribution portion of their accounts is based on years of continuous service, as defined in the plan agreement as follows:

However, a participant will become fully vested upon reaching normal retirement age of 62, or upon death or disability.

e. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is the U.S. Federal Reserve bank Prime rate plus 1%. Loan terms may not exceed five years except for the purchase of a principal residence where the plan administrator may permit a longer repayment term. Principal and interest is paid ratably through payroll deductions.

Note 1 - DESCRIPTION OF PLAN (Continued)

f. Payment of Benefits

Participants may receive the full value of their vested account due to death, disability, retirement, or termination of employment. Distributions are made as soon as administratively feasible and are distributed in a single lump sum payment, substantially equal installments, or partial withdrawals. In-service distributions are allowed to participants that have attained age 59½. Participants may make hardship withdrawals as defined by the plan agreement.

g. Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$64,252 and \$74,866, respectively. These accounts will be used to reduce future plan expenses and employer contributions. During the year ended December 31, 2024, forfeitures totaling \$61,968 were used to reduce plan expenses.

Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

a. Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

b. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

c. Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

d. Notes Receivable from Participants

Notes receivable from participants are valued at amortized cost, consisting of principal outstanding and any related accrued interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan agreement. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

e. Excess Contributions Payable

As of December 31, 2024, a liability of \$5,707 was recorded as excess contributions payable in the statement of net assets available for benefits for amounts due to highly compensated employees, necessary to satisfy ERISA non-discrimination rules with a corresponding reduction to participant contributions. The Plan distributed these excess participant contributions to the applicable participants prior to March 15, 2025.

f. Payment of Benefits

Benefits are recorded when paid.

g. Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

h. Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

Note 3 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value and notes receivable from participants, held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (“Reliance”), the trustee of the Plan.

Note 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Note 4 - FAIR VALUE MEASUREMENTS (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

- *Mutual Funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Common Collective Trust Fund*: Valued at NAV of the units in the collective trust. The NAV provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser may reserve the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidation will be carried out in an orderly business manner. There are no unfunded commitments or redemption restrictions, and this investment is redeemable on a daily basis.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain plan investments are shares of a common collective trust fund managed by Reliance. Reliance is the trustee of the Plan and provides custodial and asset management services to the Plan and, therefore, these transactions qualify as party in interest transactions.

Reliance receives revenues from fund service providers for administrative services it provides to funds which the Plan invests. This revenue is used to offset certain amounts owed to Reliance for its administrative services to the Plan. Excess revenues received by Reliance may be used to pay plan administrative expenses or may be allocated to the accounts of participants. During 2024, excess revenue sharing amounts earned were \$5,553. As of December 31, 2024 and 2023, there were unused credit balances of \$38,593 and \$32,008, respectively.

Note 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company and its participating affiliates have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7 - TAX STATUS

The Plan, originally effective January 1, 1999, was amended and restated July 31, 2022. The amended and restated Plan is a Non-Standardized Pre-Approved plan and has received a favorable advisory letter from the IRS dated October 6, 2020. The Plan itself has not separately applied for tax-exempt status; however, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 - PLAN AMENDMENT

Effective January 1, 2024, the Plan was amended to allow eligible employees entrance into the Plan upon satisfaction of three months of service as of the first day of the month coinciding with or next following date requirements met.

Note 10 - SUBSEQUENT EVENT - PLAN CORRECTION

The Plan's eligibility provisions were amended effective January 1, 2024 to allow employees with three months of service to enter the Plan. Prior to this amendment, the service requirement was one year. During 2025, it was discovered that certain employees who became eligible to participate in the Plan as a result of this amendment, were not allowed entrance into the plan upon completion of three months of service, in error. Plan management is currently in the process of determining those who were affected and the amounts involved and intends to fully correct the error under applicable regulations.
