### Note 1 - Plan Description

The following description of Legence 401(k) Plan (f/k/a Legence 401(k) Profit Sharing Plan) (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible employees and affiliates of Legence Holdings LLC (the "Company") and its subsidiaries. On July 1, 2024, the Plan changed its legal name to Legence 401(k) Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company has been appointed to administer the Plan. Reliance Trust Company (Reliance) serves as the trustee and investment manager, and ADP Retirement Services maintains the Plan's records. The Plan offers participants a variety of investment options. Individual accounts are invested in the various options at the direction of the participants.

#### **Contributions**

The Plan provides for employee salary deferral contributions, on a tax-deferred or after-tax basis, up to a maximum of 90 percent of annual eligible compensation subject to limitations established by the Internal Revenue Code. As of February 1, 2024, eligible participants are automatically enrolled to participate in the Plan at a deferral rate equal to 4 percent of eligible annual compensation, as specified in the plan document, unless they elect not to participate or have specified a different deferral percentage. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions, as limited by the Internal Revenue Service (IRS). Employee contributions to the Plan are made through regular payroll deductions.

Rollover contributions for the year ended December 31, 2024 totaled \$53,849,763. The Company acquired two subsidiaries during 2024, which were added as participating employers to the Plan. Participants were given the option to roll over the balances from the previous plans of the two subsidiaries into the Plan or another qualified plan.

Certain participant contributions in 2022, 2023, and 2024 were paid after the time frame required by the Department of Labor. For 2022 late contributions, these have not been fully corrected and lost earnings are expected to be remitted in 2025. For 2023 late contributions, some contributions were fully corrected in 2024 and the remainder of 2023 late contributions are expected to be fully corrected in 2025. For 2024 late contributions, some contributions were fully corrected in 2024 and the remainder of 2024 late contributions are expected to be fully corrected in 2025.

The Company will make a safe harbor matching contribution of 100 percent of elective deferrals up to 4 percent of eligible compensation. The Company also may elect to make additional matching contributions. During the year ended December 31, 2024, the Company did not make additional matching contributions. The Company has the right to designate all or a portion of the additional matching contributions as qualified. To the extent matching contributions are so designated, they are nonforfeitable and may not be withdrawn from the Plan prior to separation from service or attainment of age 59½.

The Plan also allows for the Company to make a discretionary profit-sharing contribution to eligible participants employed on the last day of the plan year. During the year ended December 31, 2024, the Company did not make a discretionary profit-sharing contribution.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

**Note 1 - Plan Description (Continued)**

***Vesting***

Participants are immediately 100 percent vested in employee salary contributions, rollover contributions, safe harbor matching contributions, any additional matching contributions, and any income or loss thereon. Vesting in the Company's profit-sharing contributions and the earnings or losses thereon is based on years of service as follows:

A participant's account becomes 100 percent vested upon death, attaining normal retirement age (the age of 60 or, if later, the 5th anniversary date of the first day of the plan year during which the participant entered the Plan) or early retirement age (the age of 55 or, if later, the 10th anniversary date of the first day of the plan year during which the participant entered the Plan), retirement due to disability, or termination of the Plan.

***Benefit Payments***

Upon termination of service, disability, or reaching retirement age, participants may receive a lump-sum payment in the amount equal to the participants' vested account balances. Upon death, the participant's beneficiary may receive either a lump-sum payment or periodic installments. Terminated participants' accounts with balances of \$1,000 or less will be automatically distributed upon a distribution event.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The Company must approve any such hardship withdrawals.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances were \$2,800 and \$1,126, respectively.

***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range from 3.25 percent to 9.50 percent, which are commensurate with local prevailing rates determined periodically by the plan administrator. Principal and interest are paid ratably through payroll deductions.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

**Note 1 - Plan Description (Continued)**

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Reliance Trust Company or its affiliates. Reliance Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The common/collective trust fund is valued at net asset value per share (NAV) or its equivalent of the fund, which is based on the fair value of the fund's underlying assets. Investments in certificates of deposit included within the self directed brokerage account are valued based on the net present value of future cash flows. All other investments are valued based on quoted market prices reported in active markets. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Various administrative costs are paid by the Company.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 10, 2025, which is the date the financial statements were available to be issued.

As of January 1, 2025, ADP Retirement Trust Services, LLC will become the trustee of the Plan.

**Note 3 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

**Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

### Note 4 - Certified Information

Reliance Trust Company (the "Trustee") holds the Plan's investments, other than the self-directed brokerage accounts, and executes all related investment transactions. The investment balances and related investment results included in the accompanying financial statements and supplemental schedule of assets held at end of year, other than the self-directed brokerage accounts, are based solely on information certified by the Trustee.

The Plan's investments in the self-directed brokerage accounts totaling \$5,020,142 and \$3,736,515 at December 31, 2024 and 2023, respectively, and related investment income of \$1,147,879 for the year ended December 31, 2024 were not certified by Reliance Trust Company.

### Note 5 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

### Note 6 - Rollover Contributions

During 2024, eligible participants from P2S Inc. 401(k) Plan and AMA Group 401k Plan rolled over their investment and participant notes receivable balances into the Plan. The total of the investment balance was approximately \$51,141,000, which is included within rollover contributions, and the total of the participant notes receivable was approximately \$613,000, which is included within rollover loans.
