INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTE 1 - DESCRIPTION OF THE PLAN

Description of Plan

The following description of The Argen Corporation 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) retirement plan established as of January 1, 1993 and restated in November 2015, to provide retirement benefits for substantially all employees of The Argen Corporation (the "Company" or "Employer"). The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (the "Code") and similar state tax laws.

Eligibility

The Plan covers all employees of the Company who have attained age twenty-one and those that are eligible are then auto enrolled into the Plan for Company benefits on the first day of the month after 30 days of service. The enrollment date following eligibility is the first day of each month as defined in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Participant Contributions

Each year, participants may contribute from 1% to 100% of their compensation on a pretax basis, as defined in the Plan, up to \$23,000 for the year ended December 31, 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions of \$7,500.

Employer Contributions

The Employer may make an annual discretionary matching and non-elective contribution in an amount determined at the end of the prior Plan year end. Participants are eligible for Employer contributions upon eligible enrollment into the Plan. For the year ended December 31, 2024, the Employer made discretionary matching contributions of 33% of the participant's eligible compensation up to a maximum of \$1,500. There were no non-elective contributions for the year ended December 31, 2024. Employer contributions are made on a pay period by pay period basis.

Rollover Contributions

The Plan provides for rollover contributions, which represents contributions by participants from other tax-qualified retirement plans. The maximum amount of a participant's rollover contribution is not affected by the limits otherwise applicable to participant contributions.

NOTE 1 - DESCRIPTION OF THE PLAN (continued)

Participant Accounts

Separate accounts are maintained for each participant. Each participant's account is credited with the participant's salary reduction, rollover contributions, the Employer's matching contribution, the participant's share in the Plan's earnings and losses, and charged with an allocation of administrative expenses which are allocated proportionately among all participants based on their investment in each fund. Plan earnings and losses are allocated proportionately based on each participant's investment in each fund. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their contributions to the Plan plus actual earnings thereon. Participants become vested in the Employer's contributions and earnings thereon at a rate of 100% vesting after 1 year of credited service. A participant automatically becomes fully vested in the entire balance of his or her account upon retirement, death, disability or termination of the Plan.

Forfeited Accounts

Upon termination of employment, the unvested portion of a participant's Employer contribution account is forfeited. Amounts representing forfeitures of Employer matching contributions and non-elective contributions shall be used to pay administrative expenses or reduce Employer contributions to the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$9,109 and \$8,775, respectively. In 2024, no forfeitures were used to reduce Employer contributions or pay administrative expenses.

Notes Receivable from Participants

Participants may request to borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans have a term of up to 5 years for general loans. Loans have a term of up to 15 years for the purchase of a primary residence. The loans are secured by the balance of the participant's account and bear interest at rates set forth by the Plan Administrator which approximate the prevailing market rates of interest. The interest rates on outstanding participant loans ranged from 4.25% to 9.50% at December 31, 2024 and 2023. Principal and interest is paid ratably through monthly payroll deductions.

Payment of Benefits

Upon disability, retirement, termination, or death, participants may elect to receive a distribution of their account (as defined) in lump sum or defer distribution if the account exceeds \$5,000. However, if such a participant's vested account balance is less than \$5,000, but greater than \$1,000, the Plan Administrator may roll the balance into an individual retirement account. Also, at its discretion, the Plan Administrator may elect to distribute vested account balances of less than \$1,000. Generally, initial distributions must begin the later of the April 1 of the calendar year following the year in which the participant attains the age of 72 or retires.

Hardship Withdrawals

Participants may withdraw their vested contributions in the event of hardship as defined in the Plan agreement.

Administrative Expenses

The Company pays expenses incurred for the administration and operation of the Plan. Other administrative fees associated with distributions and loans are paid by the participants. For the year ended December 31, 2024, administrative expenses paid by the Plan were \$65,587.

Plan Termination

Although it has not expressed any intent to do so, the Employer has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Employer contribution accounts. In the event of Plan termination, all amounts credited to accounts of participants shall be paid to each participant in accordance with the Plan agreement.

SECURE 2.0 Act of 2022

The Plan has implemented certain requirements of the SECURE 2.0 Act of 2022 ("SECURE 2.0"). The provisions implemented in 2024 include, among others, an increase in the required minimum distribution age from 72 to 73, reduced service requirements for long-term, part-time employees to participate in the Plan, and the removal of the pre-death required minimum distribution requirement for Roth accounts. Future provisions will be adopted at later dates, as necessary, to comply with the requirements of SECURE 2.0.

Subsequent Events

The Plan Administrator has evaluated subsequent events, as defined by Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 855, *Subsequent Events*, through the date that the financial statements were available to be issued on October 8, 2025.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value and contract value. See Note 4 for discussion of fair value measurements and Note 5 for discussion of contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends (if declared) are recorded on the ex-dividend date.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation or depreciation in the fair value of its investments, which consists of the realized gains or losses on those investments bought and sold during the year and the unrealized appreciation or depreciation on investments held at year end.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Benefits Due to Terminated Participants

Funds due to participants that have terminated employment, but have not yet been distributed are not presented as liabilities in the statements of net assets available for plan benefits. They are reflected in the statement of changes in net assets available for plan benefits when paid. As of December 31, 2024 and 2023, there were no amounts payable to terminated Plan participants.

NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEE

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA, certain information prepared and certified by a qualified institution need not be audited or reported on by an independent auditor. Pursuant to that regulation, the Plan Administrator has instructed the independent auditors not to perform any auditing procedures with respect to information certified by Reliance Trust Company (the "Trustee"), as of December 31, 2024 and 2023, and for the year ended December 31, 2024. All Plan assets are held by the Plan's Trustee, who is responsible for the maintenance of all accounting records and the preparation of reports of activity related to those assets.

The Trustee has certified to the Plan Administrator that the following information is complete and accurate as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan investments are reported at fair value in the accompanying statements of net assets available for benefits. Fair value is based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In order to increase consistency and comparability in fair value measurements, accounting rules for fair value measurements establish a fair value hierarchy that prioritizes observable and unobservable inputs used to measure fair value into three broad levels, which are described below:

Level 1: Quoted prices (unadjusted) in active markets that are accessible at the measurement date for identical assets or liabilities. The fair value hierarchy gives the highest priority to Level 1 inputs.

Level 2: Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in inactive markets; or model-derived valuations in which all significant inputs are observable or can be derived principally from or corroborated with observable market data.

Level 3: Unobservable inputs are used when little or no market data is available.

The fair value hierarchy gives the lowest priority to Level 3 inputs.

In determining fair value, the Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs to the extent possible as well as considers counterparty credit risk in its assessment of fair value. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Mutual Funds

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the mutual fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Mutual Funds (continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There was no change in the fair value methodology used at December 31, 2024 and 2023.

NOTE 5 - STABLE VALUE FUND

The Putnam Stable Value Fund (“Fund”) invests in guaranteed investment contracts and similar contracts issued by insurance companies, banks and other financial institutions; security-backed investment contracts, including separate account products of insurance companies; and in money-market, cash, cash equivalents and short-term bonds. The objective of the Putnam Stable Value Fund is to deliver intermediate bond like returns with money market liquidity. There are no unfunded commitments, withdrawal restrictions, redemption notice requirements or other redemption restrictions. The Fund may be redeemed daily. The Fund is benefit responsive, and thus, is reported at contract value. The fair value of the Fund as of December 31, 2024 and 2023, was \$2,648,788 and \$3,031,072.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants’ account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 - TAX STATUS

The Plan utilizes a Defined Contribution Volume Submitter Plan of a third-party administrator. The third-party administrator obtained its latest advisory letter on July 16, 2014, in which the Internal Revenue Service (“IRS”) stated that the document is designed and in compliance with the applicable requirements of the Code. Although the document has been amended and restated since receiving this determination letter, the Plan Administrator, the Plan's Trustee and third-party administrator believe the Plan is designed and currently operating in compliance with the applicable requirements of the Code; and therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the tax authority. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the Trustee, therefore, these transactions qualify as exempt party-in-interest transactions. All other transactions, which may be considered exempt parties-in-interest transactions, relate to normal Plan management and administrative services.
