Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of AeroVironment, Inc. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the AeroVironment, Inc. Profit Sharing and Salary Deferral 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that was established by AeroVironment, Inc. (the Employer) on June 1, 1985. The Plan is administered by the plan administrative committee, consisting of individuals appointed by the Employer's Board of Directors. All full-time employees become eligible to participate in the Plan after one year of service and if they have attained the minimum age requirement of 18 years old. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Employees who elect to participate in the Plan may contribute up to 75 percent of their pretax annual compensation subject to certain limitations as prescribed by the Internal Revenue Code (IRC). Contributions received in excess of those limitations are disbursed to participants subsequent to the Plan's year-end. Participants may also contribute amounts representing distributions or rollovers from other qualified defined benefit or defined contribution plans.

The Employer may elect to make discretionary profit sharing contributions to the Plan from net profits in an amount determined by the Employer. The profit sharing contribution is allocated among the participants in proportion to each participant's compensation to total compensation of all participants. For the year ended December 31, 2024, the Employer did not make any profit sharing contributions to the Plan.

The Employer has adopted a 401(k) Safe Harbor provision to satisfy certain IRC requirements and eliminate the need for the Plan to perform certain annual nondiscrimination tests. Under the provision, the Employer has elected to make matching contributions to all participants up to 5.75 percent of the participant's eligible compensation. The participants are immediately fully vested in these contributions. To be eligible for the Employer matching contributions, participants must have completed 1,000 hours of service during the twelve-month period starting from their hire date.

The participant profit sharing and Employer matching contributions are allocated into various investment options offered by the Plan as the participants direct.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of (a) Employer contributions, (b) Plan earnings, and (c) forfeitures of terminated participants' nonvested accounts. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 reduced by the highest outstanding loan balance in the participant's account during the prior 12-month period, or 50 percent of their vested account balance. Loan terms range from 1 to 5 years, or up to 10 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest, which is commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid through bi-weekly payroll deductions.

Withdrawals

The government places certain restrictions on withdrawals in order to retain the special tax-saving benefits associated with the Plan. The Plan allows withdrawals at retirement, disability, separation of service, or upon death. Other withdrawals are available only in cases of immediate and heavy financial hardship subject to Internal Revenue Service (IRS) regulations. A participant's right to make deferrals will be suspended for six months after the receipt of a hardship withdrawal.

Vesting

Participants are immediately vested in their contributions plus accumulated earnings thereon. Employer contributions plus accumulated earnings thereon made under the Safe Harbor provisions (adopted May 1, 2008) are also 100 percent vested when made.

Employer contributions plus accumulated earnings thereon made prior to adoption of Safe Harbor provisions are vested based on a graded vesting schedule whereby a participant is 100 percent vested after 5 years of credited service or upon reaching retirement age, death, permanent disability or termination of the Plan by the Employer.

Benefit Payments

Upon termination of service due to retirement or permanent disability, a participant may elect to receive cash in one lump-sum payment or in installments equal to the value of the participant's vested interest in his or her account. In the event of a participant's death, payment of the vested value of the participant's account is made to his or her beneficiary in one lump-sum payment or in installments.

Forfeited Amounts

Employer contributions are fully vested when made and therefore not subject to forfeitures. Forfeited nonvested amounts as of December 31, 2024 and 2023 approximated \$8,000 and \$21,000 respectively.

Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Investments and Valuation Techniques

The Plan's investments, other than common collective trusts (CCT), are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan invests in the Putnam Stable Value CCT fund, which primarily invests in guaranteed investment contracts to deliver intermediate-bond-like returns, while seeking to maintain a stable net asset value. The Plan's interest in the fund is valued at the Net Asset Value (NAV) practical expedient of the underlying investments reported by the issuer of the CCT at year-end. This practical expedient would not be used if it was determined to be probable that the Plan will sell the investments for an amount different from the reported NAV. See Note 3 for discussion of fair value measurements.

Net appreciation and depreciation in fair value of investments includes realized and unrealized gains and losses on investments sold or held during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income from investments is recorded on the cash basis, which approximates the accrual method of accounting. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Expenses

Non-investment costs, primarily accounting and administrative expenses of the Plan, are paid for by the Employer, which is a party-in-interest. These expenses, which are not reflected in the accompanying financial statements, constitute exempt party-in-interest transactions. Loan servicing costs and certain administrative fees are paid by the Plan or charged against Plan investment activities and are included in the statement of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 3 - FAIR VALUE MEASUREMENTS

Fair value measurements establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active and inactive markets, inputs other than quoted prices that are observable for the asset or liability for substantially the full term of the financial instrument, and inputs that are derived from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

There have been no changes in methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - RELATED-PARTY TRANSACTIONS

Certain Plan investments are shares of registered investment companies (mutual funds) and common trusts managed by the trustees of the Plan. These transactions qualify as exempt party-in-interest transactions. For the year ended December 31, 2024, fees paid by the Plan for investment management and recordkeeping services approximated \$131,000 and \$107,000, respectively.

NOTE 7 - TAX STATUS

The Plan is a prototype 401(k) profit sharing plan (Prototype Plan) and conforms the operations of the Plan to the Prototype Plan. The Plan received a favorable determination letter from the IRS for the Prototype Plan dated July 16, 2014, stating that the Plan is qualified in accordance with applicable sections of the IRC, and the trust under the Plan constitutes a qualified trust and is therefore exempt from federal income taxes. The plan administrator believes the Plan is currently designed and operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 - SUBSEQUENT EVENTS

The date to which events occurring after December 31, 2024 have been evaluated for possible adjustment to the financial statements or disclosure is October 9, 2025, the date on which the financial statements were issued.
