Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of The Vintage Club Employee Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to Section 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with Section 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and December 31, 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the financial statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Responsibilities of Management for the Financial Statements

NOTE 1. DESCRIPTION OF PLAN

The Vintage Club Employee Retirement Plan (Plan) was adopted on July 1, 1995 (inception of the Plan) and is a qualified retirement plan designed to reward eligible employees to save for retirement. Effective August 1, 2023, the Plan was amended and restated and Reliance Trust Company was appointed as the Plan trustee and ADP was retained as the third-party administrator. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of The Vintage Club who have three (3) months of service and are age twenty-one (21) or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: *Employee salary deferrals:* Each year, participants may contribute up to the maximum allowable of pretax annual compensation, as defined in the Plan. For the year ended December 31, 2024, the maximum amount of compensation deferral was \$23,000, respectively. For participants age fifty (50) and older, an additional catch-up provision of \$7,500 was allowed during the year ended December 31, 2024.

Plan Sponsor safe-harbor matching contributions: For participants with one (1) or more years of service, the Plan Sponsor makes safe-harbor matching contributions equal to 100% of the first 3% of the participant's eligible compensation and 50% of the next 3% of participants' eligible compensation. These contributions vest to participants immediately.

Non-elective Contributions: The Plan Sponsor may make discretionary non-elective profit-sharing contributions to the Plan. Participants must be employed on the last day of the Plan year and completed at least 1,000 hours of service during the Plan year to be eligible.

Participant Accounts: Participant accounts are credited with participants' contributions, an allocation of Plan Sponsor contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses and Plan losses.

Vesting: Participants immediately vest in their elective contributions and Plan Sponsor safe-harbor matching contributions. Participants are vested on non-elective contributions based on a defined vesting schedule ranging from two (2) to six (6) years as defined in the Plan document.

Investment Options: All investment elections are self-directed by participants.

Forfeitures: Forfeitures balances arise when participants terminate employment before becoming fully vested in their full benefits under the Plan. The Plan Sponsor may elect to use forfeiture balances to reduce employer contributions.

Payment of Benefits: Upon termination of service, participants may elect to receive a lump-sum amount equal to the value of their account. Vested account balances not exceeding \$5,000 may be distributed in a lump-sum payment, subject to the appropriate income tax withholding regulations. Participants may also elect to roll over their account to another tax deferred account or remain in the Plan until they are legally required to take distributions. With Plan Administrator's approval, participants may withdraw all or part of their aggregate contributions in the event of financial hardship. Benefits are recorded when paid.

NOTE 1. DESCRIPTION OF PLAN (continued)

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 and a maximum of the lesser of \$50,000 or 50% of the participant's vested benefit in the Plan. Notes receivable are secured by the vested balance in the participant's account and accrue interest at the prime rate plus 1%. Principal and interest are paid through payroll deductions.

NOTE 2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Plan Fees and Administrative Expenses: Plan fees and administrative expenses are generally paid by the Plan, unless paid by the Plan Sponsor.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments consists of the change in unrealized appreciation or depreciation during the year and realized gains or losses on sales of investments during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Accounting for Uncertainty in Income Taxes: The Plan's policy is to recognize tax positions in the financial statements when it is more-likely-than-not the position will be sustained upon examination by the tax authorities. As of December 31, 2024, the Plan had no uncertain tax positions that qualify for either recognition or disclosure in the financial statements. As of December 31, 2024, the Plan's annual tax filings for the prior three (3) years are open for audit by the IRS.

Subsequent Events: The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued and has determined that no events or transactions require recognition or disclosure in these financial statements.

NOTE 3. PLAN TERMINATION

Although the Plan Sponsor has not expressed an interest in terminating the Plan agreement, it may do so at any time. Upon termination of the Plan, participants' shares in the Plan would become fully vested and distributed to them.

NOTE 4. CERTIFIED INFORMATION

The Plan's investment assets as of December 31, 2024 and December 31, 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management, and agreed to or derived from information certified by the Plans trustees. Reliance Trust Company, as of December 31, 2024 and 2023 and for the year ended December 31, 2024 The Plan Administrator has obtained certifications from the trustees that information provided to the Plan Administrator by the trustees related to the investment assets is complete and accurate. Accordingly, as permitted by Section 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedule.

NOTE 5. FEDERAL INCOME TAXES

On October 6, 2020, the IRS stated that the prototype non-standardized profit sharing plan with a cash or deferral arrangement adopted by the Plan is acceptable under Internal Revenue Code (IRC) Section 401. The Plan has not received an opinion letter specific to the Plan itself; however, the Plan Sponsor believes that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 6. PARTY-IN-INTEREST TRANSACTIONS

The Plan allows for transactions with parties who perform services or have fiduciary responsibilities to the Plan. As of December 31, 2024, the Plan's investments were in funds management by Reliance Trust Services, the trustee and ADP the third-party administrator of the Plan. These transactions qualify as party-in-interest transactions for which statutory exemption exists.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. The Plan's exposure to credit loss in the event of nonperformance of investments is limited to the carrying value of such investments. The Plan's provisions as well as those of ERISA and the participants' investment preferences dictate the Plan's concentrations of credit risk and market risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

NOTE 8. FAIR VALUE MEASUREMENTS

In accordance with the authoritative guidance on fair value measurements and disclosures, in conformity with accounting principles generally accepted in the United States of America, the Plan discloses the fair value of its investments in a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements).

NOTE 8. FAIR VALUE MEASUREMENTS (continued)

The fair value hierarchy is categorized into three (3) levels based on the inputs as follows:

- Level 1* Quoted prices in active markets for identical securities. When available, fair value is measured using Level 1 inputs.
- Level 2* Other significant observable inputs (including quoted prices for similar securities, interest rates, prepayment speeds, credit risk, etc.).
- Level 3* Used when Level 1 or Level 2 inputs were not available or significantly unobservable (including composite crediting rates and surrender charges).

An asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. As of December 31, 2024 and December 31, 2023, the fair value of Plan assets held in mutual funds were determined using Level 1 inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
