### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

### 1. Description of the Plan

The Andre-Boudin Bakeries 401(k) Plan (the Plan) was established by Andre-Boudin Bakeries, Inc., also known as Boudin Bakery (the Company), effective January 1, 1986, to provide participants with a method to fund their retirement on a tax-deferred basis. The following description of the Plan, as amended and restated, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General:*

The Plan is a defined contribution plan under the provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. The Plan is administered by Company employees. Reliance Trust Company (Reliance) serves as the Plan's trustee and ADP Retirement Services (ADP) serves as the Plan's record keeper. Reliance holds, invests and reinvests Plan assets in the interest and direction of the participants and their beneficiaries. The Company has engaged UBS Financial Services Inc. as an investment advisor to assist the Plan in selecting the investment options offered to the participants and monitoring investment performance.

In 2020, the Company acquired Artisan Bakers. In 2024, the Plan was amended and restated to merge the Artisan Bakers 401(k) Plan (the Merged Plan) into the Plan. In 2024, participant account balances totaling \$70,151 were transferred from the Merged Plan to the Plan.

#### *Eligible Participants:*

Employees, as defined by the Plan agreement, aged 21 or older, after three consecutive months and a minimum of 250 hours of service, may participate in the Plan on the first day of the month following all eligibility requirements being satisfied. Certain union, leased, and nonresident employees are excluded from participating in the Plan.

#### *Contributions:*

Participants are permitted to make voluntary pre-tax salary deferrals and Roth after-tax contributions up to 90% of their annual compensation, as defined in the Plan agreement. Participants who have reached the age of 50 may also elect to withhold additional "catch-up" contributions under the Code. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollovers), excluding rollovers of after-tax contributions, subject to Code regulations.

### 1. Description of the Plan (continued)

#### *Contributions:* (continued)

The Plan provides for automatic enrollment on the date participants become eligible to participate in the Plan. The automatic salary deferral contribution for eligible participants is 3% of their compensation, unless participants request a different amount to be contributed or formally decline participation. Participants may adjust their deferral rate or discontinue their contributions at any time.

The Company may make discretionary matching and non-elective contributions to the Plan, as determined by the Company's Board of Directors. In 2024, the Company made matching contributions of \$68,214 equal to 25% of each participant's contribution up to 2% of participant eligible compensation.

The Company has not made any non-elective contributions to the Plan through December 31, 2024.

Contributions are subject to certain limitations under the Code.

#### *Participant Accounts:*

Participant accounts are credited with participant contributions, Company contributions, rollovers, and an allocation of the Plan's earnings or losses. Allocations are based on participant earnings or account balances, in accordance with Plan provisions. The benefit to which participants are entitled is the benefit that can be provided from the participant vested accounts.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

#### *Vesting:*

Participants are fully (100%) vested in their contributions, plus actual earnings (less any losses) thereon. The Company's discretionary matching contributions and Company non-elective contributions, if any, plus actual earnings (less any losses) vest 25% after one year of service, 50% after two years of service, 75% after three years of service, and 100% after four years of service.

#### 1. Description of the Plan (continued)

##### *Forfeitures:*

Forfeitures of non-vested Company contributions may be used to reduce future Company contributions or to pay Plan expenses. The Plan used \$8,445 of forfeitures to pay Company matching contributions and \$8,433 to pay administrative expenses in 2024. There were \$600 forfeitures available as of December 31, 2024 (\$555 as of December 31, 2023).

##### *Notes Receivable from Participants:*

Participants may borrow up to one-half of their account balance, a minimum of \$1,000 and not to exceed \$50,000, for a period not to exceed five years, except for notes used to purchase a primary residence for which terms of up to 30 years are permitted. Participant notes are evidenced by a written note, secured by the balance in the participant's account, and bear interest at the prime rate published in The Wall Street Journal, plus 1%. The interest rates on the notes outstanding as of December 31, 2024 ranged from 6.50% to 9.50%. Repayment of principal and interest is generally made through payroll deductions.

Note receivable transactions with participants qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

##### *Liability for Corrective Distributions:*

Liability for corrective distributions represents contributions made by certain participants that must be refunded in order for the Plan to be in compliance with applicable non-discrimination tests. The December 31, 2023 liability of \$36,445 was refunded in 2024. The December 31, 2024 liability of \$73,161 was refunded in 2025.

##### *Payment of Benefits:*

On termination of service, benefits are paid in a lump-sum cash distribution equal to the value of the participant's vested account balance, in partial withdrawals, or in regular installment payments of the participant's choice. Account balances below \$5,000 for participants no longer employed by the Company may be automatically distributed to individual retirement accounts on behalf of the participants, without participant approval. Benefits are recorded when paid.

##### *Administrative Expenses:*

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the Plan's financial statements. Participant accounts are assessed a separate fee for the administration of notes receivable and certain third-party administration fees.

Certain advisory service fees related to the Plan's investments paid by the Plan sponsor are assumed by the Plan and reflected in these financial statements. All other administrative expenses related to the Plan are paid by the Plan sponsor and not reflected in these financial statements.

##### *Risks and Uncertainties:*

The Plan offers a variety of investment options to participants. Investments are exposed to various risks, such as interest rate, market fluctuation, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible changes in risk in the near term could materially affect participant account balances and the amounts reported in the financial statements.

##### *Plan Termination:*

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions and to terminate the Plan at any time, subject to provisions of ERISA. In the event of a Plan termination, participants would become fully vested in their accounts and distributions would be made to participants as described in the Plan agreement.

#### 2. Summary of Significant Accounting Policies

##### *Basis of Accounting:*

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

##### *Use of Estimates:*

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### 2. Summary of Significant Accounting Policies (continued)

#### *Investments:*

Investments consist of mutual funds and a money market fund. These funds are valued at the net asset value of shares held by the Plan at year end, as quoted in active markets.

#### *Fair Value Measurement:*

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability as of the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

The three-level hierarchy for fair value measurement is defined as follows:

- Level I:** Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- Level II:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- Level III:** Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant at the fair value measurement.

The Plan's investments are recorded at fair value and classified as Level I within the fair value hierarchy as of December 31, 2024 and 2023.

#### *Income Recognition:*

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on the Plan's investments bought, sold or held during the year.

#### 3. Information Prepared and Certified by Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

#### 4. Income Tax Status

The Plan administrator has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Plan document has been amended and restated since receipt of the letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified, and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.
