## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

### 1. Description of the Plan

The Arkose Labs Inc. 401(k) Plan (the Plan) was established by Arkose Labs Inc. (the Company), effective August 1, 2023, to provide participants with a method to fund their retirement on a tax-deferred basis. The following description of the Plan, as amended and restated, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Prior to the Plan's inception, Company employees participated in a multi-employer plan sponsored by Sequoia One PEO, LLC. On August 25, 2023, assets totaling \$3,435,387 were transferred from the Sequoia One 401(k) Plan to the Plan.

#### *General:*

The Plan is a defined contribution plan under the provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. The Plan is administered by Company employees, who are responsible for selecting investment options offered under the Plan and monitoring investment performance. Reliance Trust Company (Reliance) serves as the Plan's trustee and ADP Retirement Services (ADP) serves as the Plan's record keeper. Reliance holds, invests, and reinvests Plan assets in the interest and direction of the participants and their beneficiaries.

#### *Eligible Participants:*

Company employees, as defined by the Plan agreement, are eligible to participate in the Plan immediately upon hire.

#### *Contributions:*

Participants are permitted to make voluntary pre-tax salary deferrals and Roth post-tax contributions up to 50% of their annual compensation, as defined in the Plan agreement. Participants who have reached the age of 50 may also elect to withhold additional "catch-up" contributions under the Code. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollovers), subject to Code regulations.

The Plan has an automatic enrollment feature under which all eligible employees hired or rehired are automatically enrolled in the Plan and have 4% of their pre-tax compensation deferred and contributed to the Plan, unless they request a different amount to be contributed or formally decline participation. Participants may adjust their salary deferral rate or discontinue their contributions at any time.

### 1. Description of the Plan (continued)

#### *Contributions:* (continued)

The Plan provides for discretionary employer matching contributions. Under the terms of the Plan agreement, the Company may elect, in its sole discretion, to make matching contributions to eligible participants' accounts. In 2024 and for the period from August 1, 2023 through December 31, 2023, the Company elected to make matching contributions equal to 25% of eligible participant deferrals, up to a maximum of \$2,000 per participant annually. The Company made discretionary matching contributions of \$121,859 to the Plan in 2024, of which \$1,100 was a receivable as of December 31, 2024. The Company made discretionary matching contributions of \$86,201 to the Plan during the period from August 1, 2023 through December 31, 2023, of which \$4,239 was a receivable as of December 31, 2023.

Contributions are subject to certain limitations under the Code.

#### *Participant Accounts:*

Each participant's account is credited with the participant's contributions, Company contributions, rollovers, and an allocation of Plan earnings or losses. Allocations are based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which participants are entitled is the benefit that can be provided from the participant accounts.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. A participant may authorize transfers among investment options at any time.

#### *Vesting:*

Participants are immediately vested (100%) in their contributions and Company contributions.

#### *Notes Receivable from Participants:*

Participants may borrow up to one-half of their account balance, for a minimum of \$1,000 and a maximum of \$50,000, for a period of one to five years, except for notes used to purchase a primary residence for which longer terms of up to 30 years may be granted. Participant notes are evidenced by a written note, secured by the balance in the participant account, and bear interest at 1% over the prime rate. Participants may have only one note outstanding. The interest rates on the notes outstanding as of December 31, 2024 ranged from 8.75% to 9.50%. Repayment of principal and interest is generally made through payroll deductions.

### 1. Description of the Plan (continued)

#### *Notes Receivable from Participants: (continued)*

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

Notes receivable transactions with participants qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules under ERISA.

#### *Payment of Benefits:*

Upon termination of service, participants may elect to leave their account balances in the Plan or receive their benefits in a lump sum amount equal to the value of their account balance, or partial withdrawals in amounts elected by the participants. The Plan may elect to distribute terminated participant account balances of less than \$1,000 in a lump-sum cash distribution without participant consent. Benefits are recorded when paid.

#### *Administrative Expenses:*

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the financial statements. Certain account maintenance and note fees are charged to the Plan and allocated to participant accounts. All other administrative expenses related to the Plan are paid by the Company and are not reflected in the Plan's financial statements.

#### *Risks and Uncertainties:*

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuation, and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risks in the near term could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

#### *Plan Termination:*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan at any time, subject to the provisions of ERISA. In the event of a Plan termination, participants would remain fully vested in their accounts and distributions will be made to participants as described in the Plan agreement.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting:*

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### *Use of Estimates:*

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### *Investments Valuation:*

Investments consist of mutual funds and a common/collective trust. These investments are accounted for as follows:

*Mutual Funds:* These funds are valued at the net asset value (NAV) of shares held by the Plan at year end, as quoted in active markets.

*Common/Collective Trust (CCT):* The Invesco Stable Asset Fund - ADPZ Class is a CCT and stable value fund that is composed primarily of fully benefit-responsive investment contracts. Units held in the CCT are valued using the NAV practical expedient of the CCT, as valued by Invesco Trust Company (Invesco), the issuer. The NAV practical expedient is based on the fair value of the underlying assets owned by the CCT, minus its liabilities, and then divided by the number of units outstanding. The NAV of a CCT is calculated based on the compilation of primarily observable market information. The Plan has no unfunded commitments with the CCT and investments are redeemable daily.

The NAV practical expedient would not be used if it is determined to be probable the Plan will sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the trust, Invesco reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidated will be carried out in an orderly business manner.

### 2. Summary of Significant Accounting Policies (continued)

#### *Fair Value Measurement:*

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability as of the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with investing in those financial instruments.

The three-level hierarchy for fair value measurement is defined as follows:

**Level I:** Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.

**Level II:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

**Level III:** Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

The Plan's mutual funds are recorded at fair value and are classified within Level I of the fair value hierarchy as of December 31, 2024 and 2023. The CCT, valued based on the NAV practical expedient, is excluded from the fair value hierarchy under GAAP.

#### *Income Recognition:*

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on the Plan's investments bought, sold, or held during the year.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is subject to income tax examinations since Plan inception.
