## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Arxada 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024, and 2023, and the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### NOTES TO FINANCIAL STATEMENTS

#### Note 1 - Description of Plan:

The following description of The Arxada 401(k) Plan (the “Plan”) provides only general information and is presented to assist in understanding the Plan’s financial statements. The financial statements and notes are representations of the Plan’s management, which is responsible for their integrity and objectivity. Participants should refer to the Plan document for a more complete description regarding the Plan’s provisions.

**General** - Lonza Specialty Ingredients (“LSI”) was spun off from Lonza, LLC effective July 1, 2021 (“date of inception”). Concurrent with the spinoff, LSI established a defined contribution plan, The LSI US Savings Plan (“LSI Plan”). All active employees and participating employers of LSI transferred their account balances from their previous employer’s plan into the LSI Plan. Included with the active employees were certain employees covered by collective bargaining agreements. Effective October 21, 2021, LSI changed its name to Arxada, LLC (the “Company” or “Plan Sponsor”) and LSI Plan’s name to The Arxada 401(k) Plan. The Plan provides for immediate participation upon hire or rehire for all eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective January 1, 2024, the Troy Corporation Profit Sharing and Savings Plan and Enviro Tech Chemical Services, Inc. 401(k) Plan, executed the approval of consolidating retirement benefits under a single plan structure sponsored by Arxada, LLC. As such, effective January 1, 2024, the Troy Corporation Profit Sharing and Savings Plan and Enviro Tech Chemical Services, Inc. 401(k) Plan merged into the Plan. The Troy Corporation Profit Sharing and Savings Plan and Enviro Tech Chemical Services, Inc. 401(k) Plan had net assets totaling \$33,857,249 transferred, which included \$671,443 of outstanding loans.

**Plan Administration** - The Plan is administered by the Plan Sponsor. The Plan’s assets are held by Reliance Trust Company (the “Trustee”), who is responsible for the custody and management of the Plan’s assets.

**Automatic Enrollment** - An eligible employee shall automatically be enrolled in the Plan forty-five days after they met the eligibility requirements at a default pre-tax contribution percentage of 6% unless the employee affirmatively elects a contribution percentage of his own choice from 0% to 50% of eligible earnings. Each April thereafter, the automatic enrollment contribution percentage shall automatically escalate in 2% increments up to a maximum of 12%. If, at any point after a participant is automatically enrolled, such participant makes a contribution election of his own choosing, such participant shall be removed from the automatic escalation program and the automatic increases will cease.

**Contributions** - All participant contributions to the Plan are voluntary. Participants are limited to a maximum contribution percentage of 50% of eligible compensation. Non-highly compensated employees may contribute up to 50% of their annual compensation on a pretax, Roth 401(k), or traditional after-tax basis, or a combination of such contributions not to exceed 50% of eligible earnings in total. Highly compensated employees may contribute up to 50% of their annual compensation on a pretax or Roth 401(k) basis, up to 6% of their annual compensation on an after-tax basis, or any combination of such contributions not to exceed 50% of eligible earnings in total.

The Company makes “safe harbor” matching contributions each payroll period for all eligible participants in an amount equal to 100% of the participant’s contributions which do not exceed 6% of their eligible compensation.

### NOTES TO FINANCIAL STATEMENTS

The Plan provides for an additional profit-sharing contribution for each eligible employee. The Company profit-sharing contribution is contingent upon the employee remaining an active employee on the last day of the Plan Year or having terminated employment by reason of death, disability, retirement or after the age of 55 and completion of at least 10 years of credited service during the Plan Year. The Company profit-sharing contribution is not contingent upon the employee contributing to the Plan. The profit-sharing contribution is 1.5% of eligible earnings for all participants except those covered by the separate collective bargaining agreement of the United Steelworkers of America, Local No. 4907 who remain at 1% of eligible earnings contributed each pay period.

The employer matching contributions are recalculated as soon as practicable following the end of each Plan Year and each participant receives a “true-up” employer matching contribution. This “true-up” contribution is equal to the difference between the employer matching contributions actually received by the participant during the applicable Plan Year and the maximum amount of employer contribution the participant is eligible to receive. The maximum amount of match (whether regular match or true-up match) is equal to 100% of up to 6% of eligible compensation contributed during any Plan Year subject to limits.

With respect to participant contributions and Company contributions made on their behalf, individual participants may elect to invest such contributions entirely in any of the Plan’s available investment funds or partially in more than one investment fund. Participants may change their investment elections for future contributions and reallocate past contributions on any business day.

**Investments** - Investment allocations are participant-directed and consist of separate investment funds. The Plan also utilizes the age appropriate Target Date Fund as a default investment account for funds prior to allocation of participant investments and for any Plan forfeitures. A participant may direct employee contributions in 1% increments in any of the investment funds provided by the Plan.

**Participants’ Accounts** - Individual accounts are established for each plan participant. Each participant’s account is credited/charged with the participant’s contribution and allocations of (a) the Company’s contribution, (b) Plan earnings/losses, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting** - All active eligible employees are always immediately 100% vested in all their contributions as well as any Company “safe harbor” and matching “true-up” contributions plus actual earnings thereon. All employees will vest 100% in the Company’s profit-sharing contributions, plus actual earnings thereon, upon attaining three years of service. If a participant dies, becomes disabled (as defined under the terms of the Plan), or terminates employment on or after attaining age 65 then they will be fully vested in the profit-sharing contributions regardless of service time.

**Payment of Benefits** - Upon termination of employment with the Company, or upon death, disability, or retirement a participant, or their designated beneficiary, may request a full distribution of their vested account balance. While actively employed by the Company, a participant may request up to two in-service withdrawals in any calendar year. Such withdrawals may be any combination of hardship or regular in-service withdrawals, to the extent amounts are available for a particular withdrawal type when requested. In the event a participant requests a hardship withdrawal, the withdrawal must meet the criteria for financial hardship and the hardship must be due to one of the permissible reasons set forth under the Plan.

### NOTES TO FINANCIAL STATEMENTS

**Forfeitures** - Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. These accounts are to be used to reduce future employer contributions to the maximum extent permitted by ERISA, and expenses incurred in connection with the administration and management of the Plan and trust fund. At December 31, 2024 and 2023, forfeited nonvested accounts and other income accounts totaled \$53 and \$20,157. Forfeitures used to reduce matching contributions totaled \$442,905 for the year ended December 31, 2024.

**Subsequent Events** - The Plan Administrator has reviewed and evaluated all events and transactions from December 31, 2024 through October 7, 2025 the date the financial statements were available to be issued. The effect of those events and transactions that provide additional pertinent information about conditions that existed at the Statements of Net Assets Available for Benefits date have been recognized in the accompanying financial statements.

Effective January 1, 2025, the Plan transitioned its trustee services from Reliance Trust Company to ADP Retirement Trust Services, LLC, which now serves as the Plan's trustee.

#### **Note 2 - Summary of Significant Accounting Policies:**

**Basis of Accounting** - The financial statements have been prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions in net assets available for benefits during the reporting period. Actual results, as determined at a later date, could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by its investments advisors, Trustee, and insurance company. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits** - Benefits are recorded when paid.

### NOTES TO FINANCIAL STATEMENTS

**Hardship Withdrawals** - The Plan provides for hardship withdrawals from participants' vested balances, not to exceed an amount required to meet an immediate need created by hardship, and then only to the extent that such immediate need cannot be satisfied by other sources reasonably available to the participant. Permissible circumstances for hardship withdrawals include medical expenses, purchase of a home, tuition payments, amounts necessary to prevent eviction from the participants' personal residence, and such other circumstances as the Plan Administrator may determine in accordance with Internal Revenue Service ("IRS") rules and regulations.

**Administrative Expenses** - Eligible expenses (as defined), to the extent not paid by the Plan Sponsor, are paid by the Plan. Participant accounts are charged with quarterly administrative expenses. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, withdrawals, recordkeeping fees, and asset fees are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation of fair value of investments.

#### **Note 3 - Information Certified by the Trustee:**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, the Trustee, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- a) Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule of assets (held at end of year).

#### **Note 4 - Fair Value Measurements:**

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified contractual term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued at the closing price in the active market in which the fund is traded.
- *Common Collective Trusts*: Investments in regulated investment companies or other trust pooled funds are valued at the net asset per share/unit on the valuation date. The net asset value is used as a practical expedient to estimate fair value. The underlying assets of the trust are normally valued based on their closing sales price or, in the absence of sales, at their reported bid price (See Note 5).

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Transfers Between Levels**

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the years ended December 31, 2024, and 2023, there were no significant transfers in or out of levels 1, 2, or 3.

#### **Note 5 - Common Collective Trust:**

The Plan invests primarily in mutual funds through its common collective trust (“CCT”). The CCT’s fair value is a relevant measurement attribute. The CCT held by the Plan is a stable value investment which has an objective to preserve capital and to provide a competitive level of income over time that is consistent with the preservation of capital. To achieve this objective, the fund invests primarily in mutual funds and cash equivalents. Redemptions are allowed for participants daily, however, in the event of a complete redemption, the Plan is subject to a temporary delay in withdrawing funds to ensure securities liquidations are carried out in an orderly fashion. There are no unfunded commitments at December 31, 2024 and 2023.

#### **Note 6 - Risks and Uncertainties of Investment Risk:**

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant’s account balances and the amounts reported in the financial statements.

The Plan may have investments in securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage-backed securities, including securities backed by sub-prime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market’s perception of the issuers and changes in interest rates.

The Plan’s investment in one fund comprised approximately 17% and 15% of total investments at December 31, 2024 and 2023, respectively.

#### **Note 7 - Tax Status:**

The Plan has been designed to qualify under Section 401(a) of the Internal Revenue Code (“IRC”). The terms of the Plan have been prepared to conform with the sample language by the IRS. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for the plan participants under Section 401(a). The Plan Administrator believes the Plan was designed and was being operated in compliance with the applicable requirements of the IRC, therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

#### **Note 8 - Party-in-Interest:**

Certain Plan investments are managed by the Trustee. Services provided by the Trustee include investment management, recordkeeping, and administrative services to the Plan. The fees associated with these services qualify as party-in-interest. Fees paid for such services totaled \$103,116 for the year ended December 31, 2024.

#### **Note 9 - Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan’s provisions to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. Upon termination, participants will become fully vested in their accounts. Under no circumstances may the Company take ownership of any of the Plan’s assets as a result of such termination.

#### **Note 10 - Notes Receivable from Participants:**

The amount available for loan withdrawals is 50% of the vested balance less the participant’s highest outstanding loan balance during the 12 months prior to the effective date of the new loan. The minimum loan granted is \$1,000 and the maximum is \$50,000. The interest rate for loans granted is the prime rate of interest published in the Wall Street Journal at the time the loan is issued. The rate in effect at the beginning of the loan remains constant over the life of the loan. The Plan allows a maximum of only two loans outstanding at any one time.

Participants may request a loan repayment term of up to five years for a general loan, and up to fifteen years for a loan used to purchase the participant’s primary residence. Full prepayment of the outstanding balance is permitted. Loans are generally repaid through payroll deduction with principal and interest being credited to the participant’s account and invested in the investment funds elected by the participant at the time of the repayment. Plan participants are required to pay a loan initiation fee which is deducted directly from their account at the onset of the loan.
