## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Surgery Center JV, 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Surgery Center, JV 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

### Basis for Opinion

### **NOTE 1 - PLAN DESCRIPTION**

#### **Nature of the Plan**

The following description of Surgery Center, JV (Sponsor) 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement or Summary Plan Description for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a contributory, defined contribution 401(k) plan available to substantially all salaried and hourly employees of the Sponsor. To be eligible to participate in the Plan and for the purposes of the employer-matching contribution, the employee must be 21 years of age or older and must have 6 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Subject to certain limitations under Internal Revenue Code (IRC) Section 401(k), participants may contribute up to 90% of their annual compensation, with the contributions and earnings thereon being nontaxable until withdrawn from the Plan. Employees are automatically enrolled in the Plan at a 3% deferral rate, unless they elect to opt out in a timely manner. Upon reaching age fifty, participants are allowed to make catch-up contributions to the Plan. The Plan Sponsor makes safe harbor matching contributions equal to 100% of employee salary deferrals that do not exceed 1% of Plan compensation plus 50% of employee elective deferrals between 1% and 6% of Plan compensation. The Plan Sponsor may also decide to make a non-elective discretionary contribution. Participants may contribute amounts representing distributions from other qualified plans. Such transfers from other qualified plans are reported as rollover contributions.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s and the Sponsor’s contributions and an allocation of net Plan earnings. Participants may direct the investment of their account balances into various investment options offered by the Plan. The benefit to which a participant is entitled is based on the participant’s vested balance.

#### **Vesting**

Participants are immediately vested in their elective deferrals, employer matching contributions, and employer non-elective contributions. Employees are fully vested after two years of service in qualified automatic contribution arrangement (QACA) safe harbor contributions.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest from 4.25% to 9.50%. The interest rate on participant loans is determined by the plan administrator in accordance with Plan provisions.

**Payment of Benefits**

Upon termination of service, due to death, disability, retirement or separation of service, a participant may elect to receive either a lump-sum distribution or installment payments under various options. The Plan also permits withdrawals from the Plan due to circumstances of financial hardship, in accordance with provisions specified in the Plan document.

**Forfeitures**

Forfeitures are retained in the Plan and may first be used to pay administrative expenses or to reduce future employer contributions. Forfeitures totaling \$0 were used to reduce employer contributions during the year ended December 31, 2024. Forfeitures available for use at December 31, 2024 and 2023 totaled \$10,658 and \$7,762, respectively.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Investment-related expenses are included in net appreciation or depreciation of fair value of investments. Administrative expenses of the Plan can be reduced by forfeitures. Administrative expenses recorded in the Plan represent processing fees, distribution fees, participant loan origination fees and annual maintenance fees paid directly from the Plan to the Plan's trustee and other third parties. Loan and distribution fees are deducted directly from the participants' accounts.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America. In preparing the financial statements, management evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

As required by accounting principles generally accepted in the United States of America, investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan's investment options include the Lincoln National Life Insurance Company Stable Value Fund, which is a benefit-responsive investment contract held in a fixed account. The statements of net assets available for benefits is prepared on a contract value basis for the Lincoln National Life Insurance Company Stable Value Fund.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Income Recognition**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Realized gains and losses from security transactions are reported on the average cost method.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit loss has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

#### **Concentration of Market Risk**

As of December 31, 2024, approximately 32% of the Plan's net assets were invested in two mutual funds and one stable fund. As of December 31, 2023, approximately 34% of the Plan's net assets were invested in two mutual funds and one stable fund. The underlying value of the investments are dependent on the performance of the individual investment holding and the market's evaluation of such performance. It is at least reasonably possible that changes in the fair value of the registered investments and their investment holdings in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

#### **Fair Value**

The established framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value is the price the Plan would expect to receive to sell an asset or pay to transfer a liability in an orderly transaction with a market participant at the measurement date. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs which are derived principally from or corroborated by observable market data by correlation or other means.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

**Payment of Benefits**

Benefits are recorded when paid.

**Refund of Excess Contributions**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction in contributions.

**NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee, Reliance Trust Company, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

**NOTE 4 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 5 - FAIR VALUES**

The following is a description of the valuation methodology used for assets measured at fair value. There was no change in the methodology used at December 31, 2024 or 2023.

- *Mutual funds*: Valued at the closing price reported on the active market on which the individual securities were traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan holds an investment contract that comprises a traditional investment contract with Lincoln National Life Insurance Company (Lincoln). This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of the traditional investment contract as of December 31, 2024 and 2023 totaled \$664,028 and \$691,089, respectively.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include retirement, death, disability, Plan termination, and bankruptcy. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers or that would also limit the ability of the Plan to transact at contract value with the participants.

**NOTE 8 - PLAN TERMINATION**

Although it has not expressed intent to do so, the Sponsor has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants' accounts would become 100% vested in their employer contributions.

**NOTE 9 - INCOME TAX STATUS**

The IRS has determined and informed the Plan Sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the advisory opinion, the plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Tax positions are recognized in the financial statements when it is more likely than not that the position will be sustained upon examination by the tax authorities. The Sponsor has concluded that as of December 31, 2024 and 2023, the Plan had no significant uncertain tax positions or material amounts of unrecognized tax benefits that qualify for either recognition or disclosure in the financial statements for open tax years based on an assessment of many factors including experience and interpretations of tax laws.

**NOTE 10 - RELATED PARTY TRANSACTIONS**

Certain Plan assets are shares of mutual funds managed by Reliance Trust Company, the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions as defined under ERISA regulations. The transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of ERISA regulations.
