### ***Basis for Opinion on the 2024 Financial Statements***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated October 14, 2024, indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, was presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

**Note 1 – Description of the Plan**

The following description of the Cambridge International Systems, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document, as amended, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, which was established by Cambridge International Systems, Inc. (the "Company") effective January 1, 2003, and covering all eligible employees of Cambridge Communications Systems of Puerto Rico, Inc., Cambridge International Systems, Inc., Cambridge International Holding Company, Inc., and Cambridge International Services, Inc.

Effective May 1, 2024, Cambridge International Services, Inc.'s participant accounts were spun off into a newly established Plan. See Note 4.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was most recently amended effective July 1, 2022, to provide an employer match for Service Contract Act employees. The Cambridge Investment Committee is responsible for oversight of the Plan. The fiduciary advisors determine the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Cambridge Investment Committee.

Plan Administrator, Recordkeeper, and Trustee

The Plan's administrator, recordkeeper, and trustee are as follows:

Plan Administrator – Cambridge International Systems, Inc.

Third Party Administrator and Recordkeeper – Automatic Data Processing, Inc. (ADP)

Custodian and Trustee – Reliance Trust Company

Investment Advisor – The Capital Group Investment Advisory Services, LLC. (The Capital Group)

Eligibility

An eligible participant is an employee that is employed by Cambridge International Systems, Inc. or any affiliate who has adopted the Plan. There are service requirements for employer match that differ from participant elective deferrals. Employees are eligible to enter the Plan on their date of hire.

Union employees whose employment is governed by a collective bargaining agreement under which retirement benefits are the subject of good faith bargaining are allowed to make participant contributions but are not entitled to Company safe harbor matching contributions or any discretionary matching or profit-sharing contributions.

Participant Contributions

Each year, participants may contribute pre-tax annual compensation and Roth deferrals, up to 99% of their compensation, as defined by the Plan, not to exceed the maximum allowable contributions under the Internal Revenue Code (the "IRC"). Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions, subject to limitations imposed by the IRC. Participants are permitted to make rollover contributions to the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer Contributions

The Company makes safe harbor matching contributions equal to 100% of salary deferrals not to exceed 3% of compensation plus 50% of salary deferrals over 3% and up to 5% of eligible compensation. The Company may make additional matching and profit-sharing contributions at the discretion of the Company's management, as determined on an annual basis. Safe harbor matching contributions are calculated on a per payroll period basis.

Safe harbor matching contributions totaled \$607,606 for the year ended December 31, 2024. The Company did not make any discretionary matching or profit-sharing contributions during the year ended December 31, 2024.

The Company is required to provide minimum health and welfare benefits at a set hourly rate based on hours worked or hours paid, as defined by individual contracts covered under the McNamara-O'Hara Service Contract Act. These prevailing wage contributions, determined under prevailing wage laws, are contributed by the Company in the form of discretionary qualified non-elective contributions. Participants direct the investment of Company contributions. Contributions are subject to certain Internal Revenue Service ("IRS") limitations. The Company did not make any qualified non-elective contributions to the Plan during the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company safe harbor and discretionary matching and qualified non-elective contributions, as well as allocations of the Company's discretionary profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, rollover contributions, qualified non-elective contributions, and safe harbor matching contributions, plus actual earnings thereon. Participants vest in discretionary non-safe harbor matching contributions and profit sharing as follows:

A participant is 100% vested in discretionary non-safe harbor matching and profit-sharing contributions when the participant reaches the normal retirement age while an employee, upon death while an employee, becoming disabled while an employee, and attainment of early retirement age (attaining 55 years of age and five years of vested service) while an employee.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of vested account balance. Only one loan may be outstanding at a given time. The loans are secured by the balance in the participant's account. The loan interest rate is set at 2% above the prime rate, as defined. Principal and interest are paid ratably through regular payroll deductions.

Forfeited Accounts

At December 31, 2024, and 2023, forfeited nonvested accounts totaled \$30, and \$32, respectively. These accounts will be used to pay administrative expenses or reduce future employer contributions. Also, in 2024, employer contributions were reduced by \$3 from forfeited nonvested accounts.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Plan Amendments

There were no amendments to the Plan during the year ended December 31, 2024.

**Note 2 - Summary of Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan Sponsor has evaluated subsequent events and transactions for potential recognition or disclosure through October 13, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note 4 - Related Party Transactions and Party-In-Interest Transactions**

Administrative fees paid directly from Plan assets to ADP, the Recordkeeper, and to The Capital Group, the Investment Advisor, totaled \$29,248, and \$25,017, respectively, for the year ended December 31, 2024.

The Company pays directly any other fees related to the Plan's operations. The Plan also allows participants to take loans against their account balances, which are also considered party-in-interest transactions.

**Note 5 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 6 - Tax Status**

The IRS has determined and informed the Company by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**Note 8 - Certified Investments**

The following information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, LLC, the Trustee of the Plan, a qualified institution.

**Note 9 - Spin-Off of Affiliate**

Employees of Cambridge International Services Inc. were previously covered by the Cambridge International Systems, Inc. 401(k) Plan. Effective May 1, 2024, a separate defined contribution plan was established for the employees of Cambridge International Services Inc. Investment balances totaling \$2,072,810 allocated to employees of Cambridge International Services Inc. were transferred to the Cambridge International Services, Inc. 401(k) Plan.

**Note 10 – Non-Exempt Transactions**

As reported on Form 5500, Schedule H, Line 4(a) – Schedule of Delinquent Participant contributions, certain participant contributions were not remitted to the Plan within the time frame specified by the Department of Labor’s Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Company during the 2024 plan year. Late remittances amounted to \$1,654. The Company transmitted lost earnings to the plan of \$3.88. These contributions are considered nonexempt party-in-interest transactions, which may result in an imposition of a 15 percent excise tax on the amount of the transactions.

**Note 11 – Subsequent Events**

Effective January 1, 2025, ADP Retirement Trust Services, LLC became the Plan’s new Trustee.
