NOTE 1 – PLAN DESCRIPTION

The following description of the Weleski Transfer, Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan covering substantially all employees of Weleski Transfer, Inc. and related companies, Sub Management, Inc., Weleski Self Storage, Inc., Weleski Transfer, Inc. of Cleveland and Walmart, Inc. (Company) who have completed six months of service, except any employee who is employed as a clerk or laborer, because these are ineligible classes of employees according to the Plan document. Weleski Transfer, Inc. of Johnstown was closed on December 31, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan agreement utilized a nonstandardized prototype sponsored by Automatic Data Processing (ADP). ADP is the recordkeeper and trustee of the Plan. The administrator of the Plan is the Company. Weleski Transfer Inc. is the Plan sponsor.

Effective November 1, 2023, a new custodian and recordkeeper was appointed. The conversion initiated a blackout period from October 31, 2023, and continued through November 11, 2023. During this time period, funds could not be applied to the employees' selected funds with the custodian or withdrawn from the Plan until the custodian could accurately complete the conversion. During this period, employee contributions continued to be made through payroll deductions, these contributions were deposited immediately upon closeout of the blackout period. The investment lineup did not change; therefore, funds were transferred into the same fund with the new custodian once the blackout period ended.

Contributions

Plan participants may contribute up to 90% of their annual compensation on a pretax and/or after-tax basis, as defined in the Plan document, subject to certain limitations under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, subject to limitations under the IRC. The Plan has an automatic enrollment feature whereby employees who met the eligibility requirements will be automatically enrolled unless the employee affirmatively elects otherwise. Employees who are automatically enrolled will have 2% of their eligible compensation withheld as a pretax salary deferral and their contributions invested in a designated fund until changed by the participant. Participants may also contribute rollover distributions from other qualified defined benefit or contribution plans.

For the years ended December 31, 2024 and 2023, the Company made discretionary matching contributions equal to \$0.20 on the \$1.00 on the first 5% of compensation that a participant contributed to the Plan. The Company may also elect to contribute discretionary nonelective employer contributions (profit sharing) each Plan year. No such profit sharing contributions were awarded for the years ended December 31, 2024 and 2023.

Participants direct the investment of their contributions, including Company contributions, into various investment options offered by the Plan. Participants may change their investment election for future contributions, or the percentage(s) invested in each of these options or transfer funds among these options on any business day. All investments are participant-directed.

Participant Accounts

Individual accounts are maintained for each Plan participant to reflect the participant's contributions, the Company's related discretionary matching and profit sharing contributions and the net investment income (loss) attributable to the participant's account. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000, or 50% of their vested account balance, whichever is less. Loan terms generally range from one to five years but can be up to thirty years for the purchase of a principal residence. A participant may not have more than one outstanding loan at a time. Loans are secured by the balance in the participant's account and bear interest at 1% plus the prime rate published in the Wall Street Journal on the first business day of the month before the loan originated. Principal and interest are paid ratably through payroll deductions. Upon termination of employment, loans will immediately become payable. If a loan is not repaid within a reasonable time following termination of employment, the loan will be recorded as a distribution against the participant's vested account balance.

Vesting

Participants are vested immediately in their elective deferral contributions, including rollovers and catch-up contributions, and actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contribution portions of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service. Additionally, participants will become 100% vested regardless of years of completed service, in the year of their death, disability and or retirement, provided they are still employed at that time. The vesting schedule is as follows:

Forfeitures

Participant account balances which are not 100% vested upon termination of services are forfeited. Forfeitures can be used to pay for Plan administrative expenses or to reduce the Company's contributions due. As of December 31, 2024 and 2023 the forfeiture account balance was \$31 and \$3,320, respectively. During the years ended December 31, 2024 and 2023, \$7,796 and \$2,590 respectively were used to reduce Company matching contributions.

Benefits

Benefits may be distributed to participants, spouses or designated beneficiaries, as appropriate, upon normal retirement (age 65), early retirement (age 62 with one year of vested service), death, disability or termination of employment. Prior to termination of service, participants who have attained the age of 59½ may make in-service withdrawals from all vested accounts. Payments are in the form of a lump-sum payout or in partial withdrawals of the participant's account balance or over a period determined by the Plan administrator. The Plan provides for required minimum distributions commencing at age 72 for certain participants. The required minimum distribution age was increased to age 73 effective January 1, 2023 in accordance with the Setting Every Community Up for Retirement Enhancement Act 2.0. The Plan provides participants may make emergency withdrawals from the Plan to meet certain hardships. The permitted hardships are defined by the Internal Revenue Service (IRS) and the requirements are strict.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and reported changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Contributions Receivables and Allowance for Credit Losses

Contributions receivables consist of amounts due from participants and/or the Plan sponsor at year end and are stated at the amount the Plan expects to collect. Management has considered past transaction history and current economic trends when determining the collectability of contributions receivables. As of December 31, 2024 and 2023, the Plan did not record an allowance for credit losses.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as distributions based upon terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid by the Plan.

Investment Valuation and Income Recognition

Investments in all funds are presented at fair value (except fully benefit-responsive investment contracts, which are reported at contract value), based on quoted market prices of the underlying securities within each fund at December 31, 2024 and 2023. Shares of mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. Participant loans are valued at amortized cost which represents fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Lincoln Fixed Account is a guaranteed annuity contract, which has been determined to be fully benefit-responsive and as such, is reported at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

GAAP establishes a framework for measuring fair value that requires or permits fair value measurement and enhances disclosures about fair value measurements. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy, which requires an entity to maximize the use of observable inputs when measuring fair value. The required disclosures concerning inputs used to measure fair value are included in Note 9.

Plan Administration Costs

Certain costs of administering the Plan are paid either by the Plan or the Company, as defined by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits. Participant accounts are also charged with an allocation of administrative expenses. Allocations are based on specific participant-initiated transactions, as defined by the Plan document. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Reclassification

Certain prior year amounts have been reclassified for consistency with the current year presentation. These reclassifications had no effect on net assets available for benefits.

Subsequent Events

The Plan evaluated subsequent events through the date of this report, which is the date the financial statements were available to be issued. The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

The Plan administrator has elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, all asset information disclosed in the accompanying financial statements and supplemental schedules, including investments held and notes receivable from participants at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividend income and interest on notes receivable from participants for the years then ended, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the trustees.

NOTE 4 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities that are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 5 – INCOME TAX STATUS

The underlying nonstandardized prototype Plan has received an opinion letter dated October 6, 2020, from the IRS that stated that the Plan and related Trust are designed in accordance with applicable sections of the IRC. Subsequent to the receipt of the determination letter from the IRS, the Plan has been amended. The Plan is required to operate in conformity with the IRC to maintain its qualification. We are aware of certain operational issues that, if not properly corrected, could be treated by the IRS as a qualification failure. We will be taking steps to correct these issues. If necessary, the tax qualification issues will be resolved directly with the IRS. Accordingly, we believe that the Plan and Trust will retain its tax-qualified status.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position, that more likely than not, would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits of any tax periods in progress. The Plan administrator believes it is no longer subject to tax examinations for the years prior to 2021.

NOTE 6 – LIFE INSURANCE POLICY

Through December 31, 2003, the Plan offered participants the option to purchase whole life, flexible premium insurance policies through the Plan. Premiums paid for the respective policy were allocated to the respective participant's accounts. As of January 1, 2004, this option was no longer offered. At that time, participants were given the option to keep their investment in these insurance policies, rollover their balances into one or more of the investment options available; rollover their balances into an individual investment account outside the Plan, or to cash out their policies. As of December 31, 2024, one participant has an insurance policy in the Plan.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Fees paid in the ordinary course of business during 2024 and 2023 for professional, administrative and custodial services were paid by the Plan based on customary and reasonable rates for services. While these transactions qualify as party-in-interest activity, they are expressly exempt from the prohibited transaction rules. ADP and Fidelity were the Plan's trustees and recordkeepers. During the years ended December 31, 2024 and 2023, the Plan's investments included shares of portfolios managed by Fidelity and therefore these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Administrative expenses noted in the statements of changes in net assets available for benefits were paid by Plan participants.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their investments including employer discretionary accounts.

NOTE 9 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Statement ASC 820, Fair Value Measurements (FASB ASC 820), establishes a framework for measuring fair value and requires certain disclosures about the fair value measurement (see Note 2). The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds* - Valued at the NAV of shares held by the Plan at year end. The NAV is based upon quoted market prices.
- *Wilcac life insurance contract* - Valued at fair value by calculating the net cash value. This asset has been classified within Level 3 of the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 10 – GUARANTEED ANNUITY CONTRACT WITH INSURANCE COMPANY

In 2017, the Plan entered into fully benefit-responsive guaranteed annuity contract with Lincoln National Life Insurance Company (Lincoln), noted as the Lincoln Fixed Account (Contract). Contributions to the Lincoln Fixed Account under this Contract are maintained in the general account of Lincoln that is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The contract does not have a maturity date.

The Plan's ability to receive amounts due in accordance with the Contract is dependent on Lincoln's ability to meet its financial obligations. Lincoln's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Because the guaranteed annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed annuity contract. The guaranteed annuity Contract is presented at contract value on the face of the statements of net assets available for benefits. Contract value, as reported to the Plan by Lincoln was \$832,910 and \$813,178 at December 31, 2024 and 2023, respectively, and represents contributions made under the Contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Interest rates are reviewed on a quarterly basis for resetting. For the years ended December 31, 2024 and 2023, the actual average yield earned by the Plan was 2.24% and 2.32%, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Examples of such events include changes to the Plan's prohibition on competing investment options, premature termination of the Contract by the Plan, plant closings, layoffs, Plan termination, bankruptcy, mergers, and early retirement incentives.

The Plan administrator believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer, and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the Contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the Contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 11 – PROHIBITED TRANSACTIONS

During the years ended December 31, 2023, 2022, 2021 and 2020, there were unintentional delays by the Plan Sponsor in remitting employee contributions to the Plan. Total employee contributions not remitted timely to the Plan for the years ended December 31, 2023, 2022, 2021 and 2020 amounted to \$338, \$537, \$1,226, and \$1,947, respectively. The Plan Sponsor has chosen to self-correct under the Employee Plan Compliance Resolution System (EPCRS) Self-Correct Program (SCP). All lost earnings were remitted by September 30, 2024.

NOTE 12 – PLAN AMENDMENTS

The Plan was amended and restated on November 1, 2023 to comply with IRS regulations. The Setting Every Community Up for Retirement Enhancement Act 2.0 (SECURE Act 2.0) of 2022 was signed into law on December 29, 2022. The SECURE Act 2.0 is a retirement plan bill that aims to increase access to retirement plans and encourage Americans to save for their future. It builds on the changes made by the SECURE Act of 2019, which was signed into law in December 2019. Some of the SECURE Act 2.0 changes affecting the Weleski Transfer, Inc. 401(k) Plan include, increasing the required minimum distribution age (RMD), additionally, Roth accounts in employer retirement plans are exempt from the RMD requirements as of 2024, and increasing the dollar limit for mandatory distributions of former participants from \$5,000 to \$7,000 and expanded eligibility to long-term part-time employees (LTPT). The long-term part-time employee rules noted in the SECURE Act and SECURE Act 2.0 do not apply to the Plan as the Plan document does not exclude part-time employees. The SECURE ACT 2.0 also allows participants to take one self-certified, penalty-free withdrawal of up to \$1,000 per calendar year for unforeseeable or immediate financial needs relating to personal or family emergency expenses. Only one withdrawal per 3-year repayment period is permitted if the first withdrawal has not been repaid. Written amendments to the Plan document to reflect these operational changes will be adopted at a later date in accordance with law and IRS guidance.
