## **Independent Auditors' Report**

To the Trustees  
Downey Oil / Kenjo 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed an audit of the financial statements of Downey Oil / Kenjo 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **Note 1 - Description of Plan**

The following description of the Downey Oil / Kenjo 401(k) Plan provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions. Copies of this document are available from the Company.

**General** - The DOWNEY OIL / KENJO 401(k) Plan (the Plan) is a defined contribution plan and is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers a controlled group that includes the employees of Downey Oil Company, Inc., Kenjo, Inc., Fasco Foods, LLC, Harco Foods, LLC and Petro Services, Inc. (collectively the "Company"). All employees of the company that are age 21 or older, have completed one year of qualifying service, and have completed more than 1,000 hours during the year, are eligible to participate in the plan.

**Plan Contributions** – Employee contributions to the Plan are made through payroll deductions. The employee contributions are remitted to the custodian/trustee after each payroll. Participants may elect to defer a maximum of 100% of compensation to the Plan, subject to IRS limitations. Participants may direct participant contributions to any of various investment options with the primary custodian/trustee. Participants have the opportunity to change the investment options previously elected at any time.

The Company makes a discretionary matching contribution of up to 6% of allowable compensation. Further, the Company can make a discretionary profit-sharing contribution. The Company did not elect to make a profit-sharing contribution in 2024 or 2023. Receivables from the Company for these contributions are unsecured.

The Plan accepts rollover contributions from other tax-qualified plans.

**Participant Accounts** – Each participant's account is credited with the participant's contributions, the employer's matching and profit-sharing contribution and Plan earnings or losses and is charged with an allocation of administrative expenses. Employer discretionary profit-sharing contributions are allocated based on compensation. Plan earnings or losses are allocated based on each participant's account balance within each elected investment option. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their contributions and become fully vested in the Company's discretionary contributions and earnings thereon after six years of service as follows.

A year of service is defined as a Plan year during which a participant has 1,000 or more hours of service. Notwithstanding the above, a participant is fully vested in his entire account upon the attainment of age 65 or at age 55 provided he has completed at least five years of service. A participant is also fully vested in his account upon his death or total and permanent disability prior to termination.

NOTE 1 – DESCRIPTION OF THE PLAN, Continued

**Payment of Benefits** – On termination of service, a participant or participant’s beneficiary will receive the value of the participant’s vested interest in a lump-sum payment. Upon attaining normal or disability retirement, the participant may apply for retirement benefits. If the participant dies before retirement, his death benefit will be paid to his beneficiary in a lump-sum payment. Participants who own at least 5% of the Company must begin withdrawing benefits no later than April 1, following the year age 70 ½ is attained. Participants who are not 5% owners must begin withdrawing benefits no later than the latter of April 1, following the year age 70 ½ is attained or the participant’s retirement date.

**Forfeitures** - When certain terminations of participation in the Plan occur, the non-vested portion of the participant’s account represents a forfeiture. Forfeitures can be used to pay administrative expenses of the Plan or reduce future Company contributions to the Plan. If a terminated participant, who is deemed to have received a distribution, resumes participation in the Plan before five consecutive one-year breaks in credited service, then the participant is entitled to a restoration of any amount forfeited.

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$20,736 and \$1,957, respectively. In 2024 and 2023, employer contributions, which totaled \$297,264 and \$292,893 were reduced by \$20,736 and \$1,957 from the forfeited non-vested account.

**Hardship Withdrawals** - Participants may withdraw their vested contributions in the event of hardship as defined in the Summary Plan Description. Participants shall not be permitted to make contributions to the Plan for a period of 6 months following receipt of the hardship distribution.

**Plan Termination** – Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The financial statements of the Plan are prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition** – The Plan’s financial statements are stated at fair value, which is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Generally accepted accounting principles establish a fair value hierarchy which classifies investments into three levels. Level 1 includes investments valued using quoted market prices in active markets for identical assets or liabilities, Level 2 includes investments valued based on inputs derived from or corroborated by observable market data and Level 3 includes investments valued based on significant unobservable inputs. Inputs are broadly defined as assumptions market participants would use in pricing an asset or liability. Assets and liabilities are classified based on the lowest level of any input that is significant to the fair value measurement.

A description of the valuation methodologies used for assets measured at fair value, as reported by the custodian/trustee, is as follows:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds of the plan are deemed to be actively traded.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recognized as earned on the accrual basis. Dividend income is recognized at the ex-dividend date.

Net appreciation of the fair value of investments consists of the unrealized appreciation or depreciation of investments held during the year, reinvestment of dividends and the realized gain or loss on investments sold during the year.

**Benefit Payments** – Benefits are recorded when paid.

**Administrative Expenses** – The Plan’s administrative expenses are paid by either the Plan or the Plan sponsor, as provided by the plan document.

**Investment Risks** – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in fair value of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the financial statements.

**Use of Estimates** – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Subsequent Events** – In preparation of the accompanying financial statements, subsequent events that have occurred since the balance sheet date have been evaluated through July 28, 2025, the date the financial statements were available for issuance.

NOTE 3 – INCOME TAX STATUS

The Internal Revenue Service (IRS) has ruled the prototype plan from which the Plan was prepared qualifies under provisions of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. The Company has not filed for a determination letter from the IRS for the events that have occurred that might adversely affect the Plan’s exempt status and believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan sponsor has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan sponsor believes the Plan is no longer subject to income tax examinations for years prior to 2017.

NOTE 4 – INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN/TRUSTEE

The Plan’s investments are held by the custodian/trustee. All investment information disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied by the Plan sponsor and certified by the custodian/trustee as complete and accurate.

NOTE 5 – FAIR VALUE MEASUREMENTS

The following table sets forth by level, within the fair value hierarchy, the Plan’s investments at fair value as of December 31:

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels; Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 and Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of corporate bonds and U.S. government securities are valued using a market approach on yields currently available on comparable securities of issuers with similar credit ratings.

Gains and losses included in changes in net assets available for benefits for the year ended December 31, 2024, are reported in net appreciation in fair value of investments.

The Plan’s policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no transfers between Level 1 and Levels 2 and 3.

The following is a description of the valuation methodologies used at December 31, 2024 and December 31, 2023:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the U.S. Securities and Exchange Commission. The funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 6 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

In 2011, the Plan entered into a fully benefit-responsive investment contract with Massachusetts Mutual Life Insurance Company (MassMutual). MassMutual maintains the contributions in a general account. The account is credited with earnings and charged for participant withdrawals and administrative fees. The contract is included in the financial statements at contract value.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Upon withdrawal by participants, the contract issuer is contractually obligated to repay the principal and accumulated interest.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 3 percent. Such interest rates are reviewed on a quarterly basis for resetting. The crediting interest rate was 3 percent as of December 31, 2024 and 2023.

Certain events limit the ability of the Plan to transact at contract value with the contract issuer. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) the establishment of a similar fund that competes for participant contributions (c) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the contract, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan sponsor does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring.

NOTE 7 – RECONCILIATION BETWEEN FINANCIAL STATEMENTS TO FORM 5500

The net assets available for benefits per the financial statements agree to Form 5500 as of December 31, 2024 and 2023.

NOTE 8 – REMITTANCE PAYMENTS

During 2024 and 2023, the Plan sponsor remitted employee contributions to the Plan within fifteen days following the day in which the amounts were withheld from the employees’ paychecks. The Plan sponsor believes these contributions have been remitted timely under Section 2510.3-102 of the Department of Labor’s rules and Regulations for Disclosure under the Employee Retirement Income Security Act of 1974. If the payments are determined to be delinquent, the Plan will receive additional contributions from the Plan sponsor for any lost profits; management does not expect such additional contributions to be significant. There will be no liability on the part of the Plan in that the Plan sponsor and/or fiduciary would be required by law to pay all excise taxes and penalties.

NOTE 9 – PARTY IN INTEREST TRANSACTIONS

MassMutual is the Plan custodian/trustee and, therefore, administrative expenses paid to MassMutual qualify as party-in-interest transactions. Administrative expenses paid to MassMutual totaled \$50,671 and \$50,438 for 2024 and 2023, respectively.

Among plan investments are various funds managed by Massachusetts Mutual Life Insurance Company. Massachusetts Mutual Life Insurance Company is the trustee as defined by the plan and, therefore, these transactions qualify as party-in-interest.
