NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE A - PLAN DESCRIPTION

The following description of the Neon One LLC 401(k) Plan (the "Plan") provides only general information. The Plan was effective January 1, 2015 and was most recently restated and amended effective January 1, 2024. Participants should refer to the Plan adoption agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Neon One LLC (the "Company" or "Plan Sponsor"). Participants are eligible to participate in the Plan on the first day of the month after attaining six consecutive months of service and after reaching the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Effective January 1, 2024, the Plan's trustee and asset custodian is Reliance Trust Company and the recordkeeper is Automatic Data Processing (ADP). Prior to January 1, 2024 the Plan's trustee and asset custodian was Ascensus Trust Company ("Ascensus").

Contributions

Participant contributions are voluntary. Participants are entitled to make pre-tax contributions and Roth contributions in whole percentages. Participant contributions, whether pre-tax contributions, Roth contributions or a combination thereof, may not in the aggregate exceed 100% of eligible compensation, as defined in the Plan adoption agreement. Employees eligible for the Plan automatically have 3% of eligible compensation contributed to the Plan, unless they affirmatively elect to opt out of the automatic enrollment feature. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans or individual retirement accounts (rollovers).

The Company provides a safe harbor matching contribution equal to a 100% match on the participant's contributions with an elective deferral percentage less than or equal to 1%, and a 50% match on the participant's contributions with an elective deferral percentage greater than 1%, but less than or equal to 6% per year. The Company matching contributions are calculated and remitted with each payroll to eligible participant accounts. An additional true-up contribution was remitted to participant accounts subsequent to December 31, 2024 to ensure the Company matching contribution was determined on an annual basis. The Company also provides a discretionary profit-sharing contribution to eligible employees that is calculated and remitted quarterly, if applicable. The Company did not elect to make a discretionary profit-sharing contribution for the year ended December 31, 2024.

All contributions are subject to certain Internal Revenue Code ("IRC") limits.

Investment Options

Each participant has the right to direct the investment of his or her account into the various investment options offered by the Plan in increments of 1% or a flat dollar amount. Participants may change their investments daily.

Participant Accounts

A separate account is maintained for each participant. Each participant's account is credited with the participant's contributions and the Company's contributions, and an allocation of (1) Plan earnings (losses) and (2) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participant contributions and earnings thereon are always fully vested.

A participant's portion of the Company safe harbor matching and profit-sharing contributions, including earnings thereon, becomes 100% vested based on completion of two and three years of vesting service, respectively.

Notes Receivable from Participants

Participants may borrow from the vested portion of the pre-tax portion of their account balance. The maximum loan available is limited to 50% of such participants' vested accounts, but in no event shall the loan be less than \$1,000 or more than \$50,000, reduced by the highest outstanding loan balance during the previous 12 months. Participants can only have one loan outstanding. The loans are secured by the balance of the participant's account. The interest rate of the loan is set by the Company using the prime rate plus 1%. The interest rate is fixed throughout the duration of the loan. Interest income is recorded on the accrual basis. Loans are repaid in equal installments through payroll withholding over a period not to exceed five years or up to thirty years for the purchase of a primary residence.

Payment of Benefits

The Plan offers four types of withdrawals: non-hardship (retirement or termination of service), hardship, age 59½ and 73 for Required Minimum Distributions ("RMDs"). Each withdrawal type has specific requirements for eligibility, as defined in the Plan adoption agreement. Upon termination of employment, if a participant's account balance is \$1,000 or less, the total account balance is paid to the participant in a lump-sum distribution.

Forfeitures

Forfeitures result from non-vested Company contributions remaining in the Plan from terminated employees in accordance with the Plan adoption agreement and are used to reduce the Company contributions. Forfeitures in the amount of \$115,904 and \$80,934 were available as of December 31, 2024, and 2023, respectively, to reduce future Company contributions. In 2024, \$106,133 forfeitures were used to fund Company safe harbor matching contributions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Refer to Note C for fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is accrued as earned. Net realized and unrealized appreciation of investments is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation in fair value of investments and includes gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent loans are reclassified as distributions based upon the terms of the Plan adoption agreement.

Administrative Expenses

Administrative expenses relating to processing loans and distributions are paid by the participants. All other administrative expenses are paid by the Plan Sponsor and are excluded from these financial statements.

Investment Expenses

Investment expenses charged by mutual funds at the individual participant level are included in the net appreciation in fair value of investments.

Risks and Uncertainties

The Plan provides for various investment options. These investment options are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment options of the Plan, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the Plan's financial statements.

NOTE C - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board ("FASB") has issued guidance that establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the FASB guidance are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities may occur and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D - TAX STATUS

The Internal Revenue Service ("IRS") has determined that the prototype non-standardized profit-sharing plan adopted by the Company and provided by ADP is designed in accordance with applicable sections of the IRC, and informed ADP of such in a letter dated October 06, 2020. The Plan was created subsequent to receiving the opinion letter. However, the Plan Administrator believes the Plan is designed and operating in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant's Company contribution account balance will become fully vested.
