INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Assured Xpress 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE 1 - DESCRIPTION OF PLAN

General

Assured Xpress (the Company) established the Assured Xpress 401(k) Plan (the Plan) on January 1, 2023. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan that covers all full-time employees of the Company, except union and leased employees, non-resident aliens, and interns. The Plan requires participants be 21 or older and there is no service requirement for eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 90 percent of pretax annual compensation, as defined in the Plan and in accordance with applicable sections of the Internal Revenue Code (IRC). Additionally, Roth elective deferral contributions are limited to 50 percent of compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan has an automatic enrollment feature, and a qualified automatic contribution arrangement that begins at three percent and increases by one percent each year until it is capped at 15 percent. Participants direct the investment of their contributions into mutual fund investment options offered by the Plan. Until June 2024, the Company matched 100 percent of the first one percent of participant deferrals and 50 percent of the next five percent of participant deferrals for a total employer match of up to 3.5 percent. Effective June 2024, the employer match was changed to 100 percent of the first one percent of participant deferrals and 50 percent of the next two percent of participant deferrals for a maximum total employer match of 1.5 percent. Additional amounts may be contributed by the Company at its discretion. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. Participant accounts are also charged a transactional administrative fee for certain distributions and other activity as specified in the service agreements. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their own contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is based on an 18-month cliff vesting schedule. A participant is 100 percent vested after 18 months of credited service.

Forfeited Accounts

Forfeited accounts may be used to reduce Plan administrative expenses or reduce Plan contributions. During 2024 and 2023, \$2,552 and \$1,837 of forfeitures were used to reduce employer contributions, respectively. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$42,197 and \$437 for the Plan, respectively.

Payment of Benefits

On termination of service due to termination, death, or retirement, a participant may elect to take a lump-sum distribution or rollovers into a new plan. The Plan was amended effective June 25, 2024 to allow for account balances less than \$5,000 to be distributed by the Company without participant election. Amounts less than \$1,000 will be provided with a lump-sum distribution upon termination. A participant may also receive an in-service withdrawal upon attaining age 59 ½. In addition, hardship distributions are permitted if certain criteria are met. Benefits are recorded when paid.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Administrative Expenses

Administrative expenses are absorbed by the Company to the extent they are not paid by the Plan. Participants are only charged administrative fees for transactions such as withdrawal processing fees and qualification fees for qualified domestic relations orders.

Subsequent Events

The Company evaluated subsequent events through September 22, 2025, the date which the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENT

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by the observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued based on the quoted net asset value (NAV) of the shared held by the Plan at year-end.

Cash and Cash Equivalents: Cash held in the Plan is included in the fair value hierarchy at cost.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of valuation methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 - RELATED-PARTY TRANSACTIONS

Certain Plan investments are mutual fund accounts managed by Matrix Trust Company, the certifying entity of the Plan. These transactions qualify as party-in-interest transactions.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE 7 - TAX STATUS

The IRS has determined and informed the plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - CERTIFYING ENTITY CERTIFICATION

The following is a summary of the unaudited information, included in the Plan's financial statements and supplemental schedules that was prepared or derived from information prepared by Matrix Trust Company, the certifying entity of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained a certification from Matrix Trust Company that such information is complete and accurate.

Statements of Net Assets Available for Benefits – all items and amounts.

Statement of Changes in Net Assets Available for Benefits – all items and amounts except for contributions, benefits paid to participants, and administrative expenses.

Supplemental Schedules – all items and amounts, except for delinquent participant contributions.

NOTE 9 - SETTING EVERY COMMUNITY UP FOR RETIREMENT ACT (SECURE 2.0)

In December 2022, SECURE 2.0 was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act. Most of the provisions will become effective for plan years beginning after December 31, 2025, therefore there is no current impact to the Plan. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.

NOTE 10 - CONTRIBUTIONS RECEIVABLE RESTATEMENT

Subsequent to the issuance of the Plan's December 31, 2023 financial statements, it was determined that owner contributions related to the 2023 plan year were not remitted to the Plan until March 2024. In accordance with the Employee Retirement Income Security Act of 1974 ("ERISA"), these contributions should have been reflected as contributions receivable and included in contributions for the year ended December 31, 2023.

Accordingly, the accompanying 2023 financial statements have been restated to record participant contributions receivable of \$45,000 and employer contributions receivable of \$6,452. As a result of these adjustments, net assets available for the benefits as of December 31, 2023 amount to \$200,444 rather than the previously reported \$148,992.
