INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Plan Participants of
Seoyon E-Hwa Interior Systems Alabama, LLC Employees Savings Trust, and
Board of Directors of Seoyon E-Hwa Interior Systems Alabama, LLC:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Seoyon E-Hwa Interior Systems Alabama, LLC Employees Savings Trust (the "Plan"), an employee benefit Plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Note 1 – Description of Plan

Seoyon E-Hwa Interior Systems Alabama, LLC. (the “Company” and the “Plan Sponsor”) sponsors the Seoyon E-Hwa Interior Systems Alabama, LLC Employees Savings Trust (the “Plan”), which is a defined contribution plan. Substantially all employees of the Company who are age of 21 and have completed 3 months of service are eligible to participate to the Plan. The Plan began on January 1, 2008 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Contributions

Participants may elect to defer up to 90% of their eligible compensation on a pre-tax or Roth basis, subject to the annual limits imposed by the Internal Revenue Code (\$23,000 for 2024, plus an additional \$7,500 catch-up contribution for participants age 50 and older). These dollar limits are indexed for cost-of-living adjustments. The Plan permits rollover contributions from other eligible retirement plans. Rollover contributions are placed in the participants' accounts and are subject to the Plan's investment rules.

Employer contributions to the Plan may include matching contributions, non-elective contributions, and qualified non-elective contributions (“QNECs”):

Employer Matching Contributions: The Plan Sponsor may, in its sole discretion, make matching contributions on participants' elective deferrals and/or catch-up contributions. For 2024, the Employer provided a discretionary matching contribution equal to 50% of elective deferrals, not exceeding 2% of a participant's compensation.

Non-Elective Contributions: The Employer may, in its sole discretion, make non-elective contributions on behalf of eligible participants. Under the Plan, non-elective contributions are allocated in proportion to each participant's compensation relative to the total compensation of all eligible participants.

QNECs: The Employer may also, at its discretion, make QNECs to ensure compliance with applicable nondiscrimination requirements.

The annual dollar limit for combined contributions (excluding catch-up contributions) cannot exceed the lesser of \$69,000 or 100% of a participant's annual compensation for 2024.

Vesting

Participants are always 100% fully vested in account attributable to salary deferrals including catch-up contribution, rollover contributions, and actual earnings thereon. Participants whose employment terminates for any reason other than death, disability, attainment of age 65, normal retirement age, will be vested in matching contributions accounts to the following schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of 50% of their vested account balance or \$50,000. Participants may only have one loan outstanding at any time and repayment of the loan is secured by participants' vested account balances. The period of repayment cannot exceed five years. The interest rate is equal to one percent above the prime rate and will be fixed for the duration of the loan.

Participants Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Plan Sponsor's contributions and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Distribution of Benefits

A participant may receive a distribution of the vested portion of some or all of accounts throughout a single lump-sum payment, upon reaching the normal retirement age, disability, death or termination of employment for reasons other than death, disability or retirement. All distributions from the Plan will require participant consent if vested account (including any rollover contribution account) balance exceeds \$7,000. And a participant may also withdraw the vested value of a participant's account in the event of a participant's heavy and immediate financial hardship. Hardship distributions may not exceed the amount of participant's financial hardship.

Forfeitures

If a participant terminates employment before becoming 100% vested in his or her account balance and receives a distribution of the vested matching contributions, the non-vested portion will be forfeited upon distribution made. Forfeited amount will be used to administrative expenses or applied to reduce future matching contributions. For the year ended December 31, 2024, the non-vested portion that was forfeited totaled \$38,005. At December 31, 2024, outstanding balance of forfeited account amounts to \$9,599.

Top-Heavy Plan

If the Plan becomes top-heavy, when more than 60% of the Plan's assets are in the accounts of key employees, in any plan year, then non-key employees will be entitled to certain "top-heavy minimum benefits", and other special rules will apply. Among these top-heavy rules, the Plan Sponsor may be required to make a contribution on a participant's behalf in order to provide with at least "top-heavy minimum benefits".

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The accompanying statements of net assets available for benefits and changes in net assets available for benefits have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of the Plan assets and liabilities at the financial statement date. Accordingly, actual results may differ from those estimates.

The Plan utilizes various investment instruments including common/collective trusts and registered investment companies. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Investments

The Plan's investments are stated at fair value. Purchases and sales of investments are recorded on a trade-date basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Distributions

Distributions to participants are recorded when paid.

Fair Value of Financial Instruments

Investments are stated at fair value. The carrying amounts for interest-bearing cash and receivables approximate their fair values due to the short-term nature of these instruments.

Note 3 – Federal Income Taxes

The Plan document is a prototype document that the Plan Sponsor adopted with specific provisions customized to meet the needs of the Plan Sponsor and the participants. The prototype document has received a favorable determination from the Internal Revenue Service that the form of the Plan is acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the original determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 4 – Plan Termination

Although it is not intended to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time subject to the provisions of ERISA. Upon termination, no further contributions will be made to the Plan and all amounts credited to participants' accounts will become 100% vested.

Note 5 – Fair Value Measurements

The FASB Accounting Standards Codification ("ASC") 820, *"Fair Value Measurements and Disclosures"*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to those valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described as follows:

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and to minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measure at fair value. There have been no changes in the methodologies used for the year ended December 31, 2024.

Registered investment companies funds: Valued at the daily closing price as reported by the fund which is deemed to be actively traded.

Fixed account: Valued at contract value based on credited rates determined by the insurance company using observable market inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 – Party-In-Interest Transactions

The Plan engages in transactions with parties-in-interest, as defined by Section 3(14) of the Employee Retirement Income Security Act of 1974 (“ERISA”). Parties-in-interest generally include the Plan Sponsor, fiduciaries, service providers, and certain affiliates, as well as participants and their beneficiaries.

During the year, the Plan held notes receivable from participants arising from participant loans and recognized related interest income. The Plan also made payments to parties-in-interest that provided administrative and recordkeeping services to the Plan. The Plan held no investments in collective trust funds or mutual funds managed by the trustee or its affiliates as of December 31, 2024.

Such transactions are considered party-in-interest transactions under ERISA regulations; however, they are specifically permitted under the provisions of the Plan and are exempt from the prohibited transaction provisions of ERISA Section 406 and Internal Revenue Code Section 4975. All such transactions were conducted in the ordinary course of the Plan’s operations, were consistent with the terms of the Plan, and

Note 9 – Corrections for Delinquent Participant Contributions

During the year ended December 31, 2024, certain participant contributions and loan repayments were not remitted to the Plan within the time frame required by the Department of Labor (“DOL”) regulations. These delays constitute prohibited transactions under ERISA.

The Plan Sponsor has identified these late remittances and is in the process of completing the correction under the IRS Self-Correction Program (“SCP”) in accordance with applicable DOL and IRS guidance. As part of this correction, the Plan Sponsor is calculating and depositing the lost earnings associated with the delayed remittances into the affected participants’ accounts. Once completed, no further corrective action will be required, and the matter will be considered fully resolved under SCP.

Note 10 – Corrections for Excess Deferrals and Matches

As part of the year-end 2024 compliance testing, the Plan identified failures in the Plan Deferral Limit Test and the Plan Match Limit Test. Specifically, excess employee deferrals of approximately \$957 and excess employer matching contributions of approximately \$783 were noted, subject to related investment gains and losses. According to the Plan Sponsor, the necessary corrective actions were completed in March 2025. For participants who had already received full distributions prior to year-end testing, no further corrective action was required and such failures were deemed corrected. For one remaining affected participant, excess matching contributions and related earnings were forfeited. These corrections are reflected in the Plan’s records and participants’ accounts subsequent to year-end.

Note 11 – Participant Loan Deemed Distributions

Certain participant loans were treated as deemed distributions in accordance with Internal Revenue Code §72(p) and related regulations. A deemed distribution occurs when a loan fails to satisfy the statutory requirements, such as exceeding the permissible loan limit, not being repaid according to the specified repayment schedule, or not being repaid following a participant’s termination of employment. Although no actual distribution of plan assets occurs at the time of a deemed distribution, the outstanding loan balance is treated as a taxable distribution to the participant and is reported on Form 1099-R using distribution code “L.” Any income tax and applicable early distribution penalty are the sole responsibility of the participant.

During the year ended December 31, 2024, the Plan determined that participant loan balances totaling \$3,622 met the criteria to be treated as deemed distributions and included such amounts in the accompanying financial statements. Any related income tax and applicable early distribution penalty remain the responsibility of the participants.

Note 12 – Corrections for Missed Contributions

During 2025, the Plan Sponsor remitted corrective contributions of \$20,473, including lost earnings of \$3,792, to the Plan. The correction related to missed employee deferrals and matching contributions on bonus compensation and payroll adjustments earned during the 2023 plan year. This correction was made pursuant to SCP. Although the actual remittance occurred in 2025, under the accrual basis of accounting, the corrective contribution and related lost earnings have been recorded in the accompanying

financial statements. As a result, the 2024 financial statements reflect employer contributions receivable of \$18,656 as of December 31, 2024, and employer contributions of \$18,656 for the year then ended.

Note 13 – Subsequent Events

Management has evaluated subsequent events occurring after December 31, 2024 through September 30, 2025, the date on which the financial statements were available to be issued. Management has concluded that all subsequent events requiring recognition or disclosure have been appropriately reflected in the financial statements, including corrections related to delinquent participant contributions, excess deferrals and matches, deemed distributions, and missed contributions, as described in Notes 9, 10, 11, and 12, respectively.
