INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of
Cryogenic Industries 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Cryogenic Industries 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section:

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of Cryogenic Industries 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document and adoption agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan established effective January 1, 2016 and amended and restated effective January 1, 2024. Employees of Cryogenic Industries, Inc. or related employers (collectively, the "Company") who meet specified age and other requirements are eligible to participate in the Plan.

Effective January 1, 2024, the trustee of the Plan changed from Ascensus Trust Company to Reliance Trust Company. Effective January 1, 2025, the trustee of the Plan changed from Reliance Trust Company to ADP Retirement Trust Services, LLC.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the dates of the financial statements and the reported amounts of increases and decreases in assets available for benefits during the reporting periods. Actual results could differ from those estimates.

Contributions - Eligible employees may contribute a portion of their compensation as defined by the Plan, subject to certain limitations under the Internal Revenue Code ("IRC"). Eligible participants automatically defer 3% of their compensation to the Plan unless they make an election otherwise. Effective January 1, 2024, the automatic enrollment percentage was increased to 4%, and an automatic increase provision was instated under which employee contributions automatically increase by 1% each year, to a maximum of 10%, unless otherwise elected. The Company may elect to match a portion of employees' contributions.

The Company made matching contributions of 100% of the first 3% of salary deferrals for the period from January 1, 2023 to June 30, 2024 and 100% of the first 4% of salary deferrals for the period from July 1, 2024 to December 31, 2024. These contributions were computed and made each pay period.

Employee Rollovers - Employee rollovers represent nonforfeitable contributions from other qualified plans.

Investment Valuation and Income Recognition - Investments are carried at fair value. The Plan presents net appreciation or depreciation in the fair value of its investments, which consists of realized gains or losses and the unrealized appreciation (depreciation) of these investments, in the statements of changes in assets available for benefits. Gains and losses on securities sold or redeemed are determined on the basis of specific identification. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Participant Accounts - Each participant's account is credited with the participant's contributions and an allocation of the Company's matching contributions, as applicable. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - The accounts for all participants' contributions are fully vested and nonforfeitable at all times. Company contributions are 100% vested after three years of continuous service.

Forfeitures - When a participant withdraws from the Plan prior to becoming fully vested, the nonvested portion of the participant's account related to matching contributions may be utilized to pay administrative expenses of the Plan; otherwise, forfeitures shall be utilized to reduce the Company's matching contributions. Forfeitures were \$318,901 and \$48,777 for the years ended December 31, 2024 and 2023, respectively. Forfeitures of \$6,314 and \$60,851 were utilized to pay plan expenses for the years ended December 31, 2024 and 2023, respectively. Forfeitures of \$131,099 were utilized to reduce employer contributions for the year ended December 31, 2024. There was no balance available to the Company as a result of forfeitures at December 31, 2023. The balance available to the Company as a result of forfeitures was \$181,488 as of December 31, 2024.

Notes Receivable from Participants - Participants may borrow from their accounts up to the lesser of \$50,000 or 50% of the participant's vested account balance. Loans must be at least \$1,000 and are secured by the balance in the participant's account. Loans bear interest at the prime rate on the origination date of the loan or at the prime rate on the origination date of the loan plus 1%. At December 31, 2024, the interest rate on loans outstanding ranged from 3.25% to 9.5%. At December 31, 2023, the interest rate on loans outstanding ranged from 3.25% to 8.5%. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Benefits - Upon termination of service due to death, disability, retirement or termination, participants or their beneficiaries may elect to receive an amount equal to the value of the vested interest in their account. Participants who face hardship or attain age 59½ may also be eligible for distributions. The form of payment is a lump-sum distribution.

Plan Expenses - The Plan's expenses are paid by the Company or the Plan as provided by the plan document. The Plan's expenses mainly consist of recordkeeping and advisory fees for the years ended December 31, 2024 and 2023.

Investment Options - Participants may direct their contributions and any related earnings into various investment options. The Plan is invested in various mutual and money market funds offered primarily by American Funds.

Participants may elect to have their accounts invested in the available options by allocating the contributions evenly among the investment options or by designating specific allocations among the options. Participants may change their investment options at any time.

Fair Value Measurements - Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs are not quoted prices in active markets, but they are observable either directly or indirectly.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's mutual and money market funds are valued using closing prices reported by the active market on which the individual funds are traded (Level 1). There have been no changes to the methodology used at December 31, 2024 or 2023. This method may produce fair value calculations that may not be indicative of net realizable values or reflective of future fair values. Furthermore, while the plan administrator believes the valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Subsequent Events - The plan administrator has analyzed subsequent events for recognition and disclosure purposes through October 9, 2025, the date the financial statements were available to be issued.

2. PLAN TERMINATION

The Company anticipates and believes that the Plan will continue without interruption but reserves the right to discontinue the Plan at its discretion. In the event that such discontinuance results in the termination of the Plan, all amounts credited to participant accounts become 100% vested. The assets of the Plan will be distributed by the trustee in accordance with the trust agreement in a uniform and nondiscriminatory manner.

3. INCOME TAX STATUS

The Plan operates under an adoption agreement in connection with a non-standardized pre-approved 401(k) plan. The Internal Revenue Service has stated in a letter dated October 6, 2020 that the prototype plan is designed in accordance with the applicable regulations of the IRC. The Plan has been amended since the date of the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management believes there is no liability related to uncertain tax positions at December 31, 2024 or 2023. The Plan is no longer subject to U.S. federal or state income tax examinations by tax authorities for tax years before 2021.

4. CERTIFIED FINANCIAL INFORMATION

Ascensus Trust Company, the trustee from January 1, 2023 to December 31, 2023, and Reliance Trust Company, the trustee from January 1, 2024 to December 31, 2024, have certified that the following data included in the accompanying financial statements is complete and accurate:
