Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Penny Lane 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following brief description of Penny Lane 401(k) Retirement Plan (“the Plan”) is provided for general information purposes only. Participants should refer to the Plan’s agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Penny Lane Centers (“Penny Lane”) who are at least twenty-one years of age, except for union employees, nonresident aliens with no U.S. source of income, and leased employees. The Plan was established on December 1, 1998, and amended and restated on January 1, 2016, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Board of Directors is responsible for oversight of the Plan. The appropriateness of the Plan’s investment options, and the investment performance are monitored by the Board with the assistance of the Plan’s third-party administrator.

Contributions

A participant becomes eligible to make contributions to the Plan on the first day of the calendar month following the completion of one hour of service in a two-month period. Participants may contribute up to the maximum determined by the Internal Revenue Code from their eligible compensation as defined in the Plan. In addition, participants qualifying for age-based provisions may contribute an additional catch-up deferral. Participants may also contribute amounts representing distributions from other eligible retirement plans.

Participants are eligible to receive matching contributions and discretionary profit-sharing contributions following the completion of one year of service, with a minimum of 1,000 hours of service during that period. Penny Lane may also make discretionary matching contributions equal to a discretionary percentage of the participant’s elective deferral and discretionary profit-sharing contributions based on the same ratio as each participant’s compensation bears to the total compensation of all participants.

Participant Accounts

Each participant’s account is credited with an allocation of contributions and plan earnings. Allocations are based on account balances, as defined. The benefits to which a participant is entitled are the benefits that can be provided from the participant’s account.

1. Description of Plan, continued

Vesting

Participants are fully vested in their elective deferrals plus actual earnings. Matching contributions and the discretionary profit-sharing contributions are vested over six years of credited service:

Forfeitures

Forfeitures are the non-vested portions of participants' accounts that are lost upon termination of employment. Forfeitures of employer contributions are applied to reduce employer contributions. As of December 31, 2024, and 2023, there were \$42,891 and \$15,790, respectively, of non-vested forfeited accounts included in the Statements of Net Assets Available for Benefit. Forfeitures used during 2024 and 2023 were \$58,720 and \$22,809, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The minimum loan term is one year and cannot exceed five years. Loans for the purchase of a primary residence may be from one to thirty years. A participant may have two loans outstanding at any one time. The loans are secured by the balance in the participant's account and bear interest at 1% above the prime rate. Principal and interest are paid ratably through semi-monthly payroll deductions.

Payment of Benefits

On termination of service, a participant may elect to receive benefit payments as follows: (a) a single lump sum payment or (b) substantially equal monthly, quarterly, or annual installments over a period of years not to exceed the life expectancy of the participant or that of the participant and his/her spouse.

2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of Presentation

The financial statements of the Plan are reported on the accrual basis of accounting.

Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains (losses) on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned, and related fees are recorded as administrative expenses and expensed when incurred.

Fair Value Measurements

Generally accepted accounting principles provide guidance on how fair value should be determined when financial statement elements are required to be measured at fair value. Valuation techniques are ranked in three levels depending on the degree of objectivity of the inputs used with each level:

Level 1 inputs - quoted prices in active markets for identical assets

Level 2 inputs - quoted prices in active or inactive markets for the same or similar assets

Level 3 inputs - estimates using the best information available when there is little or no market

The Plan is required to measure certain investments at fair value. The specific techniques used to measure fair value for the financial statement element is described in the notes below that relate to the element.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures as of the date and for the period presented. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies, continued

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with certain investment securities that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across various asset classes and the utilization of investment managers.

Subsequent Events

Management has evaluated subsequent events through October 9, 2025, the date which the financial statements were available for issue. No events or transactions have occurred during this period that appear to require recognition or disclosure in the financial statements.

3. Notes Receivable from Participants

Notes receivable from participants are repaid semi-monthly through payroll deductions and bear interest at rates that are commensurate with local prevailing rates from 4.25% to 9.50%. Notes receivable from participants outstanding at December 31, 2024 and 2023 were \$857,420 and \$484,593, respectively.

No auditing procedures were performed on investment and interest income as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

7. Related Party and Party-in-Interest Transactions

Certain administrative functions are performed by officers and employees of Penny Lane. No officer or employee received compensation from the Plan for these services.

Fees incurred by the Plan for investment management services are included in net depreciation in fair value of investments, which were not covered by revenue sharing. The Plan also made direct payments to service providers which were not covered by revenue sharing. Administrative fees paid by the Plan to the Third party administrator were \$73,144.

8. Plan Termination

Although it has not expressed any intent to do so, Penny Lane has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

9. Tax Status

The trust established under the Plan to hold the plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code and, accordingly, the trust's net investment income is exempt from income taxes. The Plan was adopted from a Volume Submitter Profit Sharing Plan with Cash or Deferred Arrangement, which has received an opinion letter dated October 29, 2008, from the Internal Revenue Service ("IRS"). It was amended and restated on January 1, 2016 as the Plan; however, the plan sponsor believes that the Plan continues to qualify and to operate as designed.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.
