Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of ESCO Construction Co. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Plan Description

The following description of ESCO Construction Co. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of ESCO Construction Co. (the "Company") who have completed two months of service and are age 18 or older, excluding members of a collective bargaining unit where retirement benefits were the subject of good-faith bargaining and nonresident aliens with no U.S. source of income. The entry date for eligible participants is the first day of the month coinciding with or following the employee meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

ESCO Construction Co. is the sponsor of the Plan. The board of directors, as provided in the plan agreement, is the plan administrator and has responsibility for the administration of the Plan. Through June 30, 2024, Charles Schwab Trust Bank functioned as the custodian of the Plan and The Retirement Plan Company, LLC served as the Plan's third-party administrator. On July 1, 2024, the Company changed plan custodians and administrators and the Plan was amended and restated. ADP Retirement Trust Services, LLC now functions as the custodian and the third-party administrator of the Plan. Investment management fees and trustee fees are paid by the Plan in accordance with the plan agreement.

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute up to 100 percent of their compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Certain participant contributions in 2024, 2023, and 2022 were paid after the time frame required by the Department of Labor. The Company remitted the 2024 delinquent contributions and the related lost earnings during August 2025 and September 2025. The Company remitted the 2023 delinquent contributions and the related lost earnings during September 2024 and October 2024. The delinquent contributions and related lost earnings for 2022 have not been remitted to the Plan.

The Company matches 100 percent of participant contributions up to the first 3 percent of compensation deferred and 50 percent of participant contributions in excess of 3 percent of compensation, up to a maximum of 5 percent of compensation. These company contributions are intended to satisfy the safe harbor provisions under the Internal Revenue Code. Participants are eligible to receive these company contributions after attaining eligibility, as noted previously.

The Company may make annual discretionary contributions. No discretionary contribution was made by the Company in 2024.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range up to 9.5 percent, which are commensurate with local prevailing rates determined periodically by the plan administrator. Principal and interest are paid ratably through payroll deductions, with maturities ranging through August 2029.

Note 1 - Plan Description (Continued)

Participant Accounts

Each participant's account is credited or charged with the participant's contributions and allocations of the Company's contributions, plan earnings, and forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on a participant's compensation or account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants' contributions, the employer safe harbor matching contribution, and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

The Company's discretionary contributions, if any, vest according to the following schedule:

Benefit Payments

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age in the form of a lump-sum amount equal to the vested balance of a participant's account.

Participants may request a certain portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances were *de minimis*, and no amounts were used to reduce company contributions or pay administrative expenses of the Plan during the year ended December 31, 2024.

Party-in-interest Transactions

Certain plan assets were in investment funds managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank was the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. In addition, the Plan has loans to participants. These transactions also qualify as party-in-interest transactions. Both of these transaction types are exempt from the prohibited transaction rules.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

Investments held by the Plan are stated at fair value based on quoted market prices. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 8, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

In 2024, the Plan changed its custodian from Charles Schwab Trust Bank to ADP Retirement Trust Services, LLC (collectively, the "Custodian"). The Custodian of the Plan held the Plan's investments and executed all related transactions during the periods under audit. The investment and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information provided by the Custodian. Additionally, ADP Retirement Trust Services, LLC held and executed participant notes receivable and certified the related balances and interest income as of December 31, 2024 and for the period from July 1, 2024 to December 31, 2024.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Money Market Fund

Money market funds are valued at quoted prices reported in active markets.

Common/Collective Trust Funds

The common/collective trust funds are valued at net asset value per share or its equivalent of the funds, which is based on the fair value of the funds' underlying net assets.
