Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Huddl3 Group 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan document, as amended and restated, for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that was established January 1, 1996, and is sponsored by HUDDL3 Group (“Company”). The Plan is a single-employer 401(k) plan covering substantially all employees of the following participating employers:

 HUDDL3 Group, LLC
 PTS Advance
 SmartSearch, Inc.

Effective February 1, 2024, LEAD3R, LLC became a participating employer under the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees are immediately eligible to participate in the Plan upon hire. There is no minimum age nor service requirement in order to be eligible to participate in the Plan. The Plan allows employees to begin participating immediately upon reaching eligibility.

Contributions

The Plan permits eligible participants to contribute up to 25% of compensation, subject to certain Internal Revenue Code limitations (\$23,000 and \$22,500, respectively, for 2024 and 2023, \$30,500 and \$30,000, respectively, for employees over the age of 50 for 2024 and 2023). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan provides for discretionary nonelective employer contributions, which are allocated based on the participants’ eligible compensation. There were no such contributions for the year ended December 31, 2024.

Participant Accounts

Individual accounts are maintained for each of the Plan’s participants to reflect each participant’s contributions and any employer contributions, as well as the participant’s share of his investment income or loss, less an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE 1 – DESCRIPTION OF PLAN, CONTINUED**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution is based on years of continuous service. A participant is 100% vested in matching Company contributions after four years of credited service and 100% vested in discretionary Company contributions after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance for up to five years. A 30-year loan is available for the purchase of a primary residence. The balance in the borrower's Plan account secures the loans; interest rates of 5.25% to 10.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Hardship Withdrawals

A withdrawal from a participant's account may be permitted if the participant has a financial hardship as defined in the Plan document.

Payment of Benefits

On termination of service, death, disability, or retirement, a participant may elect to receive either a lump-sum amount or installment payments equal to the value of his or her vested account balance, to roll over the vested balance into another qualified plan, or to leave the vested balance in the Plan if greater than \$5,000. Participants may also elect an in-service distribution after attaining age 59½.

Forfeited Accounts

Forfeited non-vested accounts may be used to reduce future employer contributions or to pay the administration costs of the Plan. During the year ended December 31, 2024, administration costs of \$66,081 were paid from forfeited non-vested accounts. As of December 31, 2024 and 2023, there were \$75,521 and \$52,356, respectively, of forfeitures that have not yet been applied to Plan expenses or allocated to eligible participants.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**Basis of Accounting**

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, CONTINUED**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 – Fair Value Measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain transactional fees are charged directly to the participant's account. Investment-related expenses are included in net appreciation in the fair value of investments.

Date of Management's Review

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

NOTE 4 – FAIR VALUE MEASUREMENTS

The Plan’s investments are reported at fair value on a recurring basis in the statement of net assets available for benefits in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 – “Fair Value Measurements and Disclosures.” This pronouncement defines fair value, establishes a framework for measuring fair value, enhances fair value disclosure requirements and creates a three-level valuation hierarchy for disclosure of fair value measurement. This valuation hierarchy is based upon the transparency of inputs to the valuation of an asset or liability as of the measurement date. The three levels of the inputs to the valuation methodology are defined as follows:

- Level 1 – Observable, quoted market prices (unadjusted) in active markets for identical assets and liabilities that the reporting entity has the ability to access at the measurement date.
- Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data. This input level includes those financial instruments that are valued using models or other valuation methodologies where substantially all of the assumptions are observable in the marketplace, can be derived from observable market data, or are supported by observable levels at which transactions are executed in the marketplace.
- Level 3 – Unobservable inputs that are not corroborated by market data. This level of input includes financial instruments whose fair value is estimated based on internally developed models or methodologies utilizing significant inputs that are generally less readily observable from observable sources.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4 – FAIR VALUE MEASUREMENTS, CONTINUED

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued based on the net asset value of the shares held by the Plan at year end.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes that the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – RELATED PARTY TRANSACTIONS

Certain administrative functions are performed by officers or employees of the Plan sponsor and, therefore, these transactions qualify as party-in-interest transactions. No officer or employee of the Company receives compensation from the Plan. Certain Plan expenses are paid directly by the Plan Sponsor.

Certain administrative functions are performed by the plan auditor and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to the plan auditor from Plan assets totaled \$11,573 for the year ended December 31, 2024 and are included in administrative expenses on the statement of changes in net assets available for benefits.

Certain administrative functions are performed by the Plan's record-keeper and third-party administrator and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to the record-keeper and third-party administrator were \$85,357 for the year ended December 31, 2024 and are included in administrative expenses in the statement of changes in net assets available for benefits.

Certain investments are managed by the investment advisors of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to the investment advisors from Plan assets totaled \$60,041 for the year ended December 31, 2024 and are included in administrative expenses on the statement of changes in net assets available for benefits.

NOTE 6 – TAX STATUS

The IRS has determined and informed the plan sponsor by a letter dated March 31, 2008, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Subsequent to year end, in May 2025, the Company’s Board of Directors expressed intent to terminate the Plan and merge plan assets into another plan as of June 1, 2025 (see Note 12).

NOTE 12 – SUBSEQUENT EVENTS

On January 1, 2025, the Plan was modified to change the plan’s trustee from Reliance Trust Company to ADP Retirement Trust Services, LLC.

On April 10, 2025, the account balances for employees of PTS Advance were transferred to a new plan, in advance of the Company’s sale of PTS Advance on May 2, 2025.

In May 2025, the Company’s Board of Directors deemed termination of the Plan imminent and decided transfer all remaining assets to another plan. Accordingly, as of May 31, 2025, no contributions, loan payments, or new loans were allowed into or out of the Plan, and all participant balances became fully vested. All account balances were transferred from the Plan into the new plan as of September 30, 2025.
