NOTE A – DESCRIPTION OF THE PLAN

The following description of the **Ken Ganley Companies Retirement Savings Plan** (Plan) provides only general information. The Plan covers various dealerships managed by **Ken Ganley Companies**. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

Ken Ganley Companies (the "Company", and plan "Sponsor") established the plan effective January 1, 1999 and has been amended on various dates, most recently November 1, 2022. The Plan is a contributory tax deferred plan established under section 401(k) of the Internal Revenue code and covers all full-time employees who have completed four-months of service and have attained the age of twenty-one. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan Administrator and is responsible for the day-to-day operation of the Plan. They designate other parties to perform certain duties.

The Plan's Trustees is **Reliance Trust Company**.

Tax Status

The Internal Revenue Service has determined by letter dated October 6, 2020 that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable provisions of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Participant Accounts

Each participant's account is credited with the participant's contribution and (a) the Company's matching contribution, (b) an allocation of Plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Contributions

Participants may elect to contribute a portion of their pay each period to the Plan. Participants may contribute the lesser of **\$23,000** and **\$22,500** for **2024** and **2023**, respectively or **75%** of their compensation. If a participant reached age **50** in **2024** or **2023**, the participant could contribute an

additional **\$7,500** or **\$7,500** to the Plan, respectively. Participants direct the investment of their contributions into various investment options offered by the Plan. These deferred contributions (salary deferrals) are not subject to federal or state income tax when the contribution is made to the Plan, instead they are taxed when paid from the Plan. A participant may also designate contributions as before-tax savings,” Roth” after tax savings, or any combination of the two. Employees may revoke their election at any time during the year.

The Company has the right to make flexible discretionary contributions to the Plan. There were no discretionary contributions made in **2024** or **2023**. These contributions shall be unrelated to any employee contributions made during the Plan year and shall be distributed to employees on a pro rata basis as of the end of the Plan year.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company’s contributions portion of their accounts plus earnings thereon is based on years of continuous service.

Participants are vested in Company contributions according to the following schedule:

Net assets available for benefits include the accounts of active participants, as well as certain separated, vested and retired participants who have elected to receive their benefits in installment payments. These participants share in the earnings of the investments.

Investment Options

Upon participation in the Plan, a participant may direct contributions in one or more of the investment funds provided under the Plan. Separate accounts are maintained for elective contributions, matching contributions and discretionary contributions. Participants may change their investment options at their own discretion.

Participant Loans

Notes receivable from participants are measured at their unpaid principal balance, plus accrued interest. Participants may borrow from their fund accounts a minimum of **\$1,000** up to a maximum equal to the lesser of **\$100,000** or **50%** of their account balance. The loans are secured by the balance in the participant’s account and bear interest at prime plus **1%** and range from **4.25%** to **9.50%**, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through monthly payroll deductions. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document. No allowance for credit losses has been recorded as of **December 31, 2024** and **2023**.

Payment of Benefits

On termination of service due to disability, retirement, or other reason, a participant (or their designated beneficiary) elects to receive benefits under the various options described in the plan documents including lump-sum payment, direct rollover options, partial distributions or a series of installment payments in an amount equal to the value of the participant's vested interest in his or her account. If any portion of the participant's vested benefit is attributable to Roth elective deferrals or Roth rollover contributions that portion may only be rolled over to a similarly designated Roth IRA or a retirement plan accommodates Roth accounts.

If the participant's vested account balance is **\$5,000** or less (disregarding any rollover balance), then it may only be paid out in a single lump sum payment. If it is over **\$5,000**, it may be paid in a single lump sum payment, or in installments over a period of not more than the participants life expectancy, or on an ad-hoc basis.

Hardship Distribution

Under certain circumstances, a participant may qualify for certain hardship distributions if a participant has an immediate and significant financial need, subject to certain usage requirement and other conditions.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants will become **100%** vested in their accounts.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

This summary of significant accounting policies of **Ken Ganley Companies Retirement Savings Plan** is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management who is responsible for the preparation and fair presentation of the financial statements. These accounting policies conform to the modified cash basis of accounting and have been consistently applied in the preparation of the financial statements.

Basis of Accounting

The financial statements are prepared on the modified cash basis of accounting. Accordingly, significant receivables, payables and other liabilities are presented based upon the following policies.

Estimates

The preparation of financial statements on the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Fair Value of Financial Instruments

Financial Accounting Standards Board *Accounting Standards Codification* (FASB ASC) 825 requires disclosures about the fair value for all financial instruments, whether or not recognized, for

financial statement purposes. Disclosures about fair market value of financial instruments are based on pertinent information available to management as of **December 31, 2024** and **2023**. Accordingly, the estimates presented in these statements are not necessarily indicative of the amounts that could be realized on disposition of the financial instruments.

Investment Valuation and Income Recognition

Investments in mutual funds and stable value collective trusts are reported at fair value as determined by the Plan trustee. See **notes C, D & E** for further investment disclosures.

Contributions

The plan recognizes and records contributions at the time payment is received. Contributions under generally accepted accounting principles are recognized as a legal obligation to contribute when incurred.

Payment of Benefits

Benefits are recorded when paid.

Expense Recognition

Expenses are recognized and recorded at the time that payment is made. Expenses under generally accepted accounting principles are recognized as they are incurred.

Administrative Expenses

Trustee fees are generally paid by the Plan, while the Sponsor pays other costs of administering the Plan. Certain administrative and clerical functions are performed by the Company's employees at no charge to the Plan.

Forfeited Accounts

Forfeitures occur when participants terminate employment before becoming fully vested in employer contributions to the Plan. At **December 31, 2024** and **2023** forfeited non-vested accounts totaled **\$47,739** and **\$27,971**, respectively. Forfeited amounts may be used to reduce administrative expenses and then future employer contributions to the Plan. The amounts of forfeitures utilized to offset plan expenses for the years ended **December 31, 2024** and **2023** were **\$35,569** and **\$3,607**, respectively. The amounts of forfeitures utilized to offset employer contributions for the years ended **December 31, 2024** and **2023** were **\$-0-** and **\$-0-**, respectively.

Reclassifications

Certain accounts in the prior-year financial statements have been reclassified for comparative purposes to conform with the presentation in the current-year financial statements.

Subsequent Events

Management has evaluated subsequent events through **October 13, 2025**, the date on which the financial statements were available to be issued. No additional events occurred that would require adjustments to, or disclosures in the financial statements.

NOTE D – FAIR VALUE MEASUREMENTS OF INVESTMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

- Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
- a. Quoted prices for similar assets or liabilities in active markets
 - b. Quoted prices for identical or similar assets or liabilities in inactive markets
 - c. Inputs other than quoted prices that are observable for the asset or liability
 - d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs that are unobservable inputs for the asset or liability.

Stable Value Collective Trusts

A stable value fund that is composed primarily of synthetic and traditional guaranteed investment contracts that are valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require **12** months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Transfers Between Levels

For years ended **December 31, 2024** and **2023**, there were **no** transfers between Levels 1 and Level 2 and **no** transfers in or out of Level 3.

NOTE E – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE F – PARTIES-IN-INTEREST

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services for the Plan, and employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent of more of such employer or employee association, or relatives of such person. **Reliance Trust Company, ADP, Inc., Ancora Retirement Plan Advisors, Inc.** and **Merrill Lynch Pierce Fenner & Smith** are the service providers.

Reportable direct expenses on the 5500 were paid to **ADP, Inc.** for various recordkeeping administrative services amounted to **\$50,443** and **\$61,168** for **2024** and **2023**, respectively. Reportable indirect expenses on the 5500 were paid to **Ancora Retirement Plan Advisors, Inc.** for investment advisor services amounted to **\$507,200** and **\$135,134** for **2024** and **2023**, respectively. Reportable indirect expenses on the 5500 were also paid to **Merrill Lynch Pierce Fenner & Smith** for investment advisor services amounted to **\$-0-** and **\$135,134** for **2024** and **2023**, respectively.

Certain administration functions are performed by officers and employees of the Company (who also may be participants in the Plan) at no cost to the Plan. These transactions are not deemed prohibited party-in-interest transactions because they are covered by the statutory or administrative exceptions from the Internal Revenue Code's and ERISA's rules on prohibited transactions.
