Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Creative Options, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Creative Options, Inc. 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 

1. Description of Plan

The following description of the Creative Options, Inc. (the “Company”) 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

Creative Options, Inc. 401(k) Retirement Plan is a defined contribution salary deferral retirement plan which provides an individual account for each participant and provides benefits upon retirement based on amounts contributed by the employee and employer matching and discretionary contributions plus earnings on those contributions. The Plan was established on January 1, 2008. The Plan, as adopted, is considered to be a “safe harbor plan” since it includes certain provisions such that it is considered to be nondiscriminatory by design.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective January 1, 2012, the Safe Harbor computation period was amended from an annual basis to a payroll basis.

Participation

All employees of the Company are eligible to participate in the Plan, except for employees covered by a collective bargaining agreement, non-resident aliens, and leased employees. In order to be eligible to participate in the Plan, an employee must have completed one year of service with at least 1,000 hours of service during that year, and be at least twenty-one years old. The initial year of eligibility is calculated from the employee’s hire date. An employee becomes eligible to enter in the Plan on the first day of the Plan year or the first day of the seventh month of the Plan year after the age and service requirements are satisfied.

Contributions

Eligible participants may defer, either as pre-tax elective deferrals or Roth elective deferrals, amounts from 1% to 90% of their compensation not to exceed the limits of Internal Revenue Code (“IRC”) Sections 401(k), 402(g), 404 and 415, which were \$23,000 and \$22,500 for years ended December 31, 2024 and 2023, respectively. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans. The Company contributes a safe harbor matching contribution of 100% of the first 3% of a participant’s deferrals and 50% of the amount of deferrals between 3% and 5%. Thus, if a participant defers 5% or more of their eligible compensation, they would receive a 4% safe harbor matching contribution. The Company may also contribute an additional discretionary match at the end of the Plan year. Participants must be employed with the Company on the last day of the Plan year to be eligible for the discretionary contribution. For the years ended December 31, 2024 and 2023, total discretionary contributions made on behalf of

participants were \$175,236 and \$138,847, respectively. All participants over the age of 50 before the close of the Plan year are eligible to make catch-up contributions totaling \$7,500 per employee per year for 2024 and 2023, under IRC Sections 401(a)(30), 402(g) and 414(v). Participant and Company contributions are directed by the participants into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's matching and discretionary contributions, and Plan earnings. Allocations are based on participant earnings, deferrals or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may redirect their investments on the first day of each quarter of the Plan year.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are also immediately vested in the Company's safe harbor matching contributions which represent safe harbor matching contributions up to 4% of the participant's compensation. Any additional discretionary matching contributions are subject to the vesting schedule as noted in the Plan document. Vesting in the Company's discretionary contributions portion of a participant's account is based on years of service. Vesting service is the total of an employee's countable periods of service beginning on their hire date. The standard measure for one year of service is the completion of 1,000 hours during the Plan year. Failure to meet the requirement means that no vesting credit is given to the participant. Participants vest at a rate of twenty percent per year starting with year two. A participant is one hundred percent vested after six years of credited service and participation in the Plan. Any employer matching contributions and discretionary contributions which are not vested, other than safe harbor matching contributions as noted above, are forfeited upon termination. If a participant is re-employed prior to incurring five consecutive one year breaks in service and restores their vested balance, the amount forfeited will be restored to his or her account. If the participant does not return, the forfeitures are used to offset Plan expenses or future employer matching contributions.

Notwithstanding the above, a participant shall be fully vested in their entire account upon the attainment of age 65, death, disability or if the Plan is terminated.

Participant Loans

The Plan Document does not allow participants to borrow money from the Plan.

Payment of Benefits

Upon termination of service, death, disability, or retirement at age 65, such participant or their beneficiary may elect to receive their individual account in a single lump-sum payment, partial payments or a direct rollover to a qualified retirement account. If the participant's vested account balance is less than \$1,000, then the participant or their beneficiary will receive a lump-sum distribution.

A terminated or retired participant may elect to receive payment from their account soon after it is valued or postpone payment until a later date. If payment is postponed, the account will continue to share in investment earnings. However, payment must start on April 1 of the year after the participant reaches required minimum distribution age as set forth by the Internal Revenue Service, even if they are still working. The required minimum distribution age is 70 ½ if that age is reached on or before December 31, 2020, 72 if reached between January 1, 2021 and December 31, 2023, and 73 if reached on or after January 1, 2024. Hardship withdrawals are permitted if certain criteria are met.

Upon the death of a participant before retirement or termination of employment, the current balance of such participant's individual account shall become payable as of the valuation date coincident with or next following the participant's death.

Forfeited Accounts

The balance of non-vested forfeited accounts was \$1,898 and \$1,804 at December 31, 2024 and 2023, respectively. The Plan allows forfeitures to be used to offset Plan expenses or future employer matching contributions. Forfeitures of \$6,075 and \$1,753 were used to reduce employer contributions during 2024 and 2023, respectively. Forfeitures of \$-0- and \$-0- were used to pay Plan administrative fees during 2024 and 2023, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by investment advisors, custodians and the insurance company. See Note 4 for discussion of fair value of investments. Income is recognized using a daily valuation method based on the daily changes in the market value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's realized gains and losses on investments bought and sold during the year as well as unrealized gains and losses on the investments held at year end.

Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. Plan participants incurred direct administrative expenses of \$28,594 and \$26,395 during the years ended December 31, 2024 and 2023, respectively.

Funding Policy

Contributions are funded as accrued.

Payments of Benefits

Benefit payments are recorded when paid.

3. Certified Information

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to certain information certified by Reliance Trust Company, except for comparing such information certified by the trustees to information included in the Plan's financial statements and supplemental schedule.

4. Fair Value Measurements

In accordance with generally accepted accounting principles, the Plan has adopted the provisions which establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodology used for assets measured at fair value.

Mutual funds: The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered actively traded.

5. Rollover Contributions

Rollover contributions are contributions to the plan resulting from a distribution received from another qualified plan. Rollover contributions are 100% vested and are not subject to forfeiture for any reason. A total of \$-0- and \$26,847 was rolled into the plan during the years ended December 31, 2024 and 2023, respectively, and is included in rollovers on the statements of changes in net assets available for benefits.

6. Related Party Transactions / Party-In-Interest Transactions

The Company sponsors the Plan. Personnel within the employer organization perform certain administrative services for the Plan, including maintenance of participant records. The payroll and related overhead costs associated with these services are not included as Plan expenses. Expenses for the audit and outside administration services are paid directly by the Plan Sponsor. Certain administrative processing and transaction fees may be paid by the Plan. Certain Plan expenses were paid to the third-party administrator and, therefore, these transactions qualify as party-in-interest transactions. The trustee also receives indirect compensation from various mutual funds held by the Plan. Such indirect compensation is netted in the investment income reported in the accompanying statements of changes in net assets available for benefits.

7. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

8. Tax Status

The prototype for this Plan obtained its latest opinion letter on March 31, 2014 in which the Internal Revenue Service stated that the prototype Plan was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since the prototype received its opinion letter. However, the Plan Sponsor and Administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is subject to income tax examinations by tax authorities for the current year and the last three years.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with such investments, and the level of uncertainty related to changes in the value of such investments, it is at least reasonably possible that changes in risk in the near-term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. Plan assets are not FDIC insured.

10. Subsequent Events

Subsequent events were evaluated through October 7, 2025, the date the financial statements were available to be issued. There were no subsequent events requiring disclosure.
