INDEPENDENT AUDITORS' REPORT

To Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Equity Settlement Services, Inc. 401 (K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Equity Settlement Services, Inc. 401 (K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. NOTE 1—DESCRIPTION OF PLAN

The following brief description of the Equity Settlement Services, Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution plan qualifying under Section 401(k) of the Internal Revenue Code ("IRC") covering all employees of Equity Settlement Services, Inc. (the "Employer") and its affiliates, Puleo Delisle LLC and GDV Abstract, LLC that are not covered by a collective bargaining agreement, with no minimum age or service requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility

An employee of the Employer becomes an eligible participant in the Plan immediately upon hire. The Plan excludes employees covered by a collective bargaining agreement. Participants' entry dates for the Plan are the first pay period in the month after hiring. Employees are automatically enrolled in the Plan upon hire, with a four percent elective deferral rate unless they choose not to participate.

Participant Contributions

A participant in the Plan may annually contribute through payroll deductions, contributions up to an annual maximum of 86 percent of eligible compensation as defined in the Plan, subject to Internal Revenue Service ("IRS") limitations. Roth elective deferrals are also permitted under the Plan. Participants may also transfer in amounts representing distributions from other qualified plans. Any participant, age 50 or over, may make an additional "catch-up" contribution as determined by the IRS. Participants direct the investment of the contributions into various investment options offered by the Plan. A participant may suspend contributions or increase or decrease their level of participation at any time.

Employer Contributions

Effective April 1, 2010, Employer matching and non-elective contributions are no longer allowed under the Plan.

Participant Accounts

Individual accounts are established for each participant. The Plan offers a variety of mutual funds and a common collective trust as investment options. Each participant's account is credited with the participant's pre-tax contributions and the proportionate share of dividends, interest and investment gains since the preceding valuation date. The participant's account is reduced by withdrawals, losses on investments and any forfeitures. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

All the Employer's matching and non-elective contributions received prior to April 1, 2010 are 100 percent vested after the completion of six years of continuous service based upon the following schedule:

A participant's "vested percentage" is based on vesting years of service. A participant earns and accumulates a year of vesting for each Plan year that he or she earns 190 hours of service for each month, as defined in the Plan. A participant is always 100 percent vested in his or her own deferred salary contribution to the Plan, but with respect to the Employer contributions, any unvested portion of his or her account shall be forfeited at termination.

Retirement Benefits

All participants are eligible to retire with their fully vested retirement benefit on the later of the following:

- Attainment of age 65
- Completion of 6 years of participation

There is no early retirement option under the Plan.

Participants may choose to have their benefits distributed to them in one of the following ways:

- In a lump-sum payment of cash
- By the purchase of a non-transferable annuity
- If the participant fails to elect a form of distribution and whose entire vested account balance (excluding outstanding loan balances) is above \$1,000, his/her entire vested account balance will be rolled over directly to an E*Trade IRA. If the participant's entire vested account balance (excluding outstanding loan balances) is less than or equal to \$1,000, however, the entire vested account balance will be made payable to the participant in the form of a cash lump sum.

Death Benefits

The beneficiary of any participant with vested benefits in the Plan is entitled to 100 percent of such benefits. Death benefits may be distributed in one of the following ways:

- In a lump-sum payment (as defined in the Plan agreement) payable no later than five years after date of the participant's death;
- As an annuity payable over the lifetime of a designated beneficiary with distribution of the death benefit commencing no later than one year after the date of the participant's death; or
- As an annuity payable to the employee's surviving spouse (as a designated beneficiary) over the spouse's lifetime with distribution of the death benefit commencing no later than the date the employee would have attained 70-1/2 years of age.

Withdrawals are also permitted in the instance of disability, in accordance with the Plan document.

Notes Receivable From Participants

The Plan allows for loans to be extended to participants for financial hardship or financial needs. All loans are considered a direct investment of the participant and payments of principal and interest are credited to the participant's account. The minimum a participant may borrow is \$1,000 and the maximum, including the outstanding balance of existing Plan loans, is 50 percent of their vested account balance, not to exceed \$50,000. The loans bear interest at rates ranging from 5.25 to 10.50 percent with maturities through July 2029. Principal and interest are paid ratably through biweekly payroll deductions, generally over periods not exceeding sixty months.

NOTE 2—SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accounting records of the Plan are prepared under the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements are discussed in the Investments note.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Investment contracts are required to be recorded at fair value, except for fully benefit responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit responsive contracts because contract value is the amounts participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Administrative Services

The expenses necessary to administer the Plan, including but not limited to, retaining necessary professional assistance from an attorney, an accountant, or an actuary are either paid by the Employer, or incurred by the Plan and allocated to each participant at the Employer's option. All other expenses including but not limited to, investment advisor fees, account maintenance fees, transaction fees and investment fund management fees, have been paid by the Plan. Participants are charged service fees for any loan and distribution transactions they request. Certain fees assessed by investment fund managers have been offset against net investment income. For the year ended December 31, 2024, the Plan paid administrator fees of \$2,418.

Payment of Benefits

Benefits are recorded when paid.

Forfeited Accounts

At December 31, 2024 and 2023, the Plan had \$8,413 and \$8,066, respectively, of forfeited, non-vested accounts. Forfeitures can be used to pay administrative expenses, at the request of the Employer. For the year ended December 31, 2024, \$170 was used from the forfeiture account.

NOTE 2—SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Excess Contribution Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. For 2024 excess contributions to distribute to the participants prior to March 15, 2025 was \$3,271 of which only \$2,632 was distributed timely. The remaining \$639 was distributed after March 15, 2025. Excess contributions for 2023 was \$8,060.

Fair Value Measurements

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Unobservable inputs that are supported by little or no market activity and that are financial instruments whose values are determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant judgment or estimation.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Fair Value Measurements (continued)

The following is a description of the valuation methodologies used for the Plan's assets. There have been no changes in the methodologies used for periods presented in these financial statements.

Mutual Funds: Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

Other Valuation Methods

Common/Collective Trust: Contract values of the common/collective trust represent contributions made under the contract, plus earnings, less Plan withdrawals and administrative expenses. The units of common collective trusts are stated at contract value in the statement of net assets available for benefits. The underlying guaranteed investment contract is fully benefit responsive, therefore, contract value is the relevant measurement attribute. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their contract value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4—COMMON/COLLECTIVE TRUST

The Plan invests in the Invesco Stable Asset Fund which is a stable value pooled fund of common/collective trusts that invests in guaranteed investment contract. The crediting interest rate is based on the level of market interest rates, the amount and timing of participant contributions, transfers, and withdrawals, investment returns, and the duration of the underlying fixed income investments. The interest crediting rate cannot be less than zero and is typically reset on a monthly or quarterly basis.

This investment contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 4 percent. The crediting rate is reviewed on a quarterly bases for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the internal Revenue Code or failure of the trust to be tax-exempt under section 501(a) of the Internal Revenue Code.
2. Premature termination of the contract.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such event include the following:

1. An uncured violation of the Plan’s investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without consent of the issuer.

NOTE 5—INFORMATION CERTIFIED BY CUSTODIAN

No auditing procedures were performed by the independent public accountants as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA with respect to information certified as complete and accurate by the custodian, except for comparing such information with the information reported in the financial statements. Based on information provided and certified by the custodian, there are no fixed income obligations, leases, or debt instruments in default or deemed uncollectible, as defined by ERISA, for the years ended December 31, 2024 and 2023.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).

NOTE 6—PLAN TERMINATION

The Employer intends to continue the Plan indefinitely for the benefit of its employees, but reserves the right to modify, amend, or terminate the Plan at any time. In the event of termination of the Plan, all amounts credited to participants' accounts shall be 100 percent vested and non-forfeitable. All participants shall receive a total distribution of their accounts as described in the Plan. Any amount in the forfeiture account upon termination shall be allocated on a pro rata basis to the participants' accounts.

NOTE 7—INCOME TAX STATUS

The Plan adopted a prototype non-standardized profit sharing 401(k) plan. By letter dated March 31, 2008, the Internal Revenue Service ("IRS") has determined that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving this opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. In addition, there are no tax related interest or penalties for the periods presented in these financial statements.

NOTE 8—RELATED PARTY TRANSACTIONS

The Plan has an investment in a common collective trust that is managed by the custodian of the Plan. These transactions qualify as party-in-interest transactions. In addition, the Plan has certain investment related expenses, which have been offset by net investment income.

NOTE 9—REFUND OF EXCESS CONTRIBUTIONS

The Plan failed the IRC 401(k) Actual Deferral Percentage ("ADP") compliance test of employee contributions for the year ended December 31, 2024 and December 31, 2023. The Plan corrected the ADP test failure by returning the excess contributions to the highly compensated employees in the following year. The refund included income allocable to the excess contributions. As of December 31, 2024 and 2023, the excess contributions payable to the participants in the following year were \$3,271 and \$8,060, respectively.
