NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

This summary of significant accounting policies of the Arcadia Management, Inc. 401(k) Plan (the "Plan") is presented to assist in understanding the Plan's financial statements and supplemental information. These financial statements, supplemental information, and notes are representations of Arcadia Management, Inc.'s (hereinafter, the "Employer" or the "Plan Sponsor") management, which is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to accounting principles generally accepted in the United States of America, and have been consistently applied in the preparation of the financial statements and supplemental schedule.

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in registered investment companies and common collective trust funds are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 3 and 4 for a further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year. During the year ended December 31, 2024, the Plan's investment gains (including gains and losses on investments bought and sold, as well as held during the year) were \$400,436.

Participant Notes Receivable

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid to the Plan's participants.

Events Occurring After Report Date

The Plan Sponsor evaluated events and transactions that occurred between January 1, 2025 and October 3, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements.

NOTE 2 - DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, restated effective September 1, 2021, was established to provide deferred compensation and profit sharing benefits to employees of the Plan Sponsor. The Plan is registered with the Internal Revenue Service ("IRS") as a prototype, non-standardized, profit sharing plan with a cash or deferred arrangement.

The Plan is a defined contribution plan covering all employees of the Plan Sponsor who have completed three months of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Reliance Trust Company ("RTC") served as the Plan Custodian of the Plan assets for the years ended December 31, 2024 and 2023. The Plan Sponsor uses Automatic Data Processing ("ADP") for its administrative and recordkeeping services.

Contributions

Each year, participants may contribute to the Plan a percentage of compensation, as defined, or in specific dollar amount. Employees may elect to defer a maximum amount not to exceed the annual thresholds established by the IRS. Participants who attained age 50 by the end of the Plan year were eligible to make catch-up contributions. Participants may also contribute amounts distributed from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Contributions are subject to certain limitations.

Automatically enrolled participants have their deferral rates set initially at 1% of eligible compensation and their contributions are invested in a balanced fund until changed by the participant. Unless the participant elects to change the deferral rate, the rate is increased by 1% annually up to a maximum of 5%.

The Plan provides for employer matching contributions at the discretion of the Plan Sponsor. Employees who are participating in the Plan are eligible to receive discretionary matching contributions. Effective September 1, 2021, the Plan Sponsor matched 25% of a participant's elective deferrals, not to exceed 100% of a participant's eligible compensation. During the year ended December 31, 2024, the Plan Sponsor contributed \$161,516 into the Plan.

Additional amounts may be contributed at the option of the Plan Sponsor. Employees share in such contributions if they are eligible and employed on the last day of the Plan year. The Plan Sponsor elected not to make additional contributions to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, an allocation of the Plan Sponsor's contribution, the Plan's earnings, and forfeitures of terminated participants' non-vested accounts, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Plan Sponsor contributions are vested in accordance with the following schedule:

Notes Receivable from Participants

The Plan provides for participant loans at a minimum of \$1,000 to a maximum of the lesser of \$50,000 or 50% of a participant's account balance. The loans are secured by the balances in the participants' accounts and bear interest at rates ranging between 5.25% and 10.50%, which are commensurate with local prevailing rates as determined by the plan administrator at the time the loans were taken. Loans are repaid over a period selected by the participant, which extends no longer than five years, or fifteen years if loan proceeds were for the purchase of a principal residence. Principal and interest are repaid ratably through payroll deductions.

Deemed Distributions

When a participant fails to make loan repayments under the terms of the loan agreement, the loan is considered to be in default. A loan in default is considered a distribution from the Plan (deemed distribution) that could result in taxable income to the participant. For the year ended December 31, 2024, there was one loan in default that resulted in deemed distributions of \$299.

In-Service Withdrawals

In-service or hardship withdrawals are permitted by the Plan.

Payment of Benefits

Participants will reach the Plan's normal retirement age at the later of age sixty-five or the fifth anniversary of the first Plan year in which the employee became a participant. At the normal retirement age, participants will be entitled to one hundred percent of their vested account balances, but benefits may be deferred if the participants so elect. Participants are entitled to one hundred percent of their vested account balances upon separation of employment and their estates are entitled to one hundred percent of the decedents' vested account balances upon death. If a participant terminates with a vested account balance that does not exceed \$7,000 and did not consent to a distribution, the participant's account will be distributed into a rollover IRA to be established by the record-keeper on the participant's behalf.

Forfeitures

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account represents a forfeiture. There were new forfeitures of \$10,246 during 2024. Forfeitures are applied against any employer discretionary contributions made during the Plan year. During the year ended December 31, 2024, \$10,262 of forfeitures were used to offset employer matching contributions. The forfeiture balance at December 31, 2024 and 2023 was \$44 and \$60, respectively.

NOTE 2 - DESCRIPTION OF THE PLAN *(continued)*

Administrative Expenses

The Plan pays for all investment-related expenses, while the Plan Sponsor pays for all other costs of maintaining and administering the Plan.

Plan Amendments

The Plan Sponsor has the right under the Plan to amend the Plan at any time. The Plan was last amended during the 2022 Plan year to comply with legislative and regulatory changes set forth in IRS Notice 2017-37.

In January 2020, Congress passed the Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE Act"). Many of the provisions of the SECURE Act are effective on January 1, 2020 and will require significant changes to plan administration and recordkeeping. The Plan has adopted mandatory and certain voluntary provisions of the SECURE 2.0 Act of 2022. Formal amendments to the Plan are due by the end of the year ending December 31, 2026.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become one hundred percent vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Plan Sponsor may determine.

NOTE 3 - FAIR VALUE MEASUREMENTS

The Plan Sponsor utilizes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

- If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset and liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024.

Mutual Funds (Registered Investment Companies): Valued at the net asset value ("NAV") of shares held by the Plan at year-end. The NAV is based upon quoted market prices.

Common/Collective Trusts: Valued at the NAV of units held by the Plan at year-end. The NAV is determined by the Custodian of the fund and is based upon the fair value of the underlying assets held by the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (a) Index Fund: The investment objective of the fund is to approximate as closely as practicable, before expenses, the performance of the S&P 500 Index over the long term, while providing participants the ability to purchase and redeem units on an “as of” basis.

- (b) Stable Asset Value Fund: The primary investment objective of the fund is to seek the preservation of principal and to provide interest income reasonably obtained under prevailing market conditions and rates, consistent with seeking to maintain required liquidity.

NOTE 5 - TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain Plan investments are managed by the Custodian and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included as part of net appreciation in fair value of investments.

NOTE 6 - TAX STATUS

The Plan Sponsor adopted a prototype, non-standardized; profit sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service dated October 6, 2020, which states that the Plan is designed in accordance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America requires the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor and Internal Revenue Service.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 - RISKS AND UNCERTAINTIES
