ADIRONDACK SCENIC INC. PROFIT SHARING 401(k) PLAN

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Adirondack Scenic Inc. Profit Sharing 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Adirondack Scenic Inc. (the "Company" or "Employer") who have three months of service and attained the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Employees may elect to defer up to 100% of their eligible compensation subject to certain Internal Revenue Code limitations. Participants have the option to treat deferrals as Roth deferrals rather than pre-tax deferrals. Participants are permitted to make contributions representing distributions from other qualified benefit or defined contribution plans (rollovers). Participants who have attained the age of fifty before the end of the Plan year are eligible to make catch-up contributions.

Participants may diversify their employee elective deferrals, rollovers and employer contributions into investments available under the Plan. Contributions are automatically invested in a designated mutual fund until changed by the participant. Participants direct the investments of employer and employee contributions into various investment options offered by the Plan.

The amount of the employer contributions for the profit sharing portion of the Plan and employer matching contributions for the 401(k) portion of the Plan are discretionary and are determined annually by the management of the Company. Participants meeting eligibility requirements that are employed on the last day of the Plan year are eligible to receive employer contributions. Participants share in employer contributions regardless of the amount of service in the year of death, disability or termination of employment on or after normal retirement age. For the years ended December 31, 2024 and 2023, the Company's profit sharing contribution and employer matching contribution was \$0.

Participant Accounts

Each participant's account is credited with the participant's contributions, along with an allocation of (a) the Company's contribution and, (b) Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances in accordance with terms of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and employer contributions plus actual earnings thereon.

Investment Options

The plan currently offers thirty-seven (37) mutual funds and one money market fund through a regulated investment company. Participants may change their investment options and transfer funds amongst investments daily.

1. DESCRIPTION OF PLAN (Continued)

Notes receivable from Participants

Participants may borrow from their accounts a minimum amount of at least \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50 percent of their account balance. Generally, loan terms range from several months to 5 years. If the loan is used to purchase a primary residence, the loan may be repaid over a reasonable period of time that may be longer than 5 years. Participants are permitted two outstanding loans. The notes are secured by the participant's account balance and bear interest at a reasonable rate, commensurate with prevailing rates as determined at the time of granting the note by the plan administrator. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Distributions from the Plan will be made upon termination of employment, retirement, death (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), disability, or under prescribed circumstances in the event of financial hardship. Distributions are made in cash in an amount equal to the value of the participant's account in either a lump sum amount or partial withdrawal. Termination distributions of account balances greater than \$5,000 may be deferred to a later date. Participants are permitted to take hardship distributions from pre-tax deferral and Roth accounts only. In-service distributions may be made upon reaching the normal retirement age.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a distribution based on the terms of the Plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as excess contributions payable, with a corresponding reduction to contributions received from participants.

Payment of Benefits

Benefits to terminated participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Administrative expenses of the Plan are allocated to participant accounts.

Financial Instruments Measured at Fair Value

The Plan has financial instruments which are recorded at fair value in the accompanying statements of net assets available for benefits. The Plan makes estimates regarding the valuation of assets and liabilities measured at fair value in the financial statements. These assets and liabilities include the investments in mutual funds and a money market fund.

Fair Value Measurement - Definition and Hierarchy

The Plan uses various valuation techniques in determining fair value and classifies investments measured at fair value into a three level hierarchy based on the nature of the inputs. Level 1 valuations are based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Level 2 valuations are based on inputs, other than quoted prices included within Level 1 that are observable either directly or indirectly. Level 3 valuations are based on inputs that are unobservable and significant to the overall fair value measurement. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Fund: Valued based on quoted prices in active markets.

Mutual Funds: Valued at the net asset value of shares held at year end based on quoted market prices.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PARTY-IN-INTEREST TRANSACTIONS

The Plan's assets include certain investments in funds managed by Glens Falls National Bank and Trust Company, the trustee, as defined by the Plan. The Plan also allows current employees who are participants to receive loans under specific circumstances. As such, transactions between the participants that have notes receivables to the Plan qualify as party-in-interest transactions.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. INCOME TAX STATUS

The Plan is tax-exempt under Section 401(a) of the Internal Revenue Code. A prototype document was used by the Plan to obtain its latest opinion letter on June 30, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

8. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.
