Independent Auditor's Report

To the Board of Trustees
Vacation Internationale, Inc. 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Vacation Internationale, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Benefits for the year end December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

1. DESCRIPTION OF PLAN

The following description of the Vacation Internationale, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

a. General

The Plan, established in July 2004, is a qualified defined contribution plan covering substantially all employees of Vacation Internationale, Inc. (the Company). The Company is also the plan sponsor and plan administrator.

The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA).

b. Eligibility

Employees are eligible to participate in the Plan and receive any employer contributions on the first day of each calendar month after completing six months of service (one month credited for one hour of service in the month).

c. Contributions

Participants may contribute up to 88% of their compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Effective October 11, 2023, the Plan was amended to allow participants to make Roth contributions (after-tax contributions).

Upon meeting the eligibility requirements, employees are automatically enrolled into the Plan at a pretax deferral rate of 4% of their gross compensation each pay period. Employees may choose to opt out of Plan participation.

The Company, at its discretion, may make employer matching and profit-sharing contributions to the Plan. During 2024, the employer matching contributions were 50% of salary deferrals up to the first 4% of plan compensation. There were no profit-sharing contributions for the year ended December 31, 2024.

Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. Participants may change their investment elections as often as permitted under the investment vehicles they choose.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

1. DESCRIPTION OF PLAN, (Continued)

d. Participant accounts

Each participant's account is credited with the participant's salary deferral contributions, discretionary employer matching contributions, discretionary profit-sharing contributions, as well as an allocation of plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined in the plan. Discretionary profit-sharing contributions, if any, are allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

e. Vesting

Participants are immediately vested in their salary deferral contributions plus actual earnings or losses thereon. Vesting in all employer contributions is based on years of service, as follows:

<u>Years of Service</u>	<u>Vesting %</u>
Less than 1	0%
1 but less than 2	25%
2 but less than 3	50%
3 but less than 4	75%
4 or more	100%

Upon death, disability or reaching normal retirement age (65), participants become fully vested in all account balances.

f. Notes receivable from participants

Participants may borrow from their account balance a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms can be up to five years except loans used to purchase a primary residence can be for up to thirty years. The loans are secured by the balance in the participant's account and bear interest at prime plus 2%. As of December 31, 2024, the rate of interest on outstanding loans ranged between 5.25% to 10.50%. The Plan requires repayment of the loan obligation through payroll deductions; however, the participant may repay the loan at any time.

g. Payment of benefits

Payment of benefits will be paid to the participants or participant's beneficiary upon termination of service, death, disability, or retirement.

1. DESCRIPTION OF PLAN, (Continued)

g. Payment of benefits, (Continued)

If the participant's account balance is over \$7,000, then the participant must consent to the distribution before it may be made, and may elect to receive the distribution under one of the following methods:

- A single lump-sum payment in cash.
- A direct rollover to an IRA or other eligible retirement plan.

If the participant's account balance is under \$7,000, then the distribution will be made as soon as administratively practicable after the participant leaves the Company. Distributions will be automatically made in a lump sum cash payment regardless of whether the participant consents to receive it.

In-service lump sum distributions are available to any participant who has reached age 59 ½.

Participants may also withdraw funds from their account in the event of financial hardships as defined in the Plan document.

h. Forfeited accounts

Forfeitures of terminated participants' nonvested accounts are maintained in a separate account under the Plan. Under the terms of the Plan, forfeitures that arise in any given plan year may be used toward the Plan's expenses or any employer contributions. Unallocated forfeitures of terminated participants' nonvested accounts totaled \$5,775 and \$6,028 at December 31, 2024 and 2023, respectively. During 2024, forfeitures in the amount of \$14,133 were used to reduce employer matching contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

a. Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

b. Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, (Continued)

c. Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's oversight committee determines the Plan's valuation policies utilizing information provided by the investment adviser and custodian. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

e. Payment of benefits

Benefits are recorded when paid.

f. Administrative expenses

Certain administrative expenses are paid directly by the Company and are excluded from these financial statements. Administrative expenses not paid by the Company are charged to participants' accounts and apportioned based upon their relative account values. Transaction based fees are charged directly to the participant's accounts. Investment related expenses are included in the net appreciation of fair value of investments.

g. Date of the Plan's review

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

3. CUSTODIAN CERTIFICATIONS UNDER ERISA SECTION 103(a)(3)(C)

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the auditors' examination did not extend to the following information certified by Reliance Trust Company, the custodian, as complete and accurate:

- Investments
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

4. FAIR VALUE MEASUREMENTS, (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. PARTY-IN-INTEREST TRANSACTIONS

Plan investments are held by Reliance Trust Company, the Plan custodian. Transactions with the custodian are recognized as exempt party-in-interest transactions under ERISA.

For the year ending December 31, 2024, the Plan paid \$16,910 for certain expenses related to plan operations to various service providers. These expenses are recognized as exempt party-in-interest transactions under ERISA.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

7. TAX STATUS

The Plan utilizes a non-standardized profit-sharing plan that received a favorable opinion letter from the IRS dated October 6, 2020, which stated that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

7. TAX STATUS, (Continued)

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any taxing periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Benefits.
