Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Prudential Lighting Union Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 DESCRIPTION OF THE PLAN

The following description of the Prudential Lighting Union Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan covering all eligible employees of Prudential Lighting Corporation (the Company) who have completed three months of service and have attained the age of 18. The Plan excludes all nonunion employees, nonresident aliens, and residents of Puerto Rico. The Plan entry date is on the first day of the month following the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Board of Directors is responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Directors.

Eligibility

Employees are eligible to participate in the Plan and may begin making contributions to the Plan as soon as administratively feasible following the first day of the month following the eligibility requirements.

If a terminated employee is re-employed by the Company, such employee will immediately become a participant in the Plan on the next entry date following the employee's rehire. If an employee is terminated before satisfying the Plan's eligibility requirements, and is later rehired, the employee must satisfy the Plan's eligibility requirements before participating in the Plan.

Contributions

Participants may elect to contribute an amount ranging from 1.00% to 80.00% of their compensation, as defined in the Plan, subject to Internal Revenue Service limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may make contributions as either pre-tax contributions, after-tax (Roth) contributions, or a combination of both. The maximum a participant can contribute to the Plan during 2024 is \$23,000, with the catch-up limit being \$7,500.

Participants may also contribute amounts representing distributions (roll-over contributions) for other qualified benefit plans.

Participants may change their contribution percentages at their own discretion. Such contribution percentage changes shall become effective as soon as administratively possible following the receipt of the change request by the recordkeeper.

The Company may annually, at its sole discretion, elect to make an employer contribution for any Plan year, and any such employer contribution shall be calculated based upon a participant's service hours completed during the Plan year.

Contributions (Continued)

Participants direct the investment of all contributions to their account into various investment options offered by the Plan.

Unless a participant makes an affirmative election, the Plan provides for an automatic enrollment feature resulting in an automatic deferral amount of 1% of compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions and employer's contribution, plus any Plan earnings. Forfeited balances of terminated participants' nonvested accounts can be used to reduce employer contributions, or to pay Plan expenses.

Allocations are based on participants' earnings. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

The participants' vested accounts for any employer contributions is based on years of service. A participant is 100% vested in employer contributions plus Plan earnings after six years of credited service, death, disability, or upon attainment of normal retirement age. A participant is fully vested in employee contributions, including roll-over contributions.

Vesting in the Company's contribution portion of their accounts is based upon years of continuous service. Should a participant leave and be rehired within 12 months, the period of absence will be included in determining a participant's years of service for vesting purposes. If a participant is in qualified military service, the military service will be considered service for vesting purposes.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested accounts balance. The \$50,000 amount is reduced by the highest outstanding loan balance the participant had during the previous one year period. The loan(s) are secured by the balance in the participant's account. The maximum length of a promissory note is 30 years for a primary residence note, or five years for all other notes. The loan interest rate is the rate in effect in the month your loan is effective. The interest rate is the prime rate published in *The Wall Street Journal* on the 14th of each month plus two percentage points. Notes receivable from participants interest rates varied from 5.25% to 10.50%. Principal and interest are paid ratably through weekly payroll deductions.

Should a participant enter into a period of military leave, the note receivable payments will be suspended during the military leave. Should a participant enter into a leave of absence without pay, or at a rate of pay that is less than the required note installments, the note payment obligation will be suspended for up to one year. If note payments do not resume during this grace period, the note will be in default, and will be deemed a participant distribution.

NOTE 1 DESCRIPTION OF THE PLAN (CONTINUED)

Payment of Benefits

Upon termination of service due to death, disability, retirement, termination of employment, or financial hardship, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, in annual installments, or an annuity. Additionally, participants who have reached age 59½ have the option of withdrawing all or part of their nonforfeitable account balance at any time.

Plan Administrative Costs

All significant costs of administering the Plan are paid by the Plan.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to any of the available investment options.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investments

Investments held by a defined contribution plan are required to be reported at fair value.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Contributions

Contributions from participants are recorded in the year in which the employee contributions are withheld from compensation. Employer contributions are recorded in the year in which the employee was paid for hours worked used to calculate the employer contribution.

Benefit Payments

Benefit payments are recorded when paid.

Plan Termination

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Tax Status

The Internal Revenue Service has determined and informed the Company by letter dated October 6, 2020, that the Plan is qualified and the trust established under the Plan is tax-exempt, under the appropriate sections of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Forfeitures

A participant's forfeiture of their nonvested account balance from employer contributions occurs when a participant is terminated. For the years ended December 31, 2024 and 2023, the balance of forfeitures was \$28,958 and \$11,141, respectively. Forfeitures are used to reduce employer contributions or to pay Plan expenses.

Subsequent Events

Subsequent events have been evaluated through October 9, 2025, the date the financial statements were available to be issued.

NOTE 3 INVESTMENTS HELD WITH TRUST COMPANY

Reliance Trust Company (qualified institution) has supplied the Plan administrator with certifications as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of the year) as of December 31, 2024.

NOTE 4 FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board (FASB) Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The valuation methodologies used for assets at fair value for Levels 1, 2, and 3 are as follows:

Level 1 – Pricing inputs represent quoted prices in active markets for identical assets or liabilities. The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year end.

Level 2 – Pricing inputs represent quoted prices of similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable, either directly or indirectly, or can be corroborated by observable market data for substantially the full term of the asset or liability.

Level 3 – Pricing inputs are unobservable for the investment; that is, inputs reflect the reporting entity's own assumptions about the assumptions market participants would use in pricing the asset or liability. The Plan has no Level 3 investments.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts – Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair values and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed in various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PARTY-IN-INTEREST TRANSACTIONS

Reliance Trust Company is the trustee as defined by the Plan. Fees incurred by the Plan for investment advising and consulting, are included in net appreciation in fair value of the investments. SageView Advisory Group, LLC is the Plan's investment advisor and has a fiduciary responsibility to the Plan; therefore, these transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
