**Note 1 - Description of Plan**

The following description of the Range Media Partners LLC 401(k) (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan, established on January 1, 2020, and most recently restated and amended December 1, 2024, is a defined contribution plan covering all eligible employees, as defined, of Range Media Partners LLC and participating employer, Range Music Partners LLC (collectively the Company or Employer or Plan Sponsor). Employees are able to participate in the Plan on the first day of the month coinciding with or next following their date of hire. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Participants may contribute either pre-tax deferrals or after-tax Roth deferrals up to 90% of their eligible annual compensation, as defined in the Plan agreement, up to a certain statutory maximum, which is set by law each year. The Plan allows for certain additional catch-up contributions for employees who have attained age 50 before the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Effective December 1, 2024, the Plan was amended to allow participants to elect after-tax voluntary employee contributions and also permit in-Plan Roth conversions at a minimum of \$500 from 100% vested accounts. The Company may also, at its discretion, elect to make a profit-sharing contribution to the Plan each year. A participant must be employed on the last day of the Plan year to be eligible to receive an allocation of the Company's discretionary profit-sharing contribution. A participant may also be eligible for discretionary profit-sharing contributions if, during any time of the Plan year, the participant dies, becomes disabled, or terminates employment as a result of attainment of normal retirement age, as defined. The Company did not elect to make a discretionary profit-sharing contribution for the year ended December 31, 2024, however employer funds were erroneously deposited into the Plan and reported as Due to Plan Sponsor in the statements of net assets available for benefits.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, allocations of Company discretionary profit-sharing contributions, and the Plan's earnings and is charged with benefits payments and an allocation of the Plan's losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. Participant transaction fees are charged directly to the accounts of the participants who incur those fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options**

Participants direct the investment of their accounts into various options offered by the Plan. Participants may change their investments periodically, as permitted by the Plan sponsor.

**Vesting**

Participants are immediately vested in their elective contributions, rollover contributions, and Company discretionary profit-sharing contributions, plus actual earnings thereon.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of a participant's vested account balance. Participants may have a maximum of two loans outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. The period for loan repayment cannot exceed five years from the date of the loan unless it was used to purchase a principal residence, in which case it may not exceed 30 years. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

Upon termination of service due to death, disability, retirement, or termination of employment, a participant with a vested balance greater than \$7,000 may receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, a series of installments over time, or partial withdrawals of at least \$500. If the amount of the participant's vested balance is \$7,000 or less, excluding rollover contributions, the Plan will automatically distribute the vested balance in a lump-sum payment. Participants attaining the age of 59 ½ may request an in-service distribution from their vested account balance at a minimum of \$500. Hardship withdrawals may be requested at a minimum amount of \$500 and are paid in one lump-sum upon approval.

**Administrative Expenses**

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan agreement. Expenses that are paid by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan are included in administrative expenses and certain investment-related expenses are included in net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits. Any costs associated with the investment of a participant's account are charged to that participant.

**Note 2 - Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded on an accrual basis. Net appreciation includes the Plan's gains and losses on investment bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participant's account balances. Delinquent notes receivable from participants are recorded as distributions based on terms of the Plan agreement.

**Payment of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued. No material events have occurred since December 31, 2024, that require recognition or disclosure in the financial statements.

**Note 3 - Information Certified by ADPRTS and Reliance Trust Company**

**Note 4 - Fair Value Measurements**

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification* No. 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include: (1) quoted market prices for similar assets or liabilities in active markets, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, and (4) inputs that are derived principally from, or corroborated by, observable market data by correlation of other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued as determined by quoted market price, which represents the net asset value of shares held by the Plan at year-end. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trust:* The Plan invests in the Invesco Stable Asset Fund (the Fund). The Fund invests 100% of its assets in Class C units of the Invesco Stable Value Trust, which is composed primarily of fully benefit-responsive synthetic guaranteed investment contracts. The Fund is valued at the net asset value (NAV) of units of the collective trust. The NAV, as provided by the issuer of the Fund, is based on the fair values of the underlying investments held by the fund less its liabilities and is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. The Plan is required to provide a 12-month irrevocable written notice of intent to redeem all or a portion of its participation in the Fund. There are no unfunded purchase commitments. The Fund files a U.S. Department of Labor Form 5500, Annual Return/Report of Employee Benefit Plan, as a direct filing entity. Accordingly, certain disclosure requirements under FASB Accounting Standards Update 2015-12 with respect to investment strategies for investments measured using the net asset value practical expedient are not required in this report.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value:

**Note 5 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 6 - Party-in-Interest Transactions**

During the year ended December 31, 2024, the Plan paid administrative expenses of \$1,145 to the Plan's recordkeeper. Notes receivable from participants also qualify as exempt party-in-interest transactions.

**Note 7 - Tax Status**

The Plan adopted a non-standardized defined contribution pre-approved plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020. The opinion letter stated that the Plan was designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the ruling. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will be fully vested in their accounts.
