Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of HCSS 401(k) Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of HCSS 401(k) Plan & Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

1. DESCRIPTION OF PLAN

The following brief description of the HCSS 401(k) Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan adopted by Heavy Construction System Specialists, LLC (the Company) and covers all eligible full-time and part-time employees of the Company who have attained age 21. Effective January 1, 2023, the Plan was amended to remove the minimum service requirement. Each eligible employee of the Company can become a participant in the Plan on the first day of the month following the date eligibility requirements have been met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

In recent years, the Plan has been amended to comply with the Heroes Earnings Assistance and Relief Tax (HEART) Act, the Worker, Retiree, and Employer Recovery Act (WREERA), and other Internal Revenue Service (IRS) and Department of Labor (DOL) guidance. The purpose of these changes was to comply with IRS and DOL regulations and maintain the Plan's tax exempt status.

Effective April 1, 2024, the Plan was amended to revise the vesting schedule applicable to employer contributions to provide for earlier vesting. The revised schedule applies to all participants. Effective June 1, 2024, the Plan was amended to increase the automatic enrollment deferral rate from 3% to 5%.

The Plan was restated October 1, 2018 to include the automatic deferral increase described in Contributions below.

Contributions

Participants may elect to contribute 1% to 87% of their eligible compensation, subject to IRS limitations for the Plan year. The Plan also permits rollover contributions from other qualified retirement plans. The Company may make a matching contribution to each participant's account based on the participant's deferral contribution. Matching contributions totaled \$2,203,556 for the year ended December 31, 2024. Participants direct the investment of contributions into a variety of investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated balance fund until changed by the participant.

Employee automatic contributions to the Plan are invested in a default investment fund and the automatic deferral amount will increase by 1% each year up to a maximum of 10%. These annual increases will occur as soon as administratively feasible following each anniversary date following the date that an employee's automatic enrollment begins.

The Company also offers a discretionary profit sharing contribution to eligible employees. The discretionary profit sharing contribution is determined annually by the Company. No discretionary profit sharing contributions were made for the year ended December 31, 2024. Total annual contributions made to the Plan on behalf of any participant are subject to limitations imposed under the Internal Revenue Code (IRC).

1. DESCRIPTION OF PLAN (continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's matching and discretionary profit sharing contributions, and Plan earnings, and charged with an allocation of administrative expenses. The Company's matching contributions are allocated based on participants' deferrals. Profit sharing contribution allocations are based on participant compensation or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service according to the following schedule:

<u>Years of service</u>	<u>Vested percentage</u>
1 year	25%
2 years	50%
3 years	100%

Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance, from a minimum of \$500 up to a maximum of \$50,000. Note terms shall not exceed five years unless the loan is for the purchase of a primary residence. Notes are secured by the balance in the participant's account and bear interest at a rate equal to the prime rate plus 2% at issuance. Principal and interest are paid ratably through payroll deductions. Interest income of \$31,615 for the year ended December 31, 2024 has been recorded as interest income in the accompanying Statement of Changes in Net Assets Available for Benefits.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or separation of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Lump sum distributions are required if the vested balance is \$5,000 or less. For accounts greater than \$5,000, the participant must consent to any distribution of their account. In-service distributions may be made from fully vested accounts if the participant has attained normal or early retirement age as defined within the Plan document.

Forfeitures

At December 31, 2024 and 2023, participant forfeitures totaled \$127,283 and \$69,631, respectively. The non-vested forfeited portion of these accounts is used to reduce future employer contributions. Forfeitures totaled \$127,283 for the year ended December 31, 2024 and employer contributions were reduced \$29,038 from forfeited non-vested accounts during the year ended December 31, 2024.

Administrative Expenses

Administrative expenses are paid by the Company or the Plan. During the year ended December 31, 2024, administrative expenses paid by the Plan totaled \$115,583.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains (losses) on the investments purchased and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document. At December 31, 2024 and 2023, no allowance for credit losses was deemed necessary. A loan that is in default is treated as a taxable deemed distribution to the participant. During 2024, \$214 of delinquent notes receivable were deemed as distributions to participants. At December 31, 2024 and 2023, no allowance for credit losses was deemed necessary.

Payment of Benefits

Benefit payments to participants are recorded when paid. Benefit payments totaled \$3,473,000 for the year ended December 31, 2024.

Subsequent Events

The Plan evaluated subsequent events through October 10, 2025, the date these financial statements were available to be issued.

3. CERTIFICATION

Investment information included in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in the fair value of investments, interest and dividends for the year ended December 31, 2024, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Reliance Trust Company (Reliance), the Plan custodian, and have not been audited by the independent auditors.

4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specified term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's policy is to recognize transfers between levels of the fair value hierarchy as of the actual date of the event of change in circumstances that caused the transfer. There were no transfers between levels of the fair value hierarchy during 2024.

5. TAX STATUS

The trust established under the Plan, which holds the Plan's assets, is qualified pursuant to the appropriate section of the Internal Revenue Code, and accordingly, the trust's net investment income is exempt from income taxes. The Plan has adopted an IRS approved prototype plan. The prototype plan has received a favorable opinion letter from the IRS that it qualifies under IRS Code Section 401(a), provided all terms of the Plan are followed. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan evaluates its tax positions in accordance with FASB ASC 740. At December 31, 2024, the Plan Administrator believes that all of its tax positions are appropriate based on current facts and circumstances, and no liability related to uncertain tax positions needs to be recorded.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants account balances would be distributed to the participants after payment of any administrative expenses.

7. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan transactions include units of investment accounts managed by Reliance for the year ended December 31, 2024. Therefore, these transactions qualify as party-in-interest transactions.

8. RISKS AND UNCERTAINTIES

The participants direct the Plan to invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.
