## **INDEPENDENT AUDITORS' REPORT**

To the Administrative Committee of  
The Goddard School

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of The Goddard School (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the statements or information regarding assets so held are prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### NOTES TO FINANCIAL STATEMENTS

---

#### 1. DESCRIPTION OF PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of The Goddard School (the "Plan") provides only general information. Participants should refer to the Plan Document and Summary Plan Description for a more complete description of the Plan's provisions.

*General* - The Plan, established effective January 1, 2012 and restated effective September 1, 2019, is a defined contribution plan which covers substantially all employees of Bellanza, Inc. (the "Sponsor") and other participating employers (collectively, the "Company"). Effective May 1, 2025 the Plan name changed to Speranza Consulting and Investments LLC 401(k) Plan and Sponsor name changed to Speranza Consulting and Investments LLC. Employees are eligible to participate upon completion of 1,000 hours and twelve months of service as defined in the Plan Document and enter the Plan on the first day of the month after meeting the eligibility requirements. Effective August 11, 2025, the Plan eliminated the twelve months of service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Basis of Accounting* - The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

*Use of Estimates* - The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of changes in net assets during the reporting periods. Actual results could differ from those estimates.

*Contributions* - The Company deposits cash to the Plan based on withholdings from the employees' pretax and/or after-tax earnings. Participants may elect to contribute to the Plan up to 85% of compensation. Eligible employees with an entry date on or after January 1, 2013 are automatically enrolled for deferral at 2% of eligible compensation unless they opt out of participation or make a different election. Participants who have attained age fifty before the end of the plan year are eligible to make catch-up contributions. Effective January 1, 2025, the Plan adopted a provision of the SECURE 2.0 Act which provides for an increase to the annual catch-up contributions limit established by the Internal Revenue Service (IRS) for participants who have attained ages 60 to 63 to the greater of \$10,000 or 50% more than the limit established by the IRS. The Plan has not been formally

amended for the adoption of this provision; however, management expects that the Plan will be amended prior to the December 31, 2026 deadline.

The Plan provides for employer matching contributions, equal to 25% of the first 4% of participant salary deferrals per pay period. The Plan also provides for discretionary annual non-elective contributions to participants in proportion to their eligible earnings compared to the eligible earnings of the other participants. There were no discretionary non-elective contributions for the years ended December 31, 2024 and 2023.

*Participant Accounts* - Each participant's account is credited with the employee and applicable employer contributions and an allocation of the Plan's earnings on a daily basis. Allocations of plan earnings are based on a participant's account balance as a percentage of the total account balances for the applicable investment option. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Investment Options* - Participants may direct their contributions as well as their share of employer contributions and any related earnings into various investment options. The Plan was invested in various funds maintained by Reliance Trust Company as of and for the years ended December 2024 and 2023 and ADP Retirement Trust Services, LLC for the period January 1, 2025 through April 30, 2025. Effective May 1, 2025, the investment funds are maintained by Matrix Trust Company.

*Vesting* - Participants are immediately vested in voluntary contributions, employer matching and non-elective contributions and investment income thereon.

*Payment of Benefits* - On termination of service due to death, disability, retirement or other reasons, and subject to certain restrictions, a participant or designated beneficiary may elect to receive an amount equal to the value of the vested interest in his or her account, subject to applicable tax withholding requirements. If a participant's vested account balance exceeds \$5,000 (or \$7,000, effective January 1, 2024) he or she may elect to receive a distribution in a lump-sum payment or IRA rollover, receive installments, request partial withdrawals, or defer receiving payments until age 70 1/2. If a participant's vested account balances does not exceed \$5,000 (or \$7,000 effective January 1, 2024) and the participant does not request a lump sum distribution, then the Plan will roll over the distribution to an IRA. Participants who face hardships or attain age 59 1/2 may also be eligible for distributions.

*Participant Loans* - Participants may borrow up to 50% of their account balance up to a maximum of \$50,000. The original amount of the loan must be at least \$500. Participants may have only one loan outstanding at any time. All loans must be repaid in their entirety within five years, unless the purpose of the loan was to purchase a principal residence. The interest rate on new participant loans is the prime rate at loan inception plus 2%. Notes receivable from participants are measured at

their unpaid principal balance plus any accrued but unpaid interest. The interest rate on loans outstanding as of December 31, 2024 and 2023 ranged between 5.25% and 10.50%.

*Administrative Expenses* - The Plan's expenses are paid by the Company or the Plan as provided by the Plan Document.

*Investment Valuation and Income Recognition* - The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

*Fair Value Measurements* - U.S. GAAP establishes a framework for measuring fair value of financial assets. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2      Inputs are not quoted prices in active markets but they are observable either directly or indirectly.
- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

*Mutual Funds*: Valued using quoted prices in an active market (Level 1 measurement).

*Common Collective Trust Funds*: invested principally in mutual funds, which are valued using quoted prices in an active market. The fair value of the underlying investments are used to determine the net asset value (NAV) of the common collective trust funds. The NAV is not publicly quoted but is available to current investors. The NAV is the basis for current transactions, and the common collective trust funds can be redeemed at NAV as of the measurement date (Level 1 measurement).

The methods described above may produce fair value calculations that may not be indicative of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other

market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting dates.

*Risks and Uncertainties* - Plan assets are composed of various investment securities, which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits and the statement of changes in assets available for benefits.

*Subsequent Events* - The Sponsor has analyzed subsequent events for recognition and disclosure purposes through October 8, 2025, the date which the financial statements were available to be issued. During 2025, two additional participating employers were admitted into the Plan as a result of acquisitions and new businesses started by the Sponsor.

## **2. PLAN TERMINATION**

The Sponsor anticipates and believes that the Plan will continue without interruption but reserves the right to discontinue the Plan at its discretion. In the event that such discontinuance results in the termination of the Plan, participants are entitled to their entire account balance. The net assets of the Plan will be distributed by the trustee in accordance with the trust agreement in a uniform and nondiscriminatory manner.

## **3. INCOME TAX STATUS**

The Plan operates under an adoption agreement in connection with a non-standardized, pre-approved profit sharing plan with a cash or deferred arrangement. The IRS issued an opinion letter dated October 6, 2020 indicating that the form of the pre-approved Plan is acceptable for use by employers under Section 401 of the Internal Revenue Code (IRC). Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Management believes that there is no liability related to uncertain tax positions at December 31, 2024 or 2023. The Plan is no longer subject to U.S. federal or state income tax examinations by tax authorities for tax years before 2021.
