Note 1 - Description of the Plan

The following brief description of the JDA Partners Technical Service 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan and was established January 1, 2012. All employees of JDA Technical Services Group, L.L.C., (the “Company” and/or “Plan Sponsor”), are eligible for participation in the Plan on the first day of the month following attaining the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is an ADP Retirement Services Defined Contribution Plan that uses Reliance Trust Company as the trustee/custodian of the assets.

Contributions

Participants may contribute up to the lesser of the annual limitation (\$23,000 for 2024) or 90% of their pretax compensation, as defined in the Plan document. The Plan provides a Safe Harbor Matching Contribution that is equal to 100% of salary deferrals that do not exceed 3% of compensation plus 50% of salary deferrals on the next 2% of compensation, as defined in the Plan document.

The Company may decide to make a Non-elective Contribution to the Plan, although the Company is not required to do so. The Non-elective Contribution will be allocated to all employees eligible to participate in the Plan.

The Plan provides for additional elective deferrals for eligible participants subject to certain limitations. All participants who have attained age 50 before the close of the Plan year are also eligible to make catch-up contributions in accordance with, and subject to the limitations of, Internal Revenue Code section 414(v). The maximum additional elective deferral for 2024 is limited to \$7,500.

The annual addition (which includes employee and employer contributions) that may be contributed and allocated to a participant’s account under the Plan for any limitation year shall not exceed the lesser of \$69,000 for 2024, as adjusted for increase in the cost of living under Code Section 412(d), or 100% of the participant’s compensation within the meaning of Code Section 415(c)(3), for the limitation year.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contribution, (b) Plan income and losses, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document.

Investment Options

Participants may invest their voluntary contributions, rollover contributions and the Company's contributions, plus actual earnings thereon into various mutual funds and common/collective trusts. The participants may change their investment election for new contributions and existing balances daily.

Vesting

Company Safe Harbor Matching contributions and participant contributions are fully vested as all employees are immediately fully vested in all contributions when they enroll in the Plan. In some circumstances, the Company may make profit sharing contributions on the participant's behalf considered Non-elective Contributions. These Non-elective Contributions are fully vested unless the participant's separation from service is other than death, disability, or attainment of age 65, in which case the following schedule applies:

Payment of Benefits

A participant who leaves the Company for any reason may receive a distribution from the Plan. The Plan provides for lump-sum distributions for retirement, termination, disability, or death. Upon termination of employment, if the participant's account balance is \$5,000 or less, a participant will automatically receive a lump-sum payment, less applicable withholding taxes. If the participant's account balance is greater than \$1,000 and is less than \$5,000 the amount will be transferred to an IRA. If the participant's account balance is greater than \$5,000, the participant may elect to either (a) receive installments, (b) request a partial withdrawal, or (3) a single lump-sum payment.

Notes Receivable from Participants

The Plan allows participants to borrow, subject to certain restrictions, against their vested account balance. Participants may borrow a minimum of \$500 up to a maximum of the lesser of (a) \$50,000 or (b) an amount equal to 50% of their current vested account balance. Notes are repayable over a term range from one to five years or up to 30 years for the purchase of a primary residence. Notes bear interest at the prime rate as published in The Wall Street Journal on the 14th of each month, plus two percentage points. The interest rate for a loan will be the rate in effect in the month the loan is effective. Notes are secured by the participant's account balance.

Administrative Expenses

Expenses incurred by the plan administrator and trustee for their services and costs in administering the Plan are paid by the Plan. The fees include the investment advisor fees, audit fees, and certain fees related primarily to benefit payment and loan administration which are paid directly by the plan participants. For the year ended December 31, 2024 the fees amounted to \$84,820 for administrative expenses.

Forfeited Accounts

Upon a participant's separation from service, amounts which are not vested will be forfeited and remain in the Plan. Forfeitures may be used to pay plan expenses for the plan year in which the forfeitures arise or to reduce the Company's employer matching and non-elective contributions for the plan year. As of December 31, 2024, there were no forfeitures in the Plan.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities as of the date of the financial statements and the reported amounts of additions and deductions in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Net (Depreciation) / Appreciation in Fair Value of Investments

The Plan presents, in the statement of changes in net assets available for benefits, the net appreciation in the fair value of its investments, which consist of the realized gains and losses from the sales of investments and the unrealized (depreciation) / appreciation on those investments. The net change in unrealized appreciation in the fair value of investments is determined by the change in fair value from the beginning of the year to the end of the year or from the date of purchase to the end of the year.

Benefit Payments

Benefits paid to participants are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a deemed distribution based upon the terms of the plan document. Accordingly, based on the plan administrator's estimate of the collectability of the notes receivable from participant's balance, the Plan provided that all notes receivables are fully collectable as of December 31, 2024 and 2023.

Subsequent Events

The Plan administrator has evaluated subsequent events through October 9, 2025, which is the date the financial statements were available to be issued.

Note 3 - Information Certified by the Trustee

No auditing procedures were performed by the independent auditors as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA with respect to information certified as complete and accurate by the custodians except for comparing such information with the related information included in the financial statements.

The following is a summary of the Plan's investment information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared or derived from information provided by Reliance Trust Company, the trustee of the Plan, and furnished to the plan administrator. The plan administrator has obtained a certification from the trustee that such information is complete and accurate.

Note 4 - Fair Value Measurements

Accounting Standards Codification (ASC) Topic 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset and liability; (4) inputs that are derived principally from or corroborated by observable (from sources independent of the reporting entity) market data by correlation or other means. If the asset or liability has specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable (best information available, which might include the entity's own data) and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The common collective trust fund is stated at net asset value of the shares determined by the underlying securities held by the Plan at year end. The net asset value is used as a practical expedient to estimate fair value. The common collective trust fund invests primarily in guaranteed investment contracts. The common collective trust funds do not have any unfunded commitments relating to its investments, or any significant restrictions or redemptions. There are no participant redemption restrictions for this investment.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with our market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of assets available for benefits.

Note 6 - Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated July 8, 2014 that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income tax has been included in the Plan's financial statements.

US GAAP requires the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax position taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan administrator believes it is no longer subject to income tax examination for years prior to 2022.

Note 7 - Party-in-Interest Transactions

Certain Plan investments are managed by the Trustee as defined in the Plan document. Transactions with the Trustee qualify as party-in-interest transactions. Any fees for investment management services are included in net appreciation (depreciation) in fair value of the investments. Direct fees incurred by the Plan for the trustee, audit, and recordkeeping services were approximately \$84,820 for the year ended December 31, 2024.

Note 8 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and assets will be allocated to participants based on his/her respective account balances after payment of all financial liquidation or termination expenses, pursuant to the direction of the plan administrator.
