### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of VEC, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

#### Note 1. Description of Plan

The following description of the VEC, Inc. 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

**General:** The Plan is a defined contribution plan that covers all employees of VEC, Inc. and Subsidiaries (the Company or Plan Sponsor) except for employees that are covered by a collective bargaining agreement or that are non-resident aliens. All eligible employees of the Company are eligible to become participants in the elective deferral portion of the Plan on his or her first day of employment with the Company. Employees that are employed on the last day of the plan year are eligible for the Company's discretionary contribution portion of the Plan as long as they have reached 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions:** Participants may contribute up to the maximum amount of pretax annual compensation as defined by the Plan and allowable under the Internal Revenue Code (IRC). Upon meeting the eligibility requirements, participants are automatically enrolled to contribute 5% of eligible compensation. Unless otherwise elected, the automatic deferral rate increases by 1% up to a maximum deferral of 10%. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions, as allowable by the IRC. Participants may also contribute amounts representing distributions from a qualified retirement plan of another employer if transferred before meeting the Plan's eligibility requirements.

The Company may elect to contribute to the Plan in the form of discretionary contribution. The discretionary contribution is determined annually by the Company's Board of Directors and is credited to the participants' separate accounts, if applicable. The Company will make discretionary contributions totaling \$420,399, before utilizing forfeitures, related to the 2024 plan year.

**Participant accounts:** A separate account is maintained for each participant consisting of (a) participant's share of the Company's contributions, (b) the participant's voluntary contributions and (c) investment earnings as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions plus actual earnings thereon. All other amounts credited to participants' separate accounts are vested according to the vesting schedule set forth below.

**Notes receivable from participants:** Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance with \$1,000 being the minimum. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

**Payment of benefits:** On termination of service, death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or periodic distributions in accordance with the plan document. A participant may also make an in-service withdrawal upon attainment of age 59½.

**Forfeited accounts:** At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,433 and \$101, respectively. Forfeited amounts can be used to restore participants' forfeitures, offset administrative expenses or reduce future employer contributions. Forfeitures of \$2,048 were used to reduce employer contributions as stated in the plan document. Accumulated forfeitures will be applied to pay expenses or reduce employer contributions in 2025.

**Administrative expenses:** Expenses of the Plan are paid by the Company or the Plan, at the discretion of the Company.

**Plan termination:** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The accompanying financial statements of the Plan are prepared using the accrual method of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results may differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions:** Contributions from plan participants and all the matching and discretionary contributions from the employer are recorded in the year in which participant compensation is earned. In the event that discretionary contributions have been approved but not yet funded as of year-end, the contributions are reflected as a receivable on the statements of net assets available for benefits.

**Payment of benefits:** Benefits are recorded when paid.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through October 7, 2025, the date on which the financial statements were available to be issued.

#### Note 4. Fair Value Measurements

Accounting standards established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) standards are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Registered investment companies:** Shares of registered investment companies are valued at quoted market prices which represent the net asset value (NAV) of the shares held by the Plan at year-end.

**Common collective/collective investment trusts:** Valued at the total of the NAV of the underlying securities held by the account at year-end. The Plan's interest in the common/collective investment trusts are valued based on the information reported by the investment advisor.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5. Income Taxes

The Internal Revenue Service (IRS) has determined and informed the Plan Sponsor, by a letter dated November 30, 2020, that the Plan, as designed, is qualified under the appropriate section(s) of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believes the Plan is qualified.

#### Note 6. Party-in-Interest Transactions

Certain plan investments were funds managed by Newport and Ascensus. Newport and Ascensus, as the trustees defined by the Plan during the plan year, qualifies as parties-in-interest. The Plan paid administrative fees of \$57,902 for the year ended December 31, 2024.

#### Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
