Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of GPMF Holdings 401(K) (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of GPMF Holdings 401(K)'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

1. DESCRIPTION OF PLAN:

The following description of the GPMF Holdings 401(K) (the "Plan") is provided for general information purposes only. Participants should refer to the Summary Plan Description or Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on May 1, 2019, covering all employees of GPMF Holdings, Inc. (the "Company"), and its participating affiliates, VertitechIT, Inc. and BaytechIT, LLC, who have elected to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Administration of the Plan

GPMF Holdings, Inc. is the plan sponsor and is responsible for the monitoring and administration of the Plan. ADP, LLC ("ADP"), the Plan's third-party administrator, is responsible for the general administration of the Plan. Reliance Trust Company ("Reliance") serves as trustee for the Plan.

Eligibility provisions

Eligible employees become participants after completing one month of service and are at least 18 years of age. The Plan entry dates are the first day of the month following the completion of the eligibility requirements.

Participants' accounts

Each participant's account is credited with the participant's voluntary contributions, the Company's matching contributions and non-elective contributions and Plan earnings (losses) and reduced by any allocable expenses, if applicable. Allocations are based on participant account balances, participant earnings, compensation or transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

Contributions

The Plan provides for participants to make pre-tax and Roth deferral contributions from a minimum of 1% up to a maximum of 90% of their annual compensation subject to annual limitations determined by the Internal Revenue Code ("IRC"). Additionally, participants over age 50 are eligible to make catch-up contributions, which are also limited by IRC regulations. The Company will contribute a safe harbor match of 100% of the first 3% of employee eligible compensation contributed to the Plan and an additional 50% of the next 2% of employee compensation contributed to the Plan.

The Plan provides for automatic participant contributions, whereby a newly eligible participant who has not elected to defer a portion of compensation or elected to receive cash in lieu of making a salary deferral election will automatically have 5% of their compensation deferred and contributed to the Plan. Until a participant elects otherwise, these automatic participant contributions are invested in a default investment fund selected by the Company.

The Plan also provides for a discretionary non-elective contribution as determined by the Company on an annual basis. Amounts allocated to participant accounts are determined by the participant's compensation as a percentage of total participant's compensation. No discretionary non-elective contributions were made for the years ended December 31, 2024 and 2023.

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options on a daily basis.

1. DESCRIPTION OF PLAN: (CONTINUED)

Vesting

Participants are immediately vested in their voluntary contributions and employer contributions to the Plan plus actual earnings thereon.

Payment of benefits

On termination of service, death, or permanent disability, a participant or their beneficiaries may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in the participant's account, periodic installments over a specified time, or a direct rollover to an individual retirement account ("IRA") or other qualified plan. The Plan also allows for other in-service and hardship distributions. For vested account balances under \$7,000 (\$5,000 in 2023), lump sum distributions or direct rollovers will be made.

Notes receivable from participants

Participants may borrow from the vested portion of their accounts at a minimum amount of \$500 up to a maximum amount of \$50,000 or 50% of their vested account balance, whichever is less. Loans are for a period not to exceed five years (except longer terms are available for loans issued for the purchase of a principal residence). Up to two loans are allowed for each participant. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined quarterly by the Plan administrator, which range from 5.25% to 10.50%. Principal and interest is paid ratably through payroll deductions so long as the participant is employed by the Company. Upon termination of employment with the Company, any remaining payments are due immediately.

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

SECURE 2.0 Act of 2022

The SECURE 2.0 Act of 2022 (the "Act") was signed into law on December 29, 2022, to increase retirement savings, improve retirement rules, and lower employer costs of setting up a retirement plan. Plan amendments required by the Act generally need not to be made until the end of the first plan year beginning on or after January 1, 2026, however, plans must operate in accordance with effective date of each new provision.

Major provisions of this Act that may affect the Plan include:

- Effective January 1, 2024, the limit for mandatory cash outs was raised from \$5,000 to \$7,000.
- Effective January 1, 2025, further expansion of eligibility to long-term part-time workers, which will allow participation after two consecutive years of 500 or more hours.
- Effective January 1, 2026, catch up contributions for any participants over age 50 who earn over \$145,000 are now required to be made on a Roth basis.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment valuation and income recognition

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and the trustee. See Note 4 for further discussion of fair value measurements. All investments are participant directed.

In accordance with the policy of stating investments at fair value, the statements of changes in net assets available for benefits includes the net appreciation in the fair value of investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

Purchases and sales of securities are reflected on the trade date and gains and losses are determined on the basis of identified cost. Interest income is recorded as earned on the accrual basis and dividends are recorded on the ex-dividend date.

Earnings on investments, with the exception of participant loans, are allocated on a pro rata basis to individual participant accounts based on the type of investment and the ratio of each participant's individual account balance to the aggregate of participant account balances. The portion of interest included in each loan payment made by a participant is recognized as interest income on the participants' individual account.

Benefit payments

Benefit payments to participants are recorded when paid.

Notes receivable from participants

Notes receivable from participants are recorded at their unpaid balance plus any accrued but unpaid interest. Since the participant's remaining vested investment balance is sufficient to cover the outstanding loan amount, there is no allowance for doubtful accounts at December 31, 2024 and 2023. Interest is calculated and included in the repayment terms of the loan when the loan is initiated and is recognized with the amortization of the loan as each payment is remitted. Loans are monitored for repayment under the original loan terms and defaulted when active participants cease payments past the allowed grace period. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. For terminated participants, once a distribution is requested, the outstanding loan balance will be netted against the remaining vested investment balance.

Plan expenses

Certain Plan expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of benefits paid to participants or their beneficiaries are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES: (CONTINUED)

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America and the Department of Labor's ("DOL") rules and regulations for reporting and disclosure under the Employee Retirement Income Security Act of 1974 requires the Plan Administrator to make estimates and assumptions that affect the reported amount of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

3. INFORMATION CERTIFIED BY THE TRUSTEE:

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under Employee Retirement Income Security Act of 1974. Accordingly, Reliance Trust Company, the trustee of the Plan, certified to the Plan administrator the fair value and physical custody of investments and investment transactions to be complete and accurate as of and for the years ended December 31, 2024 and 2023 and investments and notes receivable from participants which are included in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, as well as investment income, net appreciation in the fair value of investments included in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023 and the information contained in Note 4 concerning investments, and the information included in the supplemental Schedule of Assets (Held at End of Year).

4. FAIR VALUE MEASUREMENTS:

The Plan follows established guidelines for a fair value hierarchy that prioritizes the inputs used to measure fair value. An asset or liability's classification within the hierarchy is determined based on the lowest level input that is significant to the fair value measurement. The hierarchy prioritizes the inputs into three broad levels as follows:

- Level 1 Quoted prices (unadjusted) in active markets for identical assets or liabilities. Market price is generally obtained from exchange or dealer markets.
- Level 2 Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. Inputs are obtained from various sources including market participants, dealers and brokers.
- Level 3 Unobservable inputs that are supported by little or no market activity as they trade infrequently or not at all and that are significant to the fair value of the assets or liabilities.

4. FAIR VALUE MEASUREMENTS: (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that registered with the Securities and Exchange Commission. These funds are valued at the closing price recorded on the active market in which these individual securities are traded.

Stable value fund: Valued at the net asset value (“NAV”) of units of the fund. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. (See Note 5).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. INVESTMENT IN COMMON GROUP TRUST:

The Putnam Stable Value Fund is a common group trust administered by Putnam Fiduciary Trust Company (“Putnam”). The fund invests primarily in guaranteed investment contracts (“GIC’s”) and security-backed investment contracts. Putnam maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fund is included in the financial statements at fair market value which approximates contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The fair value of the contract represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting rate was approximately 3.96% and 4.09% at December 31, 2024 and 2023, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

6. RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS:

ADP is the third-party administrator of the Plan and fees paid to ADP are party-in-interest transactions. Transactional fees paid by the Plan to ADP totaled \$5,518 and \$2,636 for the years ended December 31, 2024 and 2023, respectively. Contract administrator and Plan record keeping fees charged by ADP are paid by the Plan sponsor.

In addition, fees paid to Merrill Lynch, Pierce, Fenner & Smith, Inc. for investment advisory services in the amount of \$22,289 and \$16,821 for the years ended December 31, 2024 and 2023, respectively, qualify as party-in-interest transactions. These expenses are also included in administrative expenses in the statements of changes in net assets available for benefits.

Certain Plan investments are shares of funds managed by Reliance. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund and are reported in both net appreciation and interest and dividends in the statements of changes in net assets available for Plan benefits.

Certain employees and officers of the Company, who may also be participants in the Plan perform administrative services at no cost to the Plan.

7. TAX STATUS:

The Plan is a prototype Plan administered by Reliance and an opinion letter was received dated October 6, 2020, in which the Internal Revenue Service stated that the Plan as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since this date. However, the Plan administrator and Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES:

The Plan provides for various investment fund options in any combination of mutual funds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. SUBSEQUENT EVENTS:

The Plan's recordkeeping and administrative services were transitioned from ADP to Empower effective July 1, 2025.

Management has evaluated subsequent events through October 12, 2025, the date the financial statements were available to be issued. No other events were identified that require disclosure in the financial statements.
