Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Kettler Welfare Benefit Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1 - Description of the Plan

General

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more detailed description of the Plan's provisions.

The Kettler Welfare Benefit Plan (the "Plan"), formerly the "Medical & Dental Plan", was merged with the KSI Services, Inc. Group Life Plan and the KSI Services STD and LTD Plan on September 1, 2012. The Plan was established to provide benefits to all full-time employees of Kettler, Inc., Kettler Management, Inc., McLean Easton LLC, American Commercial Fueling LLC, Kettler Enterprises Inc. and KMB Realty, Inc. (the "Companies"). The Plan is self-insured for group medical and prescription drug liabilities. The Trust for the Plan was established in December 2008 to provide funding for these costs. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Eligible employees may enroll in the Plan within 30 days following their date of employment. Enrollment will become effective on the first of the month following one month of continuous employment. In the event that person becomes a dependent or spouse of the employee through marriage, birth or adoption, the employee will receive a special enrollment period of 30 days from the date of the event.

As of January 1 each year, eligible employees have the option to be covered for medical benefits through the Cigna Health and Life Insurance Company ("Cigna") under the Open Enrollment plan, or two different high deductible health plans. All employees enrolled in the Open Enrollment or high deductible health plans receive prescription drug coverage administered by Evernorth Health Services.

The Plan also provides for benefits for dental, vision, flexible spending accounts, short-term disability, term life and accidental death and dismemberment.

Dental coverage is provided through a group health plan with Metropolitan Life Insurance Company ("MetLife"). Employees enrolled in dental coverage may also receive vision discounts. Eligible employees may also participate in the health flexible spending arrangement administered by UltiPro Payroll. Employees are eligible the first of the month following the first 90 days of full-time employment to receive coverage for short-term disability, long-term disability, term life and accidental death and dismemberment through a full insurance contract with MetLife.

Kettler, Inc. (the "Plan Sponsor") has stop-loss insurance with Cigna. The stop-loss insurance limits in effect during 2024 were \$125,000 for an individual and \$4,219,613 in aggregate. During 2024, the Plan Sponsor received \$1,348,595 in stop-loss refunds which were contributed to the Plan and are included in employer contributions on the statement of changes in net assets available for benefits. Upon termination of employment, employees are eligible for continued coverage under the Consolidated Omnibus Budget Reconciliation Act of 1986 ("COBRA") in compliance with COBRA regulations.

Administration of Plan assets

The Plan's assets are managed under a trust agreement with Principal Trust Company (the "Custodian"). Cigna was appointed claims administrator of the Plan.

Plan benefits

Benefits include coverage for medical, prescription drugs, dental, short and long-term disability, term life and accidental death and dismemberment, as well as vision discounts for employees and their dependents.

Funding policy

The Companies have voluntarily agreed to make contributions to the Plan which will be sufficient to provide assets to pay benefits to Plan participants. In addition to Company contributions, management has formulated a co-pay rate which employees contribute to the Plan via a payroll deduction.

Plan termination

Although the Companies have not expressed intent to terminate the Plan, they may do so at any time. In the event of Plan termination, the Companies shall be liable for, and have agreed to provide funds to the extent not provided by the Plan for all Plan benefits, including those that become due prior to termination of the agreement but are not yet paid at the Plan's termination.

Note 2 - Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America in all material respects and reflect management's estimates and assumptions, such as those regarding assets, liabilities, fair value, claims payable, claims incurred but not reported and postretirement benefit obligations that affect recorded amounts and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of benefits

Premiums paid by either the Companies or the Plan trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when the third-party claims processor submits claims for reimbursement. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of benefit obligations.

Stop-loss

Premiums for stop-loss insurance are included in insurance premiums in the accompanying statement of changes in net assets available for benefits.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies and procedures. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Risks and uncertainties

The Plan invests in an interest-bearing cash account. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect amounts reported in the statements of net assets available for benefits.

Contributions to the Plan and the value of estimated payments on reported claims and the actuarial present value of benefit obligations are reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Benefit obligations

The Plan's liability for estimated health claims incurred but not reported and claims reported but not yet paid at December 31, 2024 and 2023 were determined by Lockton Companies, consulting actuary, in accordance with accepted actuarial principles based on claims experience and other pertinent factors.

Subsequent events

Material subsequent events have been considered for disclosure and recognition in these financial statements through October 13, 2025, the date the financial statements were available to be issued.

Note 3 - Tax status

By letter dated May 25, 2010, the Internal Revenue Service determined that the Plan's trust is qualified and exempt from federal income taxes under Sections 501(a) and 501(c)(9) of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 4 - Related party and party-in-interest transactions

The Plan invests in an interest-bearing cash account that is managed by the record keeper and Custodian, Principal Trust Company. These transactions qualify as party-in-interest transactions. However, they are exempt from prohibited transaction rules under ERISA. The Plan incurred \$6,675 in administrative fees to Principal Trust Company during 2024.

Note 5 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-bearing cash: Short-term money market instruments and cash held in financial institutions are valued based on a quoted market price, which approximates fair value on an active market.
