### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2025 and 2024 Financial Statements**

We have performed the audits of the financial statements of Home Buyers Warranty 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Their report dated September 23, 2024, indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedules, other than the information in the 2023 supplemental schedules that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

### Note 1 - Description of Plan

The following description of the Home Buyers Warranty 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document or the summary plan description for a more complete description of the Plan's provisions, which are available from the plan administrator.

#### General

The Plan was established by HBW Holdings, Inc. (the "Company" or "Plan Sponsor") as a defined contribution plan effective April 1, 1986. All non-union employees of the Plan Sponsor who have completed at least thirty (30) days of service and have attained the age of 18 are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective January 1, 2025, the Plan merged into the Frontdoor, Inc. 401(k) Plan. All assets, earnings, and plan activity became the responsibility of the Frontdoor, Inc. 401(k) Plan as of the effective date of the amendment.

#### Contributions

Participants may elect to contribute up to seventy-five percent (75%) of their annual eligible compensation as pre-tax or Roth contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Additionally, participants age fifty (50) or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan.

Eligible employees are automatically enrolled in the Plan at a six percent (6%) contribution rate unless the employee elects otherwise. The Plan also automatically increases the contribution rate by one percent (1%) each year of participation up to ten percent (10%).

The Plan provides for an employer matching contribution of fifty percent (50%) of participant deferrals up to the first six percent (6%) of eligible compensation. The Plan also allows for the Company to make additional discretionary matching and qualified nonelective contributions. During 2025, 2024, and 2023, the Company did not make any discretionary contributions.

#### Participant investment account options

The Plan offered a variety of mutual funds, common/collective trust funds, and pooled separate accounts held by Principal Trust Company (Principal).

#### Participant accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) plan earnings and charged with an allocation of administrative

#### Participant accounts (continued)

expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in employee deferral contributions in their account plus actual earnings thereon. The Company's matching contributions are vested 50% after one (1) year of service and 100% after two (2) years of service.

#### Notes receivable from participants

Participants may borrow from their individual accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance and may have no more than one (1) loan outstanding at any given time. The loans are secured by balance in the participant's account and bear interest at a rate equal to the current prime lending rate plus one percent (1%). Principal and interest is repaid ratably through payroll deductions.

#### Payment of benefits

Upon termination of service due to death, disability, or retirement, a participant or their beneficiary may elect to receive an amount not to exceed the value of the participant's vested interest in his or her account in either a lump-sum amount or a direct rollover. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or a direct rollover. Withdrawals by a participant while still employed are limited to those requested due to events of financial hardship as defined in the Plan document or upon attainment of age 59½.

### Note 2 - Summary of significant accounting policies

#### Basis of accounting

The accompanying financial statements are prepared on the accrual method of accounting.

#### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions which affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the trustee. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Contributions

Contributions from Plan participants and the matching contributions from the company are recorded in the year in which employee contributions are withheld from compensation.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of January 1, 2025, December 31, 2024, and December 31, 2023.

#### Payment of benefits

Benefits are recorded when paid.

#### Administrative expenses

Certain expenses of the Plan are paid by the Company and are not included in the statements in changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### Note 3 - Information prepared and certified by the trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and the supplemental schedule is complete and accurate with respect to investments:

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and the supplemental schedule.

Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, are described below.

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued at the NAV of units of the separate accounts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Common collective trust funds:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

- \* In accordance with Subtopic 820-10, certain investments that were measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

The fair value of the investments in the pooled separate accounts and common collective trust funds have been estimated using the net asset value of the investment. The pooled separate accounts and common collective trust funds are redeemed on a daily basis and do not have any redemption restrictions, other than as disclosed above. Additionally, there are no unfunded commitments.

### Note 5 - Related party transactions and party-in-interest transactions

Certain Plan investments include interests in certain mutual funds, pooled separate accounts, and common/collective trust funds managed by Principal. These transactions qualify as party-in-interest transactions, as defined by the Plan. Certain fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments as they are paid through revenue sharing rather than direct payment. The Plan made direct payments to parties-in-interest totaling \$144,914, and \$135,743 for the years ended December 31, 2024 and 2023, respectively, which was not covered by revenue sharing. There were no fees paid in 2025. These transactions are party-in-interest transactions. The plan sponsor pays directly any other fees related to the Plan's operations.

### Note 6 - Tax status

The Internal Revenue Service (IRS) has determined that the Volume Submitter Profit Sharing Prototype Plan is designed in accordance with applicable sections of the IRC and informed the trustee of such in a letter dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that is more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 7 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note 8 - Delinquent participant contributions

Defined contribution plans must remit employee contributions to the Plan as soon as they can be reasonably separated from the employer's general assets. While the Company remitted all employee contributions to the Plan, contributions of \$123 were not remitted within the required time period for the year ended December 31, 2023. The Company remitted all prior lost earnings for the late remittances during September 2024.

### Note 9 - Subsequent events

Plan management has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure, other than as disclosed in Note 1.
