## **Independent Auditor's Report**

To the Plan Administrator of the  
Hungerford Nichols Investment Plan and Trust:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Hungerford Nichols Investment Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Note 1 – Description of the Plan

The following description of the Hungerford Nichols Investment Plan and Trust (the "Plan") provides only general information. Participants and all others should refer to the Plan document for a more complete description of the Plan's provisions.

**General.** The Plan is a defined contribution plan which went into effect January 1, 1988 that is generally available to all employees of Hungerford, Aldrin, Nichols & Carter P.C. ("the Company", "Plan Sponsor", or "Plan administrator"); Hungerford Technologies, LLC; Hungerford Valuation; and Hungerford Financial (collectively, DBA Hungerford, the "Employer"). The Plan excludes union employees, nonresident aliens, leased employees, residents of Puerto Rico, reclassified employees, and temporary and seasonal employees whose regularly scheduled service is less than 1,000 hours of service. Employees immediately become eligible to make elective deferral contributions and receive discretionary Employer matching contributions upon commencement of employment and attainment of age 21. Employees become eligible to receive discretionary Employer nonelective contributions on January 1 and July 1 when they have attained age 21 and complete one year of service. Starting January 1, 2024, Long-Term Part-Time ("LTPT") employees are eligible to save for retirement by deferring compensation to the Plan, but they are not eligible to receive any employer contributions. To be eligible to participate in the 401(k) Plan as a LTPT employee, an employee must have worked at least 500 hours of service in the consecutive service periods (e.g. starting with the 2021 plan year). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Benefits under the Plan are not guaranteed by the Pension Benefit Guaranty Corporation.

**Contributions.** The following types of contributions are allowable under the Plan:

- **Elective Deferral Contributions** – Participants may contribute a percentage of their pretax compensation, as defined in the Plan document, as an elective deferral contribution, subject to limitations. Additionally, participants may contribute a percentage of their after-tax compensation and designate it as a Roth elective deferral contribution. A participant's total elective deferral contributions cannot exceed \$23,000 (\$30,500 if 50 or older) in calendar year 2024.
- **Discretionary Employer Matching Contributions** – The Employer may make a discretionary Employer matching contribution to eligible participants. Such contribution is allocated based on a participant's elective deferrals up to a discretionary percentage of a participant's compensation or a discretionary dollar amount. During 2024, the Employer made a discretionary matching contribution equal to 50% of a participant's elective deferrals up to 8% of compensation.
- **Discretionary Employer Nonelective Contributions** – The Employer may make a discretionary nonelective contribution to eligible participants that are employed on the last day of the Plan year. Such contribution is allocated pro rata as a uniform percentage of participant compensation. During 2024, the Employer did not make a discretionary Employer profit sharing contribution.
- **Rollover Contributions** – Amounts distributed to eligible participants from other qualified employee benefit plans may be rolled into the Plan.

All contributions are allocated to the Plan's investment funds at the direction of the participants.

**Participant Accounts.** Each participant's account is credited with the participant's contributions (elective deferrals and rollovers) and an allocation of (a) the Employer's contribution (discretionary Employer matching and nonelective, if any), (b) fund earnings or losses, and (c) administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Vesting.** Participants are immediately vested in their elective deferral contributions, rollover contributions, and related earnings thereon.

With certain exceptions, participants vest in discretionary Employer matching and nonelective contributions based on years of service and a six year graded vesting schedule. Participants become 20% vested after two years of service and in 20% increments thereafter such that participants become 100% vested in their discretionary Employer matching and nonelective contribution accounts after completing six years of service. Additionally, employed participants become 100% vested in their accounts upon attainment of normal retirement age, death, disability, and termination or partial termination of the Plan.

**Investment Options.** Participants have the option to direct their investments into various mutual funds and a common collective trust.

**Forfeitures.** When certain terminations of participation in the Plan occur, the non-vested portion represents a forfeiture. Forfeitures are used to pay administrative expenses of the Plan or are used to reduce discretionary Employer matching contributions. During 2024, \$16,022 was used to pay administrative expenses of the Plan. As of December 31, 2024 and 2023, the balance in the forfeitures account totaled \$22,837 and \$13,302, respectively.

**Notes Receivable from Participants.** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (i) \$50,000, reduced by the participant's highest outstanding loan balance during the prior 12 month period, or (ii) 50% of their vested account balance. Loan terms range from 1 month up to a maximum of 5 years (a longer term up to 15 years is available if used for the purchase of a principal residence). The loans are secured by the balance of the participant's account and bear a rate of interest equal to the prime rate plus 1% at the date the loan is granted. Principal and interest payments are paid ratably through payroll deductions.

**Payment of Benefits.** Benefits to participants or beneficiaries generally are payable as a lump sum or ad-hoc equal to the value of their vested account balance upon retirement, disability, death or termination of the participant. A terminated employee with a balance of less than a certain dollar threshold, as defined by the Plan document, may be automatically paid out by the Plan upon termination. Additionally, participants may request in-service withdrawals of their rollover contributions account, upon attainment of age 59½, for a qualified reservist distribution, for a deemed severance distribution, or upon incurring a financial hardship, as defined in the Plan document, if certain criteria are met.

### Note 2 – Summary of Significant Accounting Policies

**Basis of Accounting and Use of Estimates.** The financial statements of the Plan are prepared using the accrual method of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan’s management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition.** The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Committee determines the Plan’s valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**Contributions.** Participant contributions and the related Employer matching contributions are recognized in the period in which participant contributions are withheld from compensation.

**Notes Receivable from Participants.** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Benefits Payments.** Benefits are recorded when paid.

**Administrative Expenses.** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative fees. Also, included in administrative fees are recordkeeping, trustee, and other administrative expenses. Additionally, certain investment related expenses are included in net appreciation in fair value of investments.

### Note 3 – Fair Value Measurements

The Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

**Level 1.** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2.** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3.** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

- Mutual funds are valued at the quoted net asset value ("NAV") of shares held by the Plan at year end;
- Common collective trust ("CCT") is valued at the NAV of units held by the Plan at year end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (a) The investment pursues stability of principal and current income by investing primarily in stable value products, including traditional GICs, synthetic GICs and money market instruments.
- (b) Qualified Plan participant initiated withdrawals are honored at any time without penalty. The Fund also requires participants to invest in a "non-competing fund" for at least 90 days before transferring to a "competing" fund option. Examples of "competing" fund options include a money market fund, a stable value fund, or any other fund that directly or indirectly maintains at least 80% of its assets in fixed-income securities and maintains an average effective duration of three years or less.

Any Plan sponsor initiated withdrawal from the Fund will require a 12-month written notice of the intent to withdraw assets from the Fund. At the sole discretion of Federated Investors Trust Company, the 12 month written notification requirement may be waived or reduced if the waiver or reduction would not negatively impact the Fund or the plans invested therein.

### Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination or partial termination, affected participants will become 100% vested in their accounts.

### Note 6 – Tax Status

The Company has adopted an Alerus NA Non-Standardized Pre- Approved Profit Sharing Plan ("pre-approved plan"). The pre-approved plan received an opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated that the pre-approved plan is qualified under the applicable sections of the Internal Revenue Code ("IRC"). Although the pre-approved plan and Plan have been amended since receiving the IRS opinion letter, the Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified under Section 401(a) of the IRC and the related trust is tax exempt as of December 31, 2024 and 2023. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 7 – Party-In-Interest Transactions

The Company provides to the Plan certain accounting and administrative services for which no fees are charged.

The Plan's trustee, Alerus Financial, N.A.; the Plan's third-party administrators and recordkeepers; the Plan's investment advisor; the Plan's auditors; the Company; the Employer; and Plan participants are all parties-in-interest to the Plan. Additionally, the Plan maintains notes receivable from participants. Fees paid for services rendered by parties-in-interest were based on customary and reasonable rates for such services.

### Note 8 – Concentrations, Risks, and Uncertainties

The Plan provides for various investment options. Investment securities, in general, are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts presented in the statements of net assets available for benefits. As of December 31, 2024 and 2023, there were three investments which individually represented more than 10% of net assets available for Plan benefits. See supplemental Schedule of Assets (Held at End of Year) for a complete listing of investments held at December 31, 2024.

Additionally, some investments held by the Plan are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

### Note 9 – Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 29, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan document was amended. In connection with this amendment the following occurred:

- The Plan's name was changed to the Hungerford 401(k) Plan;
- The Plan provides for an automatic contribution arrangement ("ACA") such that a newly eligible participant without an affirmative election will be auto-enrolled into the Plan and have 3% of their compensation withheld as an elective deferral contribution. Such automatic contribution will be increased 1% annually on January 1 until a 10% deferral percentage is reached;
- The Plan's hours of service required during the vesting computation period was modified from 1,000 hours to 500 hours; and
- The Plan's definition of compensation was amended.
