## NOTES TO FINANCIAL STATEMENTS Years Ended December 31, 2024 and 2023

### 1. PLAN DESCRIPTION

The following description of the Broadhead Enterprises, Inc. Employee Stock Ownership Plan (Plan) provides only general information regarding the Plan. Participants should refer to the Plan documents for a more complete description of Plan provisions.

#### **General**

Broadhead Enterprises, Inc., (Company) established the Plan effective as of January 1, 2018. The Plan operates in relevant part, as a non-leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 as amended (IRC), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility**

Employees of the Company are generally eligible to participate in the Plan after one year of service, providing they worked at least 1,000 hours and have reached the age of 21 during such plan year. Participants who do not have at least 1,000 hours of service or have not reached the age of 21 during such plan year or are not employed on the last working day of a plan year are generally not eligible for an allocation of Company contributions for such year.

#### **Contributions**

The Company makes contributions of cash or stock to the Plan which are determined annually by the trustees of the ESOP. Employee contributions are not permitted.

#### **Participant Accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. The Plan allocates contributions and forfeitures to eligible participants proportionally based on eligible compensation. Administrative expenses and investment activity are allocated proportionally based on the participant's account balance. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation.

#### **Vesting**

Participants are vested based on years of service. A participant is 100 percent vested after 6 years of credited service. The account of a participant which is not vested shall be forfeited upon completion of a break-in-service of five or more consecutive years or, if earlier, distribution of the participant's entire vested account balance.

#### **Payment of Benefits**

Upon death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested account balance by the end of the following plan year.

##### Payment of Benefits (Continued)

Upon termination of service, a participant with a non-forfeitable accrued benefit less than \$1,000 shall receive a lump-sum amount equal to the participant's vested account balance by the end of the following year. Participants with a non-forfeitable accrued benefit less than \$7,000 but exceeding \$1,000 can elect to receive a lump-sum amount equal to the participant's vested account balance by the end of the following year or a rollover distribution to an individual retirement account. Participants with a non-forfeitable accrued benefit greater than \$7,000 will begin to receive the vested account balance by the close of the sixth plan year following the plan year of termination or, if earlier, the year following the date of normal retirement age. Prior to separation from service, a participant reaching age 70 ½ can elect to receive all or a portion of their vested account balance or defer payment until retirement.

##### Forfeited Amounts

Forfeited non-vested amounts are allocated to participants in the year of forfeiture. Total forfeitures allocated to participants was \$2,842 and \$10,126 for the years ended December 31, 2024 and 2023, respectively. There were no forfeitures available to reduce administrative expenses as of December 31, 2024.

##### Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

##### Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify receive a cash distribution.

##### Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is permitted to vote for any allocated share for which instructions have not been given by a participant.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

##### **Estimates**

Preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

The common shares of the Company are valued annually by independent appraisals. See Note 4 for further discussion of investment valuation inputs.

Purchases and sales of common shares are recorded based on the most recent appraisal value.

Gains and losses (realized and unrealized) are included in the statement of changes in net assets available for benefits as net appreciation (depreciation) in company stock.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of redemptions are charged to the participant's account and are included in investment and administrative expenses.

##### **Risks and Uncertainties**

The Plan invests in the Company's stock. The Company's stock is exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with the investment portfolio, it is at least reasonably possible that changes in the values of the investment portfolio would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes in net assets available for benefits.

As of December 31, 2024 and 2023, the Plan had investments totaling \$2,489,025 and \$3,951,000 that were all concentrated in company stock.

#### 4. FAIR VALUE MEASUREMENTS

Generally accepted accounting principles established a framework for measuring fair value based on a hierarchy that prioritizes valuation inputs as referenced below:

Level 1	Inputs using quoted prices in active markets for identical assets or liabilities
Level 2	Significant other observable inputs including quoted prices for similar assets in active or inactive markets, inputs that are derived from or corroborated by observable market data by correlation or other means, or inputs other than quoted prices that are observable for the asset
Level 3	Significant unobservable inputs

Valuation levels are not necessarily an indication of associated risk.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The fair value of the Company common stock held in the Plan is valued at estimated fair value based upon independent appraisal. The appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account projected cash flow and net income, discount rates, market comparable sales, public company sales, and discounts for lack of control and lack of marketability. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Principal is the trustee as defined by the Plan, and therefore, the transactions qualify as party-in-interest transactions. There were no fees for accounting and recordkeeping paid by the Plan for the years December 31, 2024 and 2023 since all fees were paid by the Company.

The Plan invests in Company common stock, and receives dividends and contributions from the Company, as applicable. These are related party and party-in-interest transactions.

#### 6. INCOME TAX STATUS

The Plan obtained its latest determination letter on August 27, 2018, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the plan administrator and tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

#### 7. PLAN TERMINATION

The Company has the right under the Plan to discontinue contributions at any time and terminate participation in the Plan subject to provisions of ERISA. In the event of termination, participants become 100% vested in their accounts.

The Plan was terminated as of August 1, 2025. The Company purchased all shares of Company stock for \$2,600,000.

#### 8. ADMINISTRATION OF PLAN ASSETS

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

#### 9. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Net assets available for benefits and the changes in net assets available for benefits per the financial statements agree to Schedule H of Forms 5500 as of and for the years ended December 31, 2024 and 2023.

#### 10. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.
