### ***INDEPENDENT AUDITOR'S REPORT***

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Resource Management Concepts, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. ***DESCRIPTION OF PLAN***

The following description of the Resource Management Concepts, Inc. 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Resource Management Concepts, Inc. 401(k) Plan was established January 1, 1995.

***General***

The Plan is a defined contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was amended on February 28, 2023 to adopt the statutory changes pursuant to the Coronavirus Aid Relief and Economic Security Act. The Plan covers all employees who are age twenty-one or older, with the exceptions of nonresident aliens and employees covered by collective bargaining agreements. Eligible participants enter the plan on the first of the month following employment.

***Contributions***

Each year, participants may contribute up to 90% of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The maximum participant contribution is limited by the Internal Revenue Service to \$30,500 and \$30,000 for the Plan years ended December 31, 2024 and 2023, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants may designate some or all of their contributions as Roth Deferral Contributions. Amounts designated as Roth Deferral Contributions are included in the participant’s income for tax purposes.

The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation (3% prior to March 2021). The automatic Elective Deferral Contribution increases by 1% on or after the first day of the Plan year, up to a maximum contribution of 10%. The participant may affirmatively elect a different percentage or elect not to make the elective deferral contribution.

Employer matching contributions to the Plan are discretionary. However, currently the employer matches contributions for employees equal to 25% of the first 7% of the participants’ salary reduction, and 50% of the next 8% of the participants’ salary reduction.

In addition, the employer may make discretionary contributions in an amount determined by the Board of Directors at the end of each Plan year. Participants must complete 1,000 hours of service during the Plan year and be employed on the last day of the Plan year to be eligible to receive a discretionary contribution. There were no employer discretionary contributions for the year ending December 31, 2024 and 2023.

### ***Participant Accounts***

Each participant's account is self-directed and is credited with the participant's contribution and an allocation of (a) the employer contributions, and (b) plan earnings, expenses, gains and losses, according to the available investment options selected by each participant. Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan is intended to satisfy ERISA Section 404(c).

### ***Vesting***

A participant is immediately 100% vested in all employee contributions and any earnings on those contributions. Vesting in the Company's contributions is based on years of continuous service. Employer matching contributions, discretionary contributions and earnings on those contributions are 100% vested to the participant after two years of service. Participants whose employment terminated prior to December 7, 2015, are subject to a 6-year vesting schedule for employer matching and profit-sharing contributions.

### ***Forfeitures***

Forfeitures are recognized when participants terminate employment prior to becoming fully vested in the employer discretionary profit-sharing contributions. Forfeitures may be used to reduce employer contributions or to pay plan expenses. At December 31, 2024 and 2023, the forfeited nonvested accounts totaled \$94,366 and \$83,722, respectively. These amounts will be used to reduce future employer contributions or to pay future plan expenses. During the years ending December 31, 2024 and 2023, forfeited amounts totaling \$130,991 and \$52,678, respectively, were used to fund employer contributions and forfeited amounts totaling \$12,000, and \$4,019, respectively, were used to pay plan expenses.

### ***Participant Loans***

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which are calculated based on the current prime rate plus 1% at the time of each loan's origination. Principal and interest is paid ratably through monthly payroll deductions. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan payments, and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

### ***Payment of Benefits***

Upon termination of service, a participant is entitled to receive a lump-sum amount equal to the value of his or her vested interest. Forfeiture of a participant's nonvested interest will occur when a participant incurs a break-in-service. The Plan allows for in-service withdrawals as soon as a participant reaches 59 and ½ years of age.

### ***Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### ***Plan Expenses***

For the year ended December 31, 2024, the plan sponsor utilized \$12,000 from the forfeiture account towards the Plan's audit fee. Investment advisory fees of \$40,720, and recordkeeping fees of \$7,875 were also paid by the plan for the year ended December 31, 2024. Participant loan fees are charged directly to the relevant participant's account.

### ***Tax Status***

The Plan is a volume submitter plan provided by the Fidelity Management Trust Company, the trustee of the Plan. During 2022, Plan management adopted the most recent adoption agreement for the volume submitter plan. The significant change to the Plan as a result of this revised adoption agreement was to reflect the Hardship Distribution provisions of the Bipartisan Budget Act of 2018.

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

The Plan's federal tax returns are generally subject to examination by the Internal Revenue Service for three years after the date they are filed.

## **2. *SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES***

### ***Basis of Accounting***

As described in Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 946, *Financial Services – Investment Companies*, investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The statement of changes in net assets available for benefits is prepared on a contract value basis for the fully benefit responsive investment contract.

### ***Notes Receivable from Participants***

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. No allowance for loan losses has been estimated. Outstanding loan balances upon a participant's termination are treated as deemed distributions to the participant.

### ***Investment and Participant Loan Valuation and Income Recognition***

The Plan's investments are stated at fair value, except for the Common Collective Trust which is presented at contract value. See Note 3 for further discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Participant loans are valued at their outstanding balances, which approximate fair value.

### ***Use of Estimates***

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

## **3. FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The following is a description of the valuation methodologies used for assets measured at fair value in the accompanying statements of net assets available for benefits:

### ***Level 1 Fair Value Measurements***

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end. The quoted net asset values are based on the quoted market prices of the securities held by each mutual fund.

The common collective trust is a fully benefit-responsive investment contract and is presented at contract value, see Note 4.

The plan's assets at fair value as of December 31, 2024 and 2023, total \$46,717,803 and \$37,642,811, respectively, consist of mutual funds classified as Level 1 investments.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024, are reported as net appreciation in fair value of investments. For the year ending December 31, 2024, the net appreciation in the fair value of the investments consists of appreciation of \$4,518,086 from investments in mutual funds.

#### 4. *COMMON COLLECTIVE TRUST*

In 2007, the Plan added the Fidelity Advisor Stable Value Fund as an investment option, a common collective trust that is fully benefit-responsive. The Fund invests in wrap contracts which agree to pay the portfolio the difference between the contract value and the market value of the underlying assets once the market value has been totally exhausted. The Fund strives to maintain a \$1 unit price. The Fund offers two classes of units, Class I and Class II. The crediting rate is the discount rate that equates the estimated future market value of the portfolio's underlying assets with the portfolio's current contract value. The crediting rates are reset monthly. The wrap contracts provide a guarantee that the crediting rate will not fall below 0%. If the market value of the underlying assets is higher than their contract value, the crediting rate will ordinarily be higher than the average yield of the underlying assets. Investment income and the fund-level expenses are allocated on a pro rata basis to each class based on relative net assets of each Class to the total net assets in the Fund. In addition to management fees, Class II units are charged an additional monthly distribution fee. The Fund is included in the financial statements at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or portion of their investment at contract value.

The wrap contracts limit the ability of the Portfolio to transact at contract value upon the occurrence of the following events:

- The Plan's failure to qualify under Section 401(a) or Section 401(k) of the Internal Revenue Code
- The establishment of a defined contribution plan that competes with the Plan for employee contributions
- Any substantive modification of the Portfolio or the administration of the Portfolio that is not consented to by the wrap issuer
- Any change in law, regulation or administrative ruling applicable to the Plan that could have a material adverse effect on a Portfolio's cash flow
- Any communication given to participants by the Plan sponsor, any other Plan fiduciary or Fidelity Management Trust Company that is designed to induce or influence participants not to invest in the Portfolio or to transfer assets out of the Portfolio
- Any transfer of assets from the Portfolio directly to a competing investment option

Withdrawals initiated by a Plan sponsor will normally be provided at contract value as soon as practicable within twelve months following written notice to the trustee.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The average yield was 3.92% and 3.44%, and the crediting interest rate was 2.15% and 1.83% for the years ended December 31, 2024 and 2023, respectively.

A wrap issuer may terminate a wrap contract at any time. If the Fund's investment management authority over the portfolio is limited or terminated as well as if all of the terms of the wrap contract fail to be met, and if the market value of the portfolio is below the contract value at that time, the terminating wrap provider would not be required to make a payment to the Fund.

5. ***INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S CUSTODIAN***

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following investment information was certified by the Fidelity Management Trust Company and was not subjected to any auditing procedures except for comparing it to information included in the Plan's financial statements and supplemental Schedule H, line 4i—Schedule of Assets (Held at End of Year):

- a. Total investments as shown in the accompanying statements of net assets available for benefits of \$47,218,003 as of December 31, 2024, and \$38,128,893 as of December 31, 2023.
- b. Total investment income as shown in the accompanying statement of changes in net assets available for benefits of \$1,342,973.
- c. Net appreciation in fair value of investments shown in the accompanying statement of changes in net assets available for benefits of \$4,518,086.
- d. Total notes receivable from participants as shown in the accompanying statement of net assets available for benefits of \$616,746 as of December 31, 2024, and \$482,007 as of December 31, 2023.
- e. All investment-related information in the accompanying supplemental Schedule H, Line 4i—Schedule of Assets (Held at End of Year) as of December 31, 2024.

The information in Notes 3 was prepared in part or entirely from information certified by the Trustees.

6. ***RELATED PARTY TRANSACTIONS AND CONCENTRATIONS OF RISK***

Certain Plan investments are shares of mutual funds managed by Fidelity Management Trust Company. Administrative fees paid by the Plan for the year ended December 31, 2024, amounted to \$7,875. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Askey, Askey & Associates, CPA, LLC, is a service provider to the plan. Audit fees paid by the plan for the year ended December 31, 2024, amounted to \$12,000.

Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. All of the Plan's investments are managed by Fidelity Management Trust Company.

7. **RECONCILIATION OF FINANCIAL STATEMENTS TO SCHEDULE H OF FORM 5500**

The Form 5500 for the Plan is filed using the cash basis of accounting and reports the net assets available for benefits at fair value. Form 5500 does not include receivables for employer matching contributions of which there were none for the years ended December 31, 2024 and 2023. Form 5500 does not include receivables for employee contributions of which there were none for the years ended December 31, 2024 and 2023.
