## **Independent Auditor's Report**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of LIFE Benefit Plan Member 401(K) Plan (the "Plan"), formerly named League Member 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.



Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matter - Supplemental Schedules Required by ERISA**

The supplemental schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024, and Schedule H, Line 4(a) – Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, are presented for the purpose of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1 Description of Plan**

The following brief description of the LIFE Benefit Plan Member 401(K) Plan (the “Plan”), formerly named the League Member 401(k) Plan, is provided for general information purposes. Participants should refer to the *Plan Document and Summary Plan Description*, for a more complete description of the Plan’s provisions.

**General**

The Plan, a multiemployer plan, was adopted on July 1, 2007 under an agreement and declaration of trust with the League of International Federated Employees Union (“League”), the plan sponsor, and is a defined contribution plan, covering employees of individual employers who are obligated to contribute to the Plan under a collective bargaining agreement (“CBA”) with the League. Eligible employees of the employers who participate must be age 21 or older and have completed a four-month period of service. The plan sponsor controls and manages the operation and administration of the Plan, though the Board of Trustees is responsible for the oversight of the Plan. Sentinel Benefits and Financial Group (“Sentinel”) serves as the third-party administrator of the Plan, with Matrix Trust Company, LLC (“Matrix Trust”) serving as the custodian. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The IRS carried out an examination that required restatement of the Plan Document and a revision to the Plan’s trust agreement (see Note 8). This restatement included change to the plan name from League Member 401(k) Plan to the current name, LIFE Benefit Plan Member 401(K) Plan.

**Contributions**

Each year, participants may contribute up to the lesser of the maximum deferral amount allowed by the Internal Revenue Service (“IRS”), or 100% of pre-tax compensation. For 2024, the maximum allowable contribution limit was \$23,000; or if over the age of 50, participants may make a catch-up contribution which increased the maximum allowable contribution limit to \$30,500. Participants may also contribute amounts representing distributions from other qualified defined benefit and contribution plans (rollover). Discretionary profit-sharing contributions are employer decisions in any plan year pursuant to individual collective bargaining agreements with the Union. Employers contribute to the Plan on behalf of each participant who is eligible to share in matching contributions for the plan year. For the year ended December 31, 2024, employer contributions amounted to \$135,125.

**Participant Accounts**

Individual accounts are maintained for each plan participant. Each participant’s account is credited with the participant’s contribution and allocations of employer discretionary contributions and plan earnings, and is charged with allocations of administrative expenses in proportion to the total vested amount in their account. The

**Note 1 Description of Plan (continued)**

administrative expenses are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investments**

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a multitude of mutual funds as investment options for participants.

**Vesting**

Participants are vested immediately for their contributions plus actual earnings thereon. For employer contributions, participants become 25 percent vested in the remainder of their accounts after one year of continuous service, 50 percent after two years of continuous service, 75 percent after three years of continuous service, and 100 percent after four years of continuous service.

**Participant Notes Receivable**

The participants may borrow from their fund accounts, a minimum of \$1,000 up to a maximum of one-half of their vested account balance or \$50,000, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined at the time of the loan. Loans must be paid back within five years of borrowing, unless the loan is used to purchase a principal residence. If a loan is used to purchase a principal residence, the plan administrator, using his discretion, may permit a longer repayment term.

**Payment of Benefits**

On termination of service to employer due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annuitized according to the trust agreement. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Forfeitures**

The unvested portion of a participant's contribution account will be forfeited upon termination. Forfeitures can be used by the Plan to reduce its future expenses to the Plan or reallocated to remaining participants, pursuant to conditions as set forth in the Plan Document. During the years ended December 31, 2024 and 2023, forfeitures were \$4,661 and \$2,656 respectively. In 2024, all forfeitures were used to reduce plan expenses. In 2023, \$617 of the forfeitures were used to reduce plan expense, the remainder of \$2,038 was used to reduce plan expenses in 2024, and none was allocated to remaining participants.

**Note 2 Summary of Significant Accounting Policies**

**Basis of Presentation**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

**Contributions Receivable**

Contributions receivable represent uncollected contributions due to the Plan under the terms of the CBAs between the Plan and various participating employers.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan’s gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan Document. The loan interest rates had a range of 4.25% to 9.50% as of December 31, 2024.

**Payment of Benefits**

Benefit payments to participants are recorded when paid.

**Administrative Expenses**

Administrative expenses of the Plan not related to investments have been absorbed by the participating employers and participant accounts pursuant to the trust agreement. The expenses are allocated among the accounts of all participants in the Plan. Expenses that are paid by the participating employers are excluded from the Plan’s financial statements.

**Note 3 Investments**

The Plan's investments are held by a custodian.

Dividends, realized appreciation (depreciation), and unrealized appreciation (depreciation) are recognized as investment income (losses) when the investments are marked to market during the respective plan year.

During 2024, the Plan's investments, including gains and losses on investments bought and sold as well as held during the year, appreciated in value by \$175,244.

**Note 4 Fair Value Measurements**

The framework for fair value measurement and disclosures provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820-10 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price reported by the fund. These funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively trading at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5 Related Party Transactions and Party-in-Interest Transactions**

The Plan shares offices with the plan sponsor, League of Federated Employees Union and Life Benefit Plan (a welfare plan). However, due to the fact that the Plan uses a third-party administrator, there are no joint expenses allocated.

Certain Plan investments are managed by Matrix Trust Company, the custodian for the Plan. The Plan or plan sponsor may make payments to Matrix Trust Company for administrative expenses. Therefore, these transactions qualify as party-in-interest transactions.

Sentinel Benefits provides certain administrative services to the Plan pursuant to an agreement between the Plan and Sentinel Benefits.

The Plan had notes receivable from participants of \$134,994 and \$112,545 for the years ended December 31, 2024 and 2023, respectively. These notes receivable are considered to be party- in-interest transactions.

The Plan Sponsor, Life Benefit Plan, paid the plan’s accounting, legal, and insurance expenses for 2024 and 2023 on behalf of the plan.

**Note 6 Plan Termination**

Although it has not expressed any intention to do so, the plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants’ accounts would become 100% vested and distributed in accordance with the provisions of the Plan.

**Note 7 Information Prepared and Certified by the Plan’s Custodian**

Matrix Trust, the Plan’s custodian, executes the Plan’s transactions and provides other administrative services as well as other administrative costs which are absorbed by the Plan.

The following summary of the Plan’s assets and income information as of December 31, 2024 and 2023 and for the year ended December 31, 2024, included in the Plan’s financial statements and supplemental schedules, was obtained by data that has been prepared and certified to be complete and accurate by the custodian.

**Note 8 Tax Status of Plan**

The Plan is under an advisory letter dated September 4, 2001, received from the Internal Revenue Service (IRS). The IRS states in this letter that plans covered by this letter come under its volume submitter program and are in compliance with the applicable requirements of the Internal Revenue Code. The Plan had also received a favorable determination letter dated November 11, 2011, covering the 2004 cumulative list of changes in plan qualification requirements. In 2021, the IRS began an examination of the Plan’s Form 5500 for the plan year ended December 31, 2019. In 2022, the IRS concluded that the Plan, as a multiemployer plan, could not use a preapproved plan and must be restated or the IRS will revoke the qualified status of the Plan and the associated trust under Code sections 401(a) and 501(a) retroactively to the Plan year beginning January 1, 2003.

The Plan had agreed to be restated by adopting a qualified individually designed plan. The Plan’s administrator hired an ERISA attorney which restated the Plan Document,

**Note 8 Tax Status of Plan (continued)**

which was submitted and approved by the IRS. The Plan has also submitted the Plan's revised trust agreement, which was also approved by the IRS. The IRS did not issue any fines or sanctions to the Plan in connection with the examination, and all the actions required by the IRS have been completed. The restatements described above also included a change to the plan name from League Member 401(k) Plan to LIFE Benefit Plan Member 401(K) Plan.

Plan management and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS and the Department of Labor. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements other than discussed above. As noted, the Plan is subject to routine audits by taxing jurisdictions.

**Note 9 Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities. Due to the high level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. Given recent volatility in financial markets, the values of the Plan's individual investments have and will continue to fluctuate in response to changing economic and market conditions and therefore it is reasonably possible that investment value could decline in subsequent periods.

**Note 10 Delinquent Participant Contributions**

Delinquent participant contributions amounting to \$239,369, of which \$124,090 related to 2023, were corrected in 2024, and \$115,278 related to 2024 were uncorrected as of December 31, 2024 and were corrected in 2025. Participants' contributions were withheld from participants' pay on a weekly or bi-weekly basis but were not remitted to the Plan in a timely manner in accordance with the Department of Labor requirements. As of October 6, 2025, the lost earnings

applicable to these delinquent contributions of \$482 have been corrected and received by the Plan. This payment was made on behalf of the Plan by the plan sponsor.

**Note 11 Subsequent Events**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 6, 2025, the date the financial statements were available to be issued.
