INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Accordingly, no such opinion is expressed.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE A – DESCRIPTION OF THE PLAN

The following description of American Apartment Management Tax Deferred Savings Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of AAMCI - Management, Inc. (Company) who have attained age 21 and have completed one year of service (a consecutive twelve-month period during which 1,000 hours of service are completed). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants are automatically enrolled to defer 1% of pretax annual compensation, as defined in the Plan, unless a different percentage is chosen. If a different percentage is not chosen, the deferral percentage automatically increases each calendar year by 1% up to a maximum percentage of 5% through plan year ended December 31, 2016, and 10% thereafter. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company contributes a safe harbor matching contribution equal to 100% of each participant's elective contribution up to 5% of compensation. The Company may contribute additional discretionary and/or qualified non-elective contributions at the direction of the Company's Board of Directors. All Company contributions are invested at the participant's direction.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the employer's contribution plus actual earnings thereon.

Payment of Benefits

On termination of service, a participant may receive either a lump-sum distribution amount equal to the value of the participant's account or distribution in various annuity options. Upon reaching age 59.5, participants may elect to have in-service withdrawals. Hardship withdrawals are available to active participants while in service. In the event of a participant's death, disability, or attaining normal retirement age, and a distributable event has occurred, distributions will commence as soon as administratively possible following the date the participant, or beneficiary of a deceased participant, requests a distribution.

Forfeited Accounts

Forfeited accounts, if any, may be used to pay administrative expenses of the Plan or to offset any employer contributions. Forfeitures used to reduce employer contributions during the years ended December 31, 2024 and 2023 were \$2,362 and \$0, respectively. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$211 and \$2,607, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The Loans are secured by a percentage of the participant's vested account balance and bear interest at such a reasonable rate as determined periodically by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value as certified by the trustee Ascensus Trust Company and Newport Trust Company, LLC (Ascensus Trust Company). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Although participant's accounts are charged with an allocation of some administrative expenses, the Company also absorbs significant costs of maintaining the Plan.

Date of Management's Review

Subsequent events were evaluated through October 13, 2025, the date the financial statements were available to be issued.

NOTE C – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Values at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

- Self-directed brokerage accounts: Underlying investments are corporate stocks, which are valued at closing price reported on the active market for which the individual securities are traded.
- Common/collective trusts: Valued at the NAV per unit of the funds, based on the market value of its underlying investments. The NAV of the fund is calculated daily and distributions from net investment income and net realized gains are retained by and reinvested by the fund. The NAV is considered made available to its current or prospective investors through investors accessing their online balances. The investments in the common collective trusts are primarily comprised of stocks and bonds.

NOTE D – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by Ascensus Trust Company. Ascensus Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for contract administration amounted to \$17,093 and \$16,964 for the years ended December 31, 2024 and 2023, respectively.

The Plan's independent auditor and investment advisor are also parties-in-interest under ERISA. Fees expensed by the Plan for these audit and/or investment advisory services amount to \$48,889 and \$49,455 for the years ended December 31, 2024 and 2023, respectively. Fees included in administrative expenses payable were \$7,500 and \$0 for the years ended December 31, 2024 and 2023, respectively.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE F – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE G – TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Employer by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE I – SUBSEQUENT EVENTS

Subsequent to December 31, 2024, the Plan had distributions totaling approximately \$515,066 through September 10, 2025, resulting largely from the distribution of a significant death benefit.
