Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters – Supplemental Schedule Required by ERISA

The supplemental schedule listed in the table of contents is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1. Description of Plan

The following description of Sevita 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of National Mentor Holdings, LLC (Company) and its subsidiaries. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

The Retirement Committee of the Company is the Plan's administrator and Fidelity Management Trust Company (Fidelity) is the Plan's trustee.

Eligibility

Regular full time Non-Direct Support Professionals, as defined in the plan document, are generally eligible to participate in the Plan as of the first day of the beginning of the first quarter following the date of employment and attaining the age of 21.

Part-time Non-Direct Support Professionals, as defined in the plan document, are generally eligible to participate in the Plan as of the first date of the beginning of the first quarter following the completion of one year of service (with at least 1,000 hours) and attaining the age of 21.

Direct Support Professionals generally were permitted to participate in the Plan on the next quarterly entry date following the completion of one year of service (with at least 1,000 hours) and attaining the age of twenty-one. Effective June 26, 2024, full-time Direct Support Professionals generally were permitted to participate in the Plan on the next quarterly entry date following the completion of six months of service and attaining the age of twenty-one, and part-time Direct Support Professionals generally were permitted to participate in the Plan under the same eligibility terms as part-time Non-Direct Support Professionals.

Additionally, effective January 1, 2024, as part of the *SECURE ACT* and *SECURE Act 2.0*, long-time part-time employees will be permitted to participate in the Plan to the extent required by applicable law.

Participant Contributions

Eligible participants may elect to contribute up to 75% of their eligible pre-tax annual compensation, as defined by the Plan, limited to the maximum amount allowable under the provisions of the Internal Revenue Code (IRC). In addition, participants who are 50 years of age or older as of December 31, 2024, may contribute an additional "catch up" contribution. The Plan also allows participants to defer funds to the Plan as Roth contributions. These deferrals are subject to federal income taxes, and the maximum allowable participant contribution is the IRC limit combined between both the Roth and the pre-tax deferral. The Plan currently offers various mutual funds and a collective trust as investment options for participants.

The Plan also allows rollover contributions from other qualified plans as defined in the Plan document.

Employer Contributions

Each year the Company may make a discretionary matching contribution on behalf of each participant enrolled in the Plan. The discretionary matching percentage requires a participant to have made elective deferrals and be employed on the last day of the Plan year. For the year ended December 31, 2024, the matching contribution was equal to 50 cents of every dollar contributed not to exceed 50% of the first 3% of a participant's eligible compensation. The Company elected to make a matching contribution for the year ended December 31, 2024, totaling \$7,811,409.

Additional contributions in excess of the matching contributions may be made at the discretion of the Company's board of directors (discretionary contributions). To be eligible, an employee must be employed on the last day of the Plan year. The allocation of discretionary contributions to individual participant accounts is determined on a pro-rata basis using the participants' gross compensation within the applicable business unit. The Company elected not to make a discretionary contribution for the year ended December 31, 2024.

Rollover Contributions

The Plan may receive, on behalf of a participant, rollover contributions from another qualified plan prior to meeting eligibility requirements of the Plan. These contributions are 100% vested upon contribution.

Participant Accounts

Each participant's account is credited with the participant's contribution and its allocation of (a) the Company's contributions and (b) plan earnings or losses and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Effective January 1, 2021, all participant accounts balance in the Plan as well as all subsequent contributions will be fully vested at all times. Any account balances forfeited prior to January 1, 2021, will become fully vested when and if the participant is reemployed and qualifies to have the previously forfeited account reinstated.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Participants may borrow against their own accounts in an amount of not less than \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may not have more than one loan outstanding at one time. All general-purpose loans must be repaid in full by the fifth anniversary date of the loan. Loans for the purchase of a primary residence must be repaid by the twentieth anniversary date of the note.

Participants repay principal and interest through payroll deductions. During the repayment period of the loan, the trustee reallocates the repayment amounts among the investment funds in the same proportion as current investment allocations. All loans have a fixed interest rate set at inception at prime rate plus 1%.

Payment of Benefits

Upon termination of employment, retirement, death or disability, the participant or the participant's beneficiary is entitled to receive the vested portion of the participant's account in a single lump-sum or installment payments, in accordance with Internal Revenue Service (IRS) regulations and Plan provisions. Further, withdrawals from the Plan before leaving the Company are available for special "hardship" reasons (as defined) or after attaining the age of 59½. Distributions to participants are recorded when paid.

Forfeiture Accounts

At the discretion of the Company, forfeitures may be used as follows: (i) to pay administrative expenses, if any; (ii) to reduce any employer matching contributions made for the Plan year; (iii) to reduce other discretionary contributions; and (iv) as additional discretionary contributions to the Plan for the Plan year.

At December 31, 2024 or 2023, the forfeiture account contained available forfeitures of \$118,371 and \$14,919, respectively.

Other Income

Certain mutual fund and collective trust expenses that are charged by the mutual fund companies to the individual participants are credited to the Plan on a quarterly basis. These assets are held in a reserve account and may be used to pay expenses of the Plan, as described in the agreement. Amounts unused for expenses may be allocated to eligible participant accounts based upon each participant's pro rata percentage of total Plan investments. Such allocation is permitted to take place no more frequently than on a quarterly basis.

As of December 31, 2024 or 2023, the balance in the reserve account amounted to \$49,251 and \$91,881, respectively. During the year ended December 31, 2024, funds credited to the Plan amounted to \$2,743, and are included in other income in the accompanying statement of changes in net assets available for benefits. Funds totaling \$45,373 were used to pay Plan expenses during the year ended December 31, 2024.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's sponsor determines the Plan's valuation policies utilizing information provided by the trustee. See Note 8 for discussions of fair value measurements.

Realized gains and losses on investments sold and the unrealized appreciation and depreciation of investments held are reported on an average current cost basis, based on fair market value of the investments at the beginning of the plan year or at the time of purchase during the plan year.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Administrative Expenses

Expenses incurred in the administration of the Plan are paid by the Company or by the Plan.

Refundable Contributions Due to Participants

Amounts payable to participants for contributions in excess of amounts allowed by the IRC are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 contributions to the applicable participants prior to March 15, 2025.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

Effective July 1, 2025, the Plan was amended for the following provisions:

- Vesting schedules were amended for nonelective employer contributions and matching employer contributions, changing from immediate vesting to a three-year cliff vesting schedule.
- Further, the amendment specified that participants who were hired prior to July 1, 2025, were not subject to the amended vesting schedules. The vesting remains immediate for these participants and applies to profit sharing and match contributions.
- The list of participating employers was amended to add additional related employers.
- Eligibility service requirements for full-time direct support professionals was amended to remove differing service requirements.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Tax Status

The Plan operates under a pre-approved plan document, which has received a favorable opinion letter from the IRS dated June 30, 2020. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes and represents that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Financial Accounting Standards Board (FASB) has issued a standard regarding the accounting and recognition of income tax positions taken or expected to be taken by the Plan. The plan administrator assesses the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and the Plan assets are distributed in accordance with the terms of the Plan.

Note 6. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Company provides certain accounting, recordkeeping and administrative services to the Plan for which it receives no compensation. Certain Plan investments are managed by Fidelity and its affiliate Strategic Advisors, Inc. Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Fidelity for administrative services were \$827,895 and fees paid by the Plan to Strategic Advisors, Inc. for asset management were \$159,464 for the year ended December 31, 2024. Fees paid by the Plan to Fidelity for certain investment manager services were included as a reduction of the return earned on each fund. The Plan utilizes the services of a consultant and financial advisor, CapFinancial Partners, LLC, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for consulting and investment advisory services totaled \$59,662 for the year ended December 31, 2024.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Fair Value Measurements

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the

asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Significant unobservable inputs, including the Company's own assumptions in determining the fair value of investments.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 and Level 3 inputs are only used when higher level inputs are not available.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurements.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts: Valued based on the underlying unit value of the assets held. The assets on the underlying funds are invested in mutual funds, equity securities, and debt securities. The NAV of the units of the accounts is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

Money Market Fund: Valued at the closing price reported by the fund sponsor from an actively traded exchange.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
