Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Otter Tail Corporation Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Otter Tail Corporation Employee Stock Ownership Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Otter Tail Corporation Employee Stock Ownership Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Otter Tail Corporation Employee Stock Ownership Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Note 1 - Description of Plan

The following brief description of Otter Tail Corporation Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that provides eligible employees of Otter Tail Power Company (Company) with the opportunity to acquire ownership of Otter Tail Corporation common stock (common shares) through the Plan. The Plan is closed to new entrants from Otter Tail Corporation employees, but there are Otter Tail Corporation participants who are part of the Plan that no longer receive a contribution allocation. Otter Tail Corporation is the parent company of Otter Tail Power Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Benefits Administration Committee of the Company.

Eligibility

Employees of the Company are eligible to participate in the Plan if they have completed one year of service and are 21 years of age. A year of service for purposes of eligibility is a consecutive 12-month period during which the employee has 1,000 or more hours of service. A participant must be employed on the last working day of a Plan year in order to receive a contribution.

Entry Date

Employees may enter the Plan on the first day of the month coincident with or next following the date they are hired.

Contributions

The Company determines the contribution amount annually. Common shares contributed to or purchased by the Plan are allocated to the accounts of participating employees based upon the recognized compensation of all participants in the Plan. During 2024, the Company contributed a cash payment of \$285,520 to the Trustee to purchase common stock shares on the open market and allocate to eligible participants for the 2023 Plan year. Subsequent to December 31, 2024, the Company contributed a cash payment to the Trustee to purchase common stock shares on the open market. Common stock shares with a fair value of \$265,224 were purchased on the open market by the Trustee and allocated to eligible participants for the 2024 Plan year. Employee contributions are not permitted.

Participant Accounts

Each plan participant's account is credited with the allocation of the Company's discretionary contribution. Contributions are allocated based on the ratio of the participant's recognized compensation to the total recognized compensation of all qualifying participants as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. The Plan holds certain shares that may be distributed pre-tax and some that may be distributed post-tax. Plan earnings and losses are allocated to each participant's account based on the ratio of the participant's account balance.

The following is a breakdown of the pre-tax share value versus the post-tax share value:

Vesting

Each participant is immediately vested in all the common shares and other assets allocated to their account.

Payment of Benefits

Participants may elect to receive either a lump-sum amount, installments, or a combination of the two, as defined in the plan document upon death, disability, attainment of age 70½, termination of employment, or termination of the Plan. Any terminated participants with a balance of less than \$1,000 shall be distributed in the form of an involuntary cash-out. Distributions may be made at the participant's election prior to termination upon attainment of age 55 and at least 10 years of service.

Distributions to a Participant attributable to company stock shall be substantially equal annual installments over a period not longer than fifteen years.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. The election to diversify is made subsequent to year-end based upon the shares of employer stock in the participant's account at year-end.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, the accounts of each participant shall be distributed to the respective participant.

Note 2 - Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Benefits Administration Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and other third parties. See Note 4 for discussion of fair value measurements.

Notes to Financial Statements

December 31, 2024 and 2023

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Realized gains and losses are recognized on distributions to participants or beneficiaries. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year. Participants are allowed the option of a cash payment or reinvestment of dividends received.

The classification of investment earnings (losses) reported in the statement of changes in net assets available for benefits may differ from the classification of earnings (losses) on Form 5500 due to different reporting requirements on Form 5500.

Payments of Benefits

Benefit payments to participants are recorded when paid.

Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

The Plan sponsor has evaluated the subsequent events through October 9, 2025, the date which the financial statements were available to be issued.

Note 3 - Investments

The Plan held 577,248 and 665,407 shares of the Company's common stock at December 31, 2024 and 2023, respectively. The price per share on the Company's stock was \$73.84 and \$84.97 as of December 31, 2024 and 2023, respectively. The Plan conducts transactions with parties-in-interest, which include the Company, the trustee and the participants of the Plan. Realized/unrealized appreciation is as follows:

During 2024, the Plan purchased 34,846 shares of common stock for \$2,938,139. The Plan had distributions in kind of 123,005 shares of common stock for \$10,381,456.

During 2023, the Plan purchased 45,364 shares of common stock for \$3,309,443. The Plan had distributions in kind of 130,314 shares of common stock for \$9,972,908.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Common Stock – Valued at the closing price reported on the active market on which the individual securities are traded.

Note 5 - Certified Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal) (the trustee of the Plan).

Note 6 - Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated August 14, 2017, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. Subsequent to the issuance of the determination letter, the Plan was amended. However, the Company, Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and, therefore believe the Plan is qualified and the related trust continues to be tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Related Party and Party-In-Interest Transactions

Certain Plan investments are shares of common stock of the Company. In addition, the Plan received \$1,155,497 and \$1,234,586 in dividends from the Company for the years ended December 31, 2024 and 2023, respectively. These are related party and party-in-interest transactions.

Note 8 - Risks and Uncertainties

The Plan invests in the common stock of the Company. Investment securities, in general, are exposed to various risks, such as overall market volatility. Market risks include global events which could impact the value of investments, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
