### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Medical College of Wisconsin Inc. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **(1) Description of the Plan**

The following description of The Medical College of Wisconsin, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**(a) General**

The Plan is a deferred compensation plan that satisfies the Internal Revenue Code (IRC) of 1986, as amended, Section 403(b) covering employees of The Medical College of Wisconsin, Inc. (the Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Medical College of Wisconsin's Board of Trustees (the Board of Trustees) is responsible for oversight of the Plan. The Retirement Plan Committee, as delegated by the Board of Trustees, determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Trustees.

**(b) Plan Administration**

The Plan is administered by the Plan Sponsor. TIAA Individual & Institutional Services, LLC (TIAA), Fidelity Management Trust Company, Lincoln National Life Insurance Company (Lincoln), Variable Annuity Life Insurance Company (VALIC), State Street Bank and Trust Company (State Street), and Transamerica Financial Life Insurance Company, Inc. (TFLIC) are the Custodians of the Plan.

Transamerica Retirement Solutions (Transamerica) is the recordkeeper and State Street and TFLIC are the primary custodians of the Plan. In 2024, contributions were deposited with State Street and TFLIC and reported by Transamerica.

**(c) Contributions**

Participants can make voluntary (elective) contributions to the plan immediately upon hire. Voluntary contributions are not matched by the Plan Sponsor. Participants may direct contributions to a variety of investment options.

Upon reaching the eligibility date, participants must make a non-elective contribution of 6% of their pretax annual compensation, as defined by the Plan. The Plan Sponsor makes non-elective contributions to the Plan equal to 8% of the employee's compensation. Contributions are subject to certain IRS limitations.

Effective May 1, 2020, the Plan was amended to allow the non-elective contribution percentage to be modified, either retrospectively or prospectively, by approval of the Board of Trustees with delegated authority to the Retirement Plan Committee.

**(d) Participant Accounts**

Individual custodial accounts are maintained for each plan participant. Each participant's account is credited with their elective and non-elective contributions, Plan Sponsor non-elective contributions and earnings thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participants' earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**(e) Vesting**

Participants are vested immediately in their contributions, Plan Sponsor non-elective contributions and actual earnings thereon.

**(f) Payment of Benefits**

Participants may receive all or a portion of their vested account balance upon termination of employment, early retirement (defined as age 59½ years of age), death or disability. Benefits are payable upon retirement as an annuity, installment, partial payout or a lump-sum payout, depending on the custodial arrangement. Participants who terminate employment prior to retirement may elect to have their balance distributed in a lump sum or transferred to an individual retirement account (IRA) or another employer's qualified plan. Death benefits are paid according to the benefits election in effect at the time of death.

**(g) Notes Receivable from Participants**

The Plan allows participants to borrow from their accounts, in an amount ranging from \$1 up to the lesser of \$50 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate as indicated in The Wall Street Journal at the date of loan origination (rates of 7.50% to 8.50% and 4.25% to 9.50% in 2024 and 2023, respectively).

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**(2) Summary of Significant Accounting Policies**

**(a) Basis of Accounting**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

**(b) Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see note (5) Fair Value Measurement). Purchases and sales of securities are on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**(c) Benefits Paid to Participants**

Benefits paid to participants are recorded when paid.

**(d) Administrative Expenses**

Investment management fees and operating expenses for investments in mutual funds are deducted from income earned on a daily basis and are not separately presented. Consequently, the investment management fees, and operating expenses are reflected as a reduction of investment return for such investments. Administrative expenses for account maintenance and early surrender fees charged by the Custodians that are paid by the participants are reflected as administrative expenses. Each participant is assessed a quarterly administrative fee to cover certain administration expenses. Other administrative expenses of the Plan are paid by the Plan Sponsor.

**(e) Use of Estimates**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Sponsor to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023 and net appreciation, interest and dividends, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by the Plan Sponsor and agreed to or derived from information certified as complete and accurate by the Custodians.

**(4) Insurance Company Guaranteed Investment Contracts**

The Plan has guaranteed investment contracts with certain Custodians that are issued by TIAA, Lincoln, VALIC, and New York Life Insurance Company (NYL) (the Issuers). One TIAA guaranteed investment contract is a traditional investment contract that does not meet the fully benefit-responsive investment contract criteria and is reported at fair value. One TIAA guaranteed investment contract, along with the Lincoln, VALIC, and the NYL guaranteed investment contracts, are traditional investment contracts that meet the fully benefit-responsive investment contract criteria and are reported at contract value. Contract value is the relevant measurement for fully-benefit responsive investment contracts because this is the amount received by participants if they initiate permitted transactions under the terms of the Plan. The contract value represents the accumulated cash contributions and interest credited to the contract, less any withdrawals and administrative expenses.

The TIAA Traditional Annuity is a guaranteed fixed annuity contract that is guaranteed by TIAA. The TIAA Traditional Annuity, which is no longer an investment option for plan participants, was offered through a variety of contract types, including Retirement Annuities (RA) and Group Retirement Annuities (GRA). The type of contract through which a participant invested in the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant's account, and the options for receiving income upon retirement.

During the accumulation phase of the contract, contributions were used to purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium was paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by TIAA's claims-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate. For accumulating RA and GRA, the crediting interest rate was 4.61% and 4.56% as of December 31, 2024 and 2023, respectively.

The Lincoln Fixed Annuity is a guaranteed fixed annuity contract that is no longer an available investment option for plan participants. During the accumulation phase of the contract, contributions were credited with the rate of interest in effect at the time the contribution was made. The participant's principal is guaranteed by the claims-paying ability of Lincoln National Life Insurance Company. Interest is credited daily at a specified minimum interest rate. The minimum interest rate is 3.0% or 3.5% depending on the contract held. The interest-crediting rate is declared on a quarterly basis. Transfers from the Lincoln Fixed Annuity to any other plan investment type could be limited to 25% of the account value in any 12-month period. Lincoln is not currently enforcing this restriction but reserves the right to impose the limit at any time in the future without advance notice.

The VALIC Fixed Accounts are investments guaranteed at a fixed rate of return. VALIC is no longer accepting new plan participants to the MCW plan. During the accumulation phase of the contract, the participant's principal, plus a specified rate of interest, is guaranteed by VALIC's claims-paying ability. The minimum interest rate in 2024 was 1.0% to 4.5% depending on the plan and the investment.

The NYL Guaranteed Interest Account is a general account group annuity contract that is currently available to plan participants. The participant's principal is guaranteed by the claims-paying ability of NYL. Interest is

credited daily at a specified minimum interest rate. The minimum interest-crediting rate is 3.0% for January 1, 2024 and 3.0% for July 1, 2024. Rates are declared on January 1 and July 1 and will always range from 1.00% to 3.00%. Participants can initiate withdrawals on a daily basis at contract values but are restricted from transferring balances immediately to competing funds. Any balances transferred to non-competing funds cannot be subsequently transferred to competing funds for 90 days. Competing funds include money market funds, other guaranteed investment contracts and bond funds with a duration of 3 years or less. Participants have the option to annuitize their balance at guaranteed annuity purchase rates.

The Plan's ability to receive amounts due in accordance with its fully benefit-responsive contracts is dependent on the issuers' ability to meet their financial obligations. This may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuers. These events may be different under each contract. No such events are probable of occurring.

**(5) Fair Value Measurement**

Financial Accounting Standards Board Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement* (ASC Topic 820), establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy are as follows:

- Level 1 inputs are quoted prices (unadjusted) that are observable in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2 inputs are observable inputs, other than quoted prices included within Level 1, such as quoted prices for similar assets or liabilities or quoted prices in markets that are not active, that are observable for the asset or liability, either directly or indirectly.
- Level 3 inputs are unobservable inputs, where there is little or no market data, requiring the Plan to develop its own assumptions of fair value for the asset or liability.

The level in the fair value hierarchy within which a fair value measurement falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

The following is a description of the valuation methodologies used for assets measured at fair value:

**(a) Mutual Funds**

Shares in funds in registered investment companies are valued based on observable market quotation prices of the assets.

The College Retirement Equities Fund (CREF) is also a registered investment company. The fair values of accumulation units held by the Plan in CREF accounts are based on each account's daily NAV, which is considered by the Plan to be the best approximation of fair value. CREF accounts are classified within Level 1 of the fair value hierarchy. CREF accounts are not exchange-traded but data for NAVs are available daily to the Plan and client investors on TIAA's website and provides sufficient corroborative evidence to ascertain the relationship between each fund's NAV and the values of individual underlying holdings. Underlying holdings are primarily valued using market quotations or prices obtained from independent pricing sources. There are no unfunded commitments from participants in the Plan who invest in these accounts.

**(b) Self-directed Brokerage Accounts**

Investments in self-directed brokerage accounts are valued based on observable market quotation prices of the individual assets. The accounts include investments in cash and cash equivalents, common stock and mutual funds.

**(c) Insurance Company Guaranteed Investment Contracts**

These investments are contract-based, observable prices for identical or similar investments do not exist, and accordingly, these investments are valued using unobservable inputs (Level 3). The fair value is determined by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer (see note 4). Liquidity restrictions apply to certain types of contracts that could impact the value realized upon exiting the contract.

**(d) Pooled Separate Accounts**

The fair value of the Plan's interest in the TIAA Real Estate account is based on the funds' daily NAV. Underlying holdings are primarily valued using independent appraisals, independent pricing sources, or other observable market quotation prices. Liquidity needs for withdrawals are met by the general accounts, if needed.

- i. The Lincoln National Life Multi-Fund is a fund consisting of separate accounts. These separate accounts purchase specific insurance company shares of certain mutual fund families at the direction of the participant. The mutual funds offered in the Lincoln National Life Multi-Fund invest principally in equity securities, fixed-income instruments and short-term investments, in accordance with each portfolio's investment objectives. The Lincoln National Life Multi-Fund allows lump-sum cash withdrawals up to 15% of the account value during any contract year with no surrender charge. Amounts withdrawn in excess of the 15% are subject to a declining surrender charge over seven or eight years depending on the product (6% or 7% in the first year, declining to 1% in the final year and no surrender charges thereafter). There is no surrender charge if an annuity distribution option is selected.

- ii. For the TIAA Traditional Annuity, the RA contract does not allow lump-sum cash withdrawals and transfers must be spread over 10 annual installments. With the GRA contract, lump-sum withdrawals are available within 120 days of termination of employment and are subject to a 2.5% surrender charge. All other withdrawals and transfers from RA and GRA contracts must be spread over 10 annual installments (five annual installments for withdrawals after termination of employment). When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits.
- iii. The TIAA Real Estate account is a separate account investing mainly in real estate properties and real estate-related investments. The investments are valued daily but redemptions are limited to one per calendar quarter.

**(6) Income Tax Status**

The Plan is intended to comply with the applicable requirements of Section 403(b) of the IRC. A tax determination letter program is not available for IRC Section 403(b) plans through the Internal Revenue Service (IRS). The Plan Sponsor believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(7) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**(8) Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.
