Opinion

We have audited the accompanying financial statements of Jefferies Financial Group Inc. Savings and Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in assets available for benefits for the year ended December 31, 2024, and the related notes to financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the assets available for benefits of Jefferies Financial Group Inc. Savings and Retirement Plan as of December 31, 2024 and 2023, and the changes in its assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

Notes to Financial Statements

1. Description of the Plan

The following description of the Jefferies Financial Group Inc. Savings and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document and summary plan description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which covers employees of Jefferies Financial Group, Inc. and certain subsidiaries (collectively, the Plan Sponsor or the Employer), age 18 or older, who have completed ninety days of service. The Plan is intended to be a qualified retirement plan under the Internal Revenue Code (IRC), and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. T. Rowe Price Trust Company is the custodian and recordkeeper for the Plan.

Contributions

Contributions are made to the Plan by both participants and the Employer. Participating employees may contribute up to 50% of their annual eligible pre-tax compensation and up to 15% of their annual eligible after-tax compensation not to exceed the dollar limit set by the IRC of \$23,000 (\$30,500 for employees who were age 50 or older) for the year ended December 31, 2024. The Plan has an additional limit that after-tax compensation may not exceed \$32,000.

For employees hired on or after March 1, 2018, the Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

For employees hired prior to January 1, 2014, the Employer provides a matching contribution to the Plan in an amount equal to 50% of employee's pre-tax contributions that do not exceed 6% of the employee's compensation, subject to IRS limitations. Employees hired on or after January 1, 2014, receive an Employer matching contribution in an amount equal to 25% of the employee's pre-tax contributions.

The Employer also makes annual contributions to the Plan for employees earning less than \$300,000 annually that were hired prior to January 1, 2014. The annual contribution is a percentage of the employee's wage which is calculated based on the employee's age and service term. Employees hired on or after January 1, 2014 are not eligible for these annual Employer contributions.

Rollover contributions are assets transferred to the Plan by participants who receive distributions from other qualified plans and are subject to the consent of the Plan Administrator. Rollover contributions become part of the participant's account but are not entitled to any Employer matching contribution.

Participant Accounts

Each participant's account is adjusted for the participant's contribution, the Employer's matching contribution, Employer contributions based on age and service, earnings, expenses, gains, and losses specifically identified with the participant's account. The benefit to which a participant is entitled is the participant's vested account balance. Participants direct the investment of funds held in their accounts in the Plan.

Vesting

Participants are vested immediately in their contributions and Employer matching contributions plus actual earnings thereon. Vesting in Employer contributions based on age and service, and earnings thereon, is based on years of continuous service and are fully vested upon three years of continuous service.

Payment of Benefits

Upon a participant's death, retirement, or termination of employment, a participant or his/her beneficiaries may elect to receive a distribution equal to the vested balance in his/her account in a single, lump-sum cash payment or through various annuity options.

In all instances, if a participant's vested account balance does not exceed \$1,000, the trustee will distribute the balance in a lump sum payment as soon as administratively practicable. Under certain circumstances, including financial hardship, participants may withdraw their contributions.

Notes Receivable from Participants

Participants may borrow the lesser of \$50,000, or 50%, of their vested account balance with a minimum loan amount of \$1,000. The loans are secured by an assignment of a participant's vested interest in the Plan, and bear interest at prime rate plus 2%. Principal and interest are paid ratably through payroll deductions or as a lump sum for the outstanding loan balance. Loan terms range from one to fifteen years. As of December 31, 2024, participant loans had maturities through 2036 at interest rates ranging from 5.25% to 10.50%.

Forfeitures

Forfeitures of non-vested participant account balances are used to reduce future Employer contributions to the Plan. Forfeitures used for the year ended December 31, 2024 were \$114,089 and forfeited accounts totaled \$493,049. Forfeited balances earned \$8,236 during the year ended December 31, 2024. As of December 31, 2024 and 2023, the balance of the forfeiture account was \$389,256 and \$2,060, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in securities that are exposed to various risks, such as interest rate, currency exchange credit, and the overall fluctuation in the market. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the accompanying statements of assets available for benefits.

Investment Valuation and Income Recognition

The Plan's investments in mutual funds are valued at fair value based on quoted market prices in active markets. Noninterest bearing cash is stated at face value which approximates fair value. The Plan's investment in the common trust fund is valued based on net asset value as determined by using the estimated fair value of the underlying assets held in the fund. Net asset value is used as a practical expedient for fair value.

Net appreciation (depreciation) in fair value of investments represents the difference between the carrying value (which represents the prior year ending value or cost if the investment was purchased during the current year) and the fair value of investments held at year-end and includes both realized and unrealized gains (losses). Realized and unrealized gains (losses) on investments are recognized currently. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Dividends are reinvested as earned. Interest income is recorded on the accrual basis.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based on the Plan document.

Payment of Benefits

Benefits are recorded when paid by the Plan.

Administrative Expenses

Plan administrative expenses may be paid by the Plan or the Plan Sponsor at the Plan Sponsor's option. During the year ended December 31, 2024, the Plan Sponsor paid all but \$2,520 of administrative expenses.

Subsequent Events

Plan management has evaluated events occurring subsequent to year-end through October 10, 2025, which is the date the financial statements were available to be issued.

3. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Financial Accounting Standards Board established a framework for measuring fair value in the form of a fair value hierarchy, which prioritizes inputs into valuation techniques used to measure fair value into three broad levels. This hierarchy requires assets to be classified by level in their entirety based upon the lowest level of input that was significant to the fair value measurement. The three levels of the fair value hierarchy are as follows:

Level 1 Quoted prices in active markets for identical assets or liabilities.

Level 2 Observable inputs other than Level 1 including quoted prices for similar assets or liabilities, quoted prices in less active markets, or other observable inputs that can be corroborated by observable market data.

Level 3 Unobservable inputs supported by little or no market activity for financial instruments whose value is determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant management judgment or estimation.

4. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

5. Tax Status

The Internal Revenue Service has determined and informed the Employer by a letter dated May 15, 2013, that the Plan and related trust are designed in accordance with applicable sections of the IRC to qualify for tax exemption. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Accordingly, the accompanying financial statements do not contain an income tax provision.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that all Plan years remain open to examination by the IRS.

6. Exempt Party in Interest Transactions

Of the Plan's investments, \$41,805,318 and \$40,550,526 as of December 31, 2024 and 2023, respectively, consisted of mutual funds and a common trust fund that are managed by the custodian and therefore represent party-in-interest transactions. Fees and commissions paid to the custodian have been netted in investment income. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. Notes receivable from participants are also exempt party-in-interest transactions because they are receivables from Plan participants.
