## **INDEPENDENT AUDITORS' REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter – Supplemental Schedules Required by ERISA**

The supplemental schedules listed in the table of contents are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTES TO FINANCIAL STATEMENTS AS OF AND FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

---

#### 1. PLAN DESCRIPTION

The following is a brief description of Hamister Group, LLC 401(k) Co-Workers Retirement Plan (the “Plan”) provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General** – The Plan is a defined contribution retirement plan as permitted under Section 401(k) of the Internal Revenue Code. The Plan is funded by employee and employer contributions and covers substantially all eligible employees of Hamister Group, LLC, Brompton Heights, Inc., Orchard Heights, Inc., Heather Heights of Pittsford, Inc., Health Services of Northern New York, Inc., Pennsylvania Hospitality Management, Inc., The Hamister Group of Florida, HH HGI Buffalo, LLC, Forest Hill Heights, LLC, HH C1 Evansville, LLC, HH HG1 Evansville, LLC, HH R1 Columbus, LLC, HH F1 Hazleton, LLC, HH H1 Hazleton, LLC, HH R1 Hazleton, LLC, HH 310, LLC, HH Jamestown, LLC, Northshore Heights, LLC, Lansdowne Heights, LLC, HH DevonHouse, LLC, Northland Heights, LLC, HH SBS Rochester, LLC, Sweetbriar Assisted Living, LLC, Chantilly Heights, LLC, HH HS1 Newtown, LLC, Buckingham Heights, LLC, and Shelby Gardens, LLC (collectively the “Company” and “Plan Sponsor”). Investment fees are paid by the Plan. The Plan is intended to conform to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Eligibility** – All employees of the Company who have attained the age of 18 and completed six months of service, as defined, are eligible to participate in the Plan. Eligible employees are automatically enrolled on or after their completion of the age and service requirements. For employees to be eligible to receive employer matching contributions they must have completed one year of service.

**Contributions** – Participants may authorize a pre-tax elective deferral contribution or designated Roth contributions in an amount equal to a percentage of the contributing employee’s compensation, as defined by the Plan, not to exceed the maximum annual limitations as provided by the Internal Revenue Code (“IRC”). Eligible participants are automatically enrolled in the Plan at 4% of the contributing employee’s compensation, as defined by the Plan, unless they elect not to make elective deferral contributions. Participants who are age 50 or older before the end of the Plan year are allowed to make an additional catch-up contribution, which is also subject to the employer matching contribution. Participants may also contribute amounts representing distributions from other qualified pension plans.

The Company contributes a matching contribution to those participating employees who have elected to make employee contributions. The matching contributions are based on an amount equal to 25% of an employee’s contribution up to a maximum of 4% of employee compensation. Additional employer 401(k) and profit sharing contributions are permitted at the employer’s discretion. There were no profit sharing contributions for the years ended December 31, 2024 and 2023.

**Withdrawals and Distributions** – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of his or her vested account balance, or annual installments over various terms. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. The Plan also allows for in-service withdrawals for employees who attain the age of 59 ½. Additionally, participants who have suffered a financial hardship as defined in the Plan document may take withdrawals from their account balance.

## 1. PLAN DESCRIPTION (continued)

**Participant Accounts** – Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contributions, (b) Plan earnings and losses, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants may receive their accumulated vested benefits held by the Plan’s custodian upon termination of employment or elect to keep their vested balance in the Plan until the earlier of normal retirement age, death or disability if their account balance is in excess of \$5,000. If the participant elects to keep his or her interest in the Plan, the participant’s account will continue to receive its share of earnings or losses.

**Vesting** – All participants are immediately 100% vested in their contributions, in addition to allocated earnings thereon. Participants are 25% vested in employer contributions after completing one year of service (as defined), with an increase of 25% in each of the next three years.

**Forfeitures** – Any non-vested employer contributions, which remain after an employee has terminated employment, are applied to reduce either employer contributions or administrative expenses. At December 31, 2023, there was \$3,251 of forfeitures available. There were no forfeitures available as of December 31, 2024. Forfeitures used to reduce employer contributions and administrative expenses during the years ended December 31, 2024 and 2023 were \$11,925 and \$3,792, respectively.

**Excess Contributions Payable** – Contributions received from participants are net of obligations of \$14,807 and \$21,927 at December 31, 2024 and 2023, respectively, to certain active participants to return excess deferred contributions as required to satisfy certain nondiscrimination provisions of the Plan. These excess employee contributions were returned to participants in 2025 and 2024, respectively.

**Administrative Expenses** – Costs of administering the Plan were shared by the Plan and the Plan Sponsor for the years ended December 31, 2024 and 2023.

**Plan Termination** – Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements have been prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition** – The Plan determines the fair value of assets and liabilities, which are subject to be reported at fair value based on U.S. generally accepted accounting standards. The standard establishes a hierarchy for the determination of fair value, as well as disclosure requirements relative to those assets and liabilities. The hierarchy identifies three levels of input. Level 1 inputs are generally quoted market prices for identical assets or liabilities, which are actively traded, on an exchange. Level 2 inputs generally consist of market prices for identical assets, which are not actively traded, or market prices of similar assets or liabilities, which are actively traded, on an exchange. Level 3 inputs are referred to as unobservable inputs and consist primarily of information derived by management where Level 1 and Level 2 inputs are not available. These may include such things as present value of expected future cash flows or other valuation methodologies. Under the hierarchy, Level 1 inputs are the most preferred followed by Level 2, and Level 3. Level 3 inputs are to be used when neither Level 1 nor Level 2 inputs are available.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

An investment's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value as of December 31, 2024 and 2023:

*Pooled separate accounts:* These accounts are valued at the net asset values ("NAV") of units held by the Plan at year-end. The pooled separate accounts have been measured at fair value using the NAV practical expedient as of December 31, 2024 and 2023, and generally have no redemption restrictions or unfunded capital commitments.

*Common collective trusts:* The stable value fund primarily holds guaranteed and other similar investment contracts that are fully-benefit responsive. The fund is valued based on the NAV of the shares held by the Plan as of year-end using NAV contract value, and generally has no redemption restrictions or unfunded capital commitments. The other common collective trusts are valued at the NAV of units held by the Plan at year-end. These common collective trusts have been measured at fair value using the NAV practical expedient as of December 31, 2024 and 2023, and generally have no redemption restrictions or unfunded capital commitments.

*Mutual funds:* Valued based on the quoted market price available on an active market, which represents the NAV of the shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation in fair value of investments, which includes unrealized and realized gains and losses on investments that were held or sold during the period.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividend income is recognized on the ex-dividend date.

*Use of Estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

*Risks and Uncertainties* – The Plan's assets include various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to the value of such investments, changes in the values of investments will occur and such changes could materially affect the amounts reported in the accompanying financial statements.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

*Payment of Benefits* – Benefits are recorded when paid.

*Subsequent Events* – The Plan has evaluated the effects of all subsequent events through October 7, 2025, the date the financial statements were available to be issued, to determine if events or transactions occurring through that date require potential adjustment or disclosure in the financial statements.

## 3. FAIR VALUE MEASUREMENTS

The Plan uses fair value measurements to record fair value adjustments to certain assets and to determine fair value disclosures (as discussed in Note 2). The following table sets forth, by level within the fair value hierarchy, the Plan's assets that are measured at fair value as of December 31, with the exception of the pooled separate accounts and the common collective trusts, which are measured at fair value using the NAV practical expedient. The fair value for the pooled separate accounts and the common collective trusts are provided below to permit reconciliation of the fair value hierarchy to the amounts presented in the Statements of Net Assets Available for Benefits.

**5. INCOME TAX STATUS**

The Plan has adopted the Principal Financial Group Prototype Non-Standardized Profit Sharing Plan with Cash or Deferred Arrangement (the "Prototype Plan"). The Prototype Plan received an Opinion Letter from the Internal Revenue Service on June 30, 2020, stating that the form of the Prototype Plan is acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and the related trust is tax exempt.

**6. PARTY IN INTEREST TRANSACTIONS**

Plan investments in pooled separate accounts are managed by Principal Life Insurance Company. Additionally, Plan investments in common collective trusts are managed by Principal Global Investors Trust Company, an affiliate of Principal Life Insurance Company. Principal Life Insurance Company is the custodian as defined in the Plan, and therefore, these transactions qualify as party in interest.
