INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of the
Drexel Chemical Company Money Purchase Pension Plan and Trust
Memphis, Tennessee

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Drexel Chemical Company Money Purchase Pension Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Drexel Chemical Company Money Purchase Pension Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be

independent of Drexel Chemical Company Money Purchase Pension Plan and Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Drexel Chemical Company Money Purchase Pension Plan and Trust's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



Note 1 – Description of plan

The following description of the Drexel Chemical Company Money Purchase Pension Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering salaried, and all hourly employees who have completed one year of service and are age 21 or older. It is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA) and was established to qualify under Section 401(a) of the Internal Revenue Code of 1954 (the Code).

Contributions

Employer contributions are calculated as 5.35% of total compensation plus 5.35% of compensation in excess of 20% of the Social Security taxable wage base. Compensation considered for contributions to the plan is limited to \$345,000 for the plan year 2024 and \$330,000 for 2023. Only participants who have completed one year of service (1,000 hours) and are actively employed on the last day of the plan year are eligible to share in the contributions. Employer contributions totaled \$754,638 and \$755,779 for the years ended December 31, 2024 and 2023, respectively. Contributions meet the minimum funding requirements.

Participants may make certain rollover contributions from other plans as defined in the Plan document.

Participant accounts

A participant's account is invested by the trustee. The value of a participant's account is the contributions made on the employee's behalf plus a proportionate interest in the investment earnings of the funds in which the contributions are invested. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The participant accounts are valued yearly at the end of the Plan year.

Vesting

Vesting is based on years of service, 25% after two years increasing by 25% annually through year five when fully vested. A participant also becomes 100% vested in the event of death, disability, and retirement after age 65 or if the Plan is discontinued.

A participant's rollover account shall be fully vested at all times and shall not be subject to forfeiture for any reason.

Payment of benefits

Distributions due to participant termination shall be made in a lump sum following the one-year anniversary of the termination if the total owed is less than \$1,000. If the amount due is greater than \$1,000 upon termination, the distributions are made based on the participant's election of a lump-sum payment or installments. Distribution upon death shall be made to the participant's beneficiaries.

Forfeited accounts

Forfeitures of participant accounts are used to reduce the employer's contribution for the plan year. Rehires receive restoration of their forfeited balances under certain plan provisions. The amount of forfeitures of non-vested balances used to reduce employer contributions during the plan years ended December 31, 2024 and 2023, were \$22,613 and \$20,776, respectively. The Plan has chosen to deem terminated participants that cannot be located as lost and their entire balance is deemed to be forfeited. If the participant is found, the balance must be restored with earnings.

Note 2 – Summary of significant accounting policies*Basis of accounting*

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Appreciation or depreciation in the fair value of investments is based on the difference between the fair value of the assets at the beginning of the year, or at the time of purchase for assets purchased during the year, and the related fair value on the day investments are sold, or on the last day of the year for investments still held. Interest and dividend income is recorded on the accrual basis.

Expenses

The Plan pays various transaction fees and some administrative expenses whereas the Company pays some basic administrative expenses of the Plan as provided in the Plan document.

Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Payment of benefits

Benefit payments to participants are recorded when paid.

Date of management's review

Management has evaluated subsequent events through September 29, 2025, which was the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements. Management has determined that there are no material events or transactions that would require recognition or disclosure in the Plan's financial statements.

Note 3 – Information prepared and certified by trustee

The following is a summary of the information included in the Plan's financial statements and supplemental schedule for 2024 which was prepared by the trustee of the Plan assets, First Horizon Bank, and furnished to the plan administrator. The plan administrator has obtained a certification from the trustee that such information is complete and accurate.

- A. Investments at the beginning and end of the year.
- B. Changes in net assets resulting from investment activities.
- C. Information included in the supplemental schedule of assets (held at end of year).
- D. Information included in the supplemental schedule of reportable transactions.

Note 4 – Fair value measurements

FASB Accounting Standards Codification ("ASC") 820, *Fair Value Measurement and Disclosures*, provides a common definition of fair value and establishes a framework for measuring fair value. ASC 820 defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. ASC Topic 820 also establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value, and describes three levels of inputs that may be used to measure fair value.

- Level 1 - Quoted prices for identical assets in active markets that the entity has the ability to access as of the measurement date.
- Level 2 - Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets, quoted prices in markets that are not active, and other inputs that are observable or can be correlated by observable market data.
- Level 3 - Significant unobservable inputs that reflect a plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at net asset value (NAV) of units held by the Plan at year end, as determined by the issuer, based on the fair value of the underlying investments.

Money market funds: Money market funds are classified in Level 1 of the fair value hierarchy as fair value is based on quoted prices in active markets for identical securities.

US Government Securities: Valued at fair value based on quoted prices in active markets for identical securities (Level 1 of the fair value hierarchy). If quoted prices are not available, fair value is determined using observable inputs other than quoted prices, such as yields on similar securities (Level 2 of the fair value hierarchy).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Tax status

The Plan operates under the Acuff & Associates, Inc. Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA. That Pre-Approved Plan has received a favorable opinion letter from the Internal Revenue Service dated November 30, 2020. The letter states that the Pre-Approved Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

The Plan is subject to routine audits by various taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

Note 6 – Plan termination

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

Note 7 – Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 – Transactions with parties in interest

Certain Plan transactions qualify as party-in-interest transactions. First Horizon Bank, the trustee, manages the Plan's investments and provides related services. July Services serves as the Plan's third-party administrator. For the year ended December 31, 2024, fees paid out of the assets of the Plan totaled \$50,956 which included \$40,444 to First Horizon Bank for trustee services, \$6,512 to July Services for administrative services, and \$4,000 for Plan audit services.

Note 9 – Separated participants

At December 31, 2024 and 2023, vested amounts allocated to participants whose employment with the Plan sponsor had ended, but whose account balances had not yet been distributed, totaled \$2,078,936 and \$1,989,843 respectively.
